AMENDMENT NO. 5 TO MINNESOTA PARTICIPATING ADDENDUM NO. 170214, RELEASE NO. L-336(5)

THIS AMENDMENT is by and between the State of Minnesota, acting through its commissioner of Administration (“State”), in cooperation with NASPO ValuePoint and Soundoff Signal 3900 Central Parkway, Hudsonville, MI 49426 (“Contractor”).

WHEREAS, the State has a Contract with the Contractor identified as Minnesota Participating Addendum No. 170214, September 10, 2019, through August 31, 2024 (“Contract”), to provide Public Safety Vehicle Accessories and LED Emergency Light Bars, Siren Warning Accessories; and

WHEREAS, Minn. Stat. § 16C.03, subd. 5, affords the commissioner of Administration, or delegate pursuant to Minn. Stat. § 16C.03, subd. 16, the authority to amend contracts; and

WHEREAS, the terms of the Contract allow the State to amend the Contract as specified herein, upon the mutual agreement of the Office of State Procurement and the Contractor in a fully executed amendment to the Contract.




NOW, THEREFORE, it is agreed by the parties to amend the Contract as follows:

2. All other prices, terms, conditions, and specifications remain unchanged.

This Amendment is effective beginning December 1, 2023, or upon the date that the final required signatures are obtained, whichever occurs later, and shall remain in effect through contract expiration, or until the Contract is canceled, whichever occurs first.

Except as herein amended, the provisions of the Contract between the parties hereto are expressly reaffirmed and remain in full force and effect.
