### STATE OF OKLAHOMA AMENDMENT NO. 1 TO STATEWIDE CONTRACT AMENDMENT CONTRACT WITH PHILIPS NORTH AMERICA LLC

This First Amendment to 0300 - AED Defibrillators, Advanced Life Support and Chest NASPO PA 1 - Philips North America LLC January 7, 2025 (the “First Amendment”) is effective as of the date of the last signature below, between the State of Oklahoma by and through the Office of Management and Enterprise Services and Heartstream US LLC (“Supplier”). This First Amendment supplements and amends 0300 - AED Defibrillators, Advanced Life Support and Chest NASPO PA 1 - Philips North America LLC January 7, 2025 entered into by the parties and effective January 7, 2025, including all supplements and amendments thereto. Unless otherwise indicated herein, capitalized terms used in this Amendment without definition shall have the respective meanings specified in the Contract.

For good and valuable consideration, the parties agree to amend the Contract as follows:

1. Philips North America LLC has assigned all of its rights, benefits and interests, and transferred all its obligations and liabilities under this Contract to Heartstream US LLC effective March 27, 2026.
2. Heartstream US LLC has assumed all rights, benefits and interests and has assumed all obligations and liabilities under the Contract effective March 27, 2026.
3. All references in the Contract referring to Philips North America, LLC are amended to refer to Heartstream US LLC.
4. In the event of a conflict between the terms and conditions hereof and the terms and conditions of the Contract, the specific terms set forth in this Amendment shall govern the subject matter herein.
5. Except as expressly modified in this Amendment, all terms and/or provisions of the Contract not addressed herein remain as executed by the parties in the Contract and remain in full force and effect.
6. This Amendment may be executed by electronic signature in counterparts (e-mail, facsimile or otherwise). The counterparts each of which shall constitute an original, but all of which together shall constitute one and the same instrument.
