

Change In Barracks Parking Regulations

The present system of cars being parked next to barracks constitutes a very serious fire hazard. In the future employees are urged to park autos inside and against the fence.

There is ample space next to the fence for all cars now being parked in the barracks area. There will be plenty of parking space on both sides of 1st, 2nd, 3rd, 4th, 5th and 6th Streets and on "A" Avenue. Single parking will be permissable along the fence line between barracks and mess halls. Under the new parking regulations no one will than the have to walk farther than then length of a barracks to his car.

In the new hutment area, no private vehicles will be allowed inside the fence, but parking lots just out-side will be provided.

Incentive Plan Payments Start

February 28th marked the completion of the first four-month period since the beginning of the Incentive Plan on October 28th, and employees who had satisfactory attendance records during that time are now eligible for the allowance.

The payment not exceeding one hundred dollars, is an amount equal to the railroad coach fare from the last previous point of employment to Pasco for those employees inter-viewed and hired at Pasco, and from point of recruitment for those

roll three months or more prior to the inception of the plan are eligible for return transportation as well.

Some time is necessary for the checking of the records; but payments will be made within thirty days. Employees will receive them with a weekly pay check; or by mail, if no longer here. Payments will be continuous from now on, whenever employees complete their four-month periods of satisfactory four-month periods of satisfactory attendance and become eligible.

Satisfactory attendance for the purpose of this plan means that an employee must not have more than two days' absence in any one month. The only absence that is excusable is due to illness, and this must be properly authenticated by a doctor's certificate.

The Incentive Plan was instituted to increase production and to decrease absenteeism and turn-over. Those receiving payment of the fare to Pasco because of satisfactory at-tendance from Oct. 28th to Febr-uary 28th will also be eligible for return fare, upon completing an additional three months of satisfactory attendance.

Absenteeism Down to 8%

WHAT WE CAN DO

"The Folks back here in the United States don't seem to alize there's a war on!

How many times have you read that statement in the paper the words of some returning serviceman? He comes home from the sight of constant horror on the battlefield and sees us, secure, well-fed, warmly-housed. He hears us grouse about not being able to get enough butter or enough gasoline, and he compares our troubles with the awfulness he has seen.

No, he doesn't reason it out that we don't mean to grouse about these little things . . . that the folks back home are willing to do everything possible to help win the war. But his complaint should be a warning to us. We should look around to see if there isn't something we can do to help still more.

One very important way to help is to give a lot more this year to the American Red Cross, which not only serves our fighting men all over the world but is ready in case of disaster here at home.

The Red Cross collects blood plasma to keep wounded men from dying, it prepares surgical dressings, its workers serve in military hospitals the world over, it packs millions of food boxes for men who have been taken prisoner by the enemy, and it provides a channel of communication between enemy-interned civilians and their families.

Its services are so many that the average person has no conception of their extent.

What can we do to help? We can support the Red Cross with every dollar we can spare, because we know those dollars go directly to aid the men doing the actual fighting. Let's show our men overseas we know there's a war onl

'Word to the Wise Sufficient' Says Transportation Committee

Important information has been received by the Plant Transportation Planning Committee from the Office of Price Administration of Spokane, Washington that because of the heavy demands for automotive tires, gasoline, oil and automo-tive transportation by the Army and Navy it may become necessary soon to take some drastic steps to be able to procure enough of these commodities to keep the war work

going.
It is pointed out, First, that immediately after the attack by Japan on the United States that it would be necessary to ration all rubber products including automobile tires for the very simple reason that our sources of supply had been lost to our enemy.

Secondly, it became necessary to ration gasoline and oil so that the ration gasoline and oil so that the Army and Navy would have a sufficient supply of these commodities to successfuly conduct the war.

Third, it now appears that it is necessary to ration all of these commodities for the protection of

automotive transportation. 76% of all people employed in War Industries reach their work by automobile. 70% of these cars are 10 years or more old and are being scrapped or junked at the rate of 5000 cars a day. It is reported that formerly the United States had some 27,500,the United States had some 27,500,000 cars are being used on our
highways; recent figures indicate
that there are only 23 million cars
that are useable. It is estimated
that when we reach 22 million cars
that there will be a serious transportation problem. Therefore, it is
necessary that rationing be placed
on tires, gasoline, oil and automotive transportation tive transportation.

It stands to reason that any mil-eage which you save this year you may have in the following years to come, and the necessity for saving this mileage is at a very critical point at the present time.

A recent bulletin received from the Office of Price Administration in the Spokane district is as fol-

> "May we redirect your attention to Amendment No. 103 to Ration Order 50. The provis-ions as set forth requiring your immediate consideration are: In any case of a reduction in the value of "A", "B", or "C" coupons, restoration of such reduction may not be made to any employee of a plant having an organized transportation plan unless:

Such plant has been desig-(a) nated as one in which its employees are eligible for restoration, or

The employee - applicant has a full car club.

Under point (a) above, plants may not be designated by Dis-trict Directors until they have been investigated and found to attain certain general standards prescribed by the Office of Price Administration.

The primary standard will be that the transportation committee has achieved an average car occupancy of 3:5 persons on a major shift, and only in very unusual circumstances will any poorer performance be considered as justification for designation, as a satisfactory ride-

The conditions learned from this survey will be used to classify the plant as satisfactory or unsatisfactory, in accordance with the minimum standard of 3:5 occupancy.

When any coupon cut is necessary, the District Director will be properly informed on the eligibility for restoration of mileage lost through such cut."




