NEED DRAFT BOARD PERMISSION
TO VISIT FOREIGN COUNTRIES

Under Selective Service Regulations, male registrants who wish to visit foreign countries, including Canada, must first obtain permission from their Local Draft Boards.

Registrants contemplating vacation trips to Canada should contact their local boards well in advance, advising the local boards of the exact dates they expect to be in Canada as well as the purpose of the visit, which may be stated as "Vacation".

It is expected that no difficulty will be encountered if this procedure is followed and that the Local Board will respond by issuing DSS Form 351, "Permit of Local Board for Registrant to Depart from the United States".
