Numerous asparagus fields in the Richland Area have been badly damaged through cutting and trampling by unauthorized harvesters. The loss as a result has been twofold: 1. The asparagus cut (about 2000 Lbs.) and the asparagus trampled (about 500 lbs.), all of which were primarily intended for our armed forces. 2. The man hours of labor (about 386) required to clean up and recut where improper cutting and damage by trampling was done.

This asparagus, like all fruit and other vegetables growing on this reservation, is United States government property.

There crops are primarily intended for our armed forcer, and there's no question about their needs.
