# Paint Craft Now Winner in Absentee-ism

The Paint Craft, a former champion in the absenteeism derby, surged to the front of the parade in the latest tabulations to nose out Pipe, a two-week leader, with a 5.3 per cent as compared with Pipe's 5.6

Ridiculous as this sounds, many persons working and living on this project do not realize that the Hanford Engineer Works is a government job, not the work of a private company.

The War Department, finding it necessary to the successful prosecution of the war, awarded a contract for the design, construction and operation of this important war project to the du Pont Company, which sublets contracts to various other firms. The Corps of Engineers of the U.S. Army is responsible for the general direction of the entire project, through its resident officers and civilian employees.

The entire cost of the project and everything pertaining to it is paid for by the United States Government. Every citizen, by means of taxes, pays a portion. Upon completion, the entire plant will be owned by the government.

HEW workers, as taxpayers who pay a share of their own wages and whose money pays for part of the materials and equipment they use, should carefully watch and avoid any wastage of time or materials.
