

## Closeness Centrality Calculation:

$$\text{Gephi equation (we think)} \Rightarrow C(x) = \frac{1}{\sum_y d(x,y)} (n-1)$$

computing closeness centrality for db5, HM01, weighted

Gephi reporting 0.55

assuming from  $x \rightarrow y$

HM01 weights:

$$\begin{aligned} \sum_y &= (\overset{\text{HM01}}{0.5453}) + (\overset{\text{HAP4}}{0.4667}) + (\overset{Y0X1}{0.04830}) + (\overset{C1N5}{0.3959}) + (\overset{C1N5 \rightarrow \text{YHPI}}{0.3959 + 0.08035}) \\ &+ (\overset{C1NS \rightarrow \text{YHPI} \rightarrow \text{GLN3}}{0.3959 + 0.08035 + 1.806}) + (\overset{C1N5 \rightarrow \text{SFPI}}{0.3959 + 0.3287}) + (\overset{C1NS \rightarrow \text{SFPI} \rightarrow \text{SW15}}{0.3959 + 0.3287 + -1.716}) \\ &+ (\overset{C1N5 \rightarrow \text{STB5}}{0.3959 + -0.2396}) + (\overset{\text{MSN2}}{0.100}) + (\overset{\text{MSN2} \rightarrow \text{SW14}}{0.100 + 0.4358}) + (\overset{\text{MSN2} \rightarrow \text{ASH1}}{0.100 + -1.537}) \\ &= 3.233 \end{aligned}$$

$$C(x) = \frac{1}{3.233} (12-1) = 3.413 \neq 0.55$$

$$\begin{aligned} \sum_y &= (\cancel{\overset{\text{HM01}}{1}}) + (\overset{\text{HAP4}}{1}) + (\overset{Y0X1}{1}) + (\overset{C1NS}{1}) + (\overset{\overset{\text{C1NS} \rightarrow \text{YHPI}}{2}}{2}) + (\overset{\overset{\text{C1NS} \rightarrow \text{GLN3}}{3}}{3}) \\ &+ (\overset{\overset{\text{C1NS} \rightarrow \text{SFPI}}{2}}{2}) + (\overset{\overset{\text{C1NS} \rightarrow \text{SFPI} \rightarrow \text{SW15}}{3}}{3}) + (\overset{\overset{\text{C1NS} \rightarrow \text{STB5}}{2}}{2}) + (\overset{\overset{\text{MSN2}}{1}}{1}) + (\overset{\overset{\text{MSN2} \rightarrow \text{SW14}}{2}}{2}) + (\overset{\overset{\text{MSN2} \rightarrow \text{ASH1}}{2}}{2}) \\ &= 20 \end{aligned}$$

$$C(x) = \frac{1}{20} (12-1) = 0.55$$
