

**BLUE JAYS™ / MONDELEZ CATCH SOME JOY CONTEST (the “Contest”)**

**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. SPONSOR:** The sponsor of this Contest is Mondelez Canada Inc., 3300 Bloor Street West, Suite 1801, Toronto, Ontario, Canada, M8X 2X2 (“**Sponsor**”).

**2. ELIGIBILITY:**

- (a) The Contest is open only to residents of Canada who are of age of legal majority in the province/territory in which they reside at the time of entry.
- (b) The following individuals and their household members (whether or not related) are not eligible to enter the Contest: employees, officers, directors, shareholders, agents, representatives, successors and assigns of each of (i) Sponsor, (ii) Rogers Blue Jays Baseball Partnership (“**RBJBP**”), owner of the *Toronto Blue Jays*™ Major League Baseball team (the “**Team**”), (iii) the MLB Entities (defined below), (iv) each of their respective parents, affiliated companies, and subsidiaries, and (v) any and all other companies associated with the Contest. The “**MLB Entities**” shall mean the Office of the Commissioner of Baseball (the “**BOC**”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. (“**MLBAM**” or “**MLB.com**”), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (the “**Clubs**”), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities.
- (c) Sponsor and RBJBP shall have the right at any time to require proof of identity and/or eligibility to enter the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. Sponsor and RBJBP reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

**3. HOW TO ENTER:**

- (a) The Contest entry period (the “**Entry Period**”) begins at 10:00 am Eastern Time (“**ET**”) on Monday, June 11, 2018 and ends at 4:59 pm ET on Friday, August 31, 2018.
- (b) **Limit of five (5) Entries (defined below) per person/Email Address (defined below) per day, regardless of the method of entry.** By way of illustration, if two (2) or more otherwise eligible persons share a single email account only one (1) of them may enter the Contest. If one (1) person has two (2) or more email accounts, that person may enter the Contest using only one (1) Email Address and only the Entry/Entries (defined below) received from the first Email Address will be considered.
- (c) There are two (2) ways to enter: (1) via bluejays.com/CatchSomeJoy by uploading a photograph of a Valid Receipt (defined below) from the purchase of one (1) or more Participating Products (defined below) during the Entry Period or (2) via email. No other method of entry will be accepted.

**I. Via bluejays.com by uploading a photograph of a Valid Receipt from the purchase of one (1) or more Participating Products (defined below) during the Entry Period:**

During the Entry Period, go to [www.bluejays.com/CatchSomeJoy](http://www.bluejays.com/CatchSomeJoy) and:

(A) if you have not yet entered the Contest,

- (i) click on the “REGISTER” button, set up a Contest account by entering a valid email address that belongs to you (the “**Email Address**”), and click on the “NEXT STEP” button. If you have entered an invalid email address, you will be prompted to re-enter a valid Email Address;
- (ii) Complete the online entry form as instructed, including all required information, and click on the “SUBMIT AND UPLOAD RECEIPT” button to submit your completed online entry form; and
- (iii) Upload a photograph of a Valid Receipt (defined below) that is in jpeg, .png, or .GIFF format and that does not exceed 5 MB in total size and click on the “UPLOAD” button.

**OR**

(B) if you have already entered the Contest,

- (i) click on the “UPLOAD A RECEIPT” button, enter your Email Address, and click on the “NEXT STEP” button; and
- (ii) Upload a photograph of a Valid Receipt (defined below) that is in jpeg, .png, or .GIFF format and that does not exceed 5 MB in total size and click on the “UPLOAD” button.

You will receive a notification email by or on behalf of the Sponsor (from support@receiptprocessor.com) between twenty-four (24) and forty-eight (48) hours of you uploading a receipt as directed above to notify you whether or not the receipt you uploaded was in fact a Valid Receipt and, accordingly, whether you received an Online Entry (defined below) in the Contest (or, where a Valid Receipt was for the purchase of more than one (1) Participating Products (defined below), whether you received multiple Online Entries).

An “**Online Entry**” means the successful transmission of a Valid Receipt (defined below) in connection with the purchase of one (1) Participating Product (defined below), as directed above. For clarity, the successful transmission of a Valid Receipt for the purchase of five (5) Participating Products will entitle you to five (5) Online Entries on the date of the successful transmission of the Valid Receipt. Similarly, the successful transmission on the same day of five (5) Valid Receipts, each for the purchase of one (1) Participating Product, will entitle you to five (5) Online Entries on the date of the successful transmission of the Valid Receipts.

A “**Valid Receipt**” means a receipt from the purchase of one (1) or more Participating Products (defined below) during the Entry Period that includes the following information: the date of the purchase (which must be during the Entry Period), the name of the retailer that issued the receipt, the name(s) of the Participating Product(s) purchased, and the total amount of the purchase. Each Valid Receipt may be submitted in connection with this Contest only once and any Valid Receipt subsequently submitted will be void.

“**Participating Products**” mean the Sponsor products listed in Schedule “A” attached hereto, sold at any retailer in Canada during the Entry Period.

Entrants are invited to contact RBJBP at [tbjcontest@bluejays.com](mailto:tbjcontest@bluejays.com) should they have any questions as to the foregoing Contest entry method.

**OR**

**ii. Via Email:** If you do not want to purchase any Participating Products, you may enter the Contest by simply sending an email to [tbjcontest@bluejays.com](mailto:tbjcontest@bluejays.com) during the Entry Period that (1) has as its subject line “Catch Some Joy Contest”, (2) includes a description of fifty (50) words stating why you would like to win the Contest (the “**Written Submission**”), and (3) specifies your full name, address, city, province, postal code, age, and telephone number. The literary quality of the Written Submission will not be judged or otherwise used in any way in, and will have no effect on, the determination of the winners.

Each email that complies with the foregoing requirements and is submitted in accordance with the foregoing instructions is referred to as an “**Email Entry**”. For clarity, in order to receive five (5) Entries on any given day, you must send five (5) Email Entries on such given day. You are permitted to use the same Written Submission in multiple Email Entries during the Entry Period.

Online Entries and Email Entries will be referred to herein collectively as “**Entries**”.

**As mentioned above, there is a limit of five (5) Entries per day per person/email address, regardless of method of entry.**

- (d) RBJBP’s computer shall be the official clock of the Contest. Free access to the Internet is available at most public libraries. Entrants are solely responsible for Internet connectivity, software and/or hardware that may be required in order to create and/or submit any Entry.
- (e) By entering this Contest, each entrant consents to the collection, use, and disclosure of his/her personal information for the purposes and in the manner described herein. All information submitted by entrants on bluejays.com (i.e., in connection with Online Entries) is being collected by 3 Tier Logic Inc. (“**3 Tier Logic**”) on behalf of Sponsor and is subject to, and will be treated in a manner consistent with the privacy policies of each of 3 Tier Logic and Sponsor, accessible at <http://3tierlogic.com/privacy> and [http://disclaimer.mondelezinternational.com/ca/privacy\\_policy\\_en.aspx](http://disclaimer.mondelezinternational.com/ca/privacy_policy_en.aspx), respectively. Information submitted by entrants on bluejays.com (i.e., in connection with Online Entries) will also be provided to (i) RBJBP, treated in accordance with RBJBP’s Privacy Policy, available at [www.bluejays.com/privacy](http://www.bluejays.com/privacy), subject to the entrants’ stated preferences from time to time and (ii) MLBAM, treated in accordance with MLBAM’s Privacy Policy, available at [www.mlb.com/privacy](http://www.mlb.com/privacy). Information submitted by entrants via email (i.e., in connection with Email Entries) is being collected by RBJBP and is subject to, and will be treated in a manner consistent with, RBJBP’s Privacy Policy, available at [www.bluejays.com/privacy](http://www.bluejays.com/privacy), subject to the entrants’ stated preferences from time to time. Information submitted by entrants via email (i.e., in connection with Email Entries) may also be provided to Sponsor, treated in accordance with Sponsor’s privacy policy, available at [http://disclaimer.mondelezinternational.com/ca/privacy\\_policy\\_en.aspx](http://disclaimer.mondelezinternational.com/ca/privacy_policy_en.aspx). Entrants entering the Contest via Online Entries may be given the option to receive commercial electronic messages (e.g., emails) and/or other communications from MLB.com, RBJBP, and/or Sponsor; however, eligibility to participate in the Contest is not dependent upon an entrant’s consent to receive such messages and communications and consenting to receive such messages and communications will not impact an entrant’s chances of winning.

- (f) All information submitted by entrants offline is being collected by RBJBP and will be available to Sponsor. All such information will be treated by Sponsor in accordance with Sponsor's Privacy Policy available at [http://disclaimer.mondelezinternational.com/ca/privacy\\_policy\\_en.aspx](http://disclaimer.mondelezinternational.com/ca/privacy_policy_en.aspx) and by RBJBP in accordance with RBJBP's Privacy Policy, available at [www.bluejays.com/privacy](http://www.bluejays.com/privacy). Sponsor's and RBJBP's treatment of information is subject to each entrant's stated preferences from time to time.
- (g) For certainty, any personal information submitted by entrants within their Entries will, as between Sponsor, RBJBP, and MLBAM, be owned by RBJBP and/or MLBAM.

#### 4. PRIZE DESCRIPTION:

**I. Grand Prize:** One (1) grand prize (the "**Grand Prize**") will be awarded. The winner of the Grand Prize will choose **one (1) of the three (3) prizes** set out below. **For clarity, there is a limit of one (1) Grand Prize for the winner.**

Option #1 – Trip for the winner and three (3) guests to Toronto to attend two (2) 2018 Team regular season home games

- (a) Admission tickets for the winner and three (3) guests (collectively, the "**Grand Prize Participants**") to attend the Team's regular season baseball games played in Toronto at *Rogers Centre*<sup>TM</sup> stadium (the "**Stadium**") on Friday, September 21, 2018 and Saturday, September 22, 2018 (each, a "**Home Game**"). For clarity, the prize includes a total of eight (8) admission tickets (four (4) admission tickets for each Home Game);
- (b) Opportunity for the winner or one (1) of the other Grand Prize Participants who is at least six (6) years of age to throw the ceremonial first pitch prior to the September 21, 2018 Home Game (the "**First Pitch Opportunity**");
- (c) Two (2) hotel rooms (standard double occupancy) for three (3) nights in Toronto in a hotel selected by Sponsor (the "**Toronto Hotel**");
- (d) CDN \$1,000 (total) in spending money (via cheque);
- (e) Four (4) Team-branded "replica" jerseys and four (4) Team-branded authentic baseball caps;
- (f) Two (2) Team and Sponsor branded baseballs;
- (g) Two (2) adult-sized baseball mitts;
- (h) One (1) Team and Sponsor branded duffel bag;
- (i) CAD \$100 worth of Sponsor products consisting of cookies, gum, and candy bars, the specific products to be determined by Sponsor in its sole discretion (the "**Sponsor Products**"); and
- (j) Subject to Section 1(a) of these Official Rules,
- (i) Round trip economy air transportation for the Grand Prize Participants between the international airport within Canada closest to the winner's residence (as determined in the sole discretion of Sponsor) and Toronto, departing on Thursday, September 20, 2018 and returning on Sunday, September 23, 2018 or on such other dates as may be determined by Sponsor (the "**Toronto Airfare**") (estimated retail value of CDN \$1,600) and;

- (ii) Return ground transportation (via a single vehicle) for the Grand Prize Participants between the Toronto airport and the Toronto Hotel (the “**Toronto Ground Transportation**”) (estimated retail value of CDN \$150).

The total estimated retail value of this Grand Prize (i.e., Option #1) is CDN \$7,625 (inclusive of the Toronto Airfare and the Toronto Ground Transportation). Actual retail value of this Grand Prize (i.e., Option #1) will depend on whether the winner resides within 300 kilometres of the Stadium (in which case the Toronto Airfare and the Toronto Ground Transportation will not be provided, as more particularly set out in Section 1(a) of these Official Rules, below) and, if the winner resides farther than 300 kilometres of the Stadium, on the winner’s departure city (the estimated retail value of the Toronto Airfare is based on the departure city of Montreal). Any difference in value will not be awarded.

**OR**

Option #2 – Trip for the winner and three (3) guests to New York City to attend two (2) 2019 Team regular season away games

- (a) Admission tickets for the Grand Prize Participants to attend two (2) of the Team’s baseball games played in New York City during the 2019 Major League Baseball regular season determined by the Sponsor in its sole discretion (each, an “**Away Game**”). For clarity, the prize includes a total of eight (8) admission tickets (four (4) admission tickets for each Away Game);
- (b) Round trip economy air transportation for the Grand Prize Participants between the international airport within Canada closest to the winner’s residence (as determined in the sole discretion of Sponsor) and New York City, on travel dates to be determined by Sponsor (the “**NYC Airfare**”);
- (c) Two (2) hotel rooms (standard double occupancy) for two (2) nights in New York City in a hotel selected by Sponsor (the “**NYC Hotel**”);
- (d) Return ground transportation (via a single vehicle) for the Grand Prize Participants between the New York City airport and the NYC Hotel;
- (e) USD \$500 (total) in spending money (via cheque);
- (f) Four (4) Team-branded “replica” jerseys and four (4) Team-branded authentic baseball caps;
- (g) Two (2) Team and Sponsor branded baseballs;
- (h) Two (2) adult-sized baseball mitts;
- (i) One (1) Team and Sponsor branded duffel bag; and
- (j) CAD \$100 worth of Sponsor Products.

The total estimated retail value of this Grand Prize (i.e., Option #2) is CDN \$8,500. Actual retail value of this Grand Prize (i.e., Option #2) will depend on the winner’s departure city (the estimated retail value of the NYC Airfare is based on the departure city of Ottawa). Any difference in value will not be awarded.

**OR**

Option #3 – Trip for the winner and three (3) guests to Dunedin, Florida to attend two (2) 2019 Team spring training home games

- (a) Admission tickets for the Grand Prizes Participants to attend two (2) of the Team's spring training baseball games played in Dunedin, Florida in March 2019 determined by the Sponsor in its sole discretion (each, a "**Spring Training Game**"). For clarity, the prize includes a total of eight (8) admission tickets (four (4) admission tickets for each Spring Training Game);
- (b) Round trip economy air transportation for the Grand Prize Participants between the international airport within Canada closest to the winner's residence (as determined in the sole discretion of Sponsor) and Tampa, Florida, USA in March 2019 on travel dates to be determined by Sponsor (the "**Florida Airfare**");
- (c) Two (2) hotel rooms (standard double occupancy) for four (4) nights in Tampa or its surrounding areas in a hotel selected by Sponsor (the "**Florida Hotel**");
- (d) Return ground transportation (via a single vehicle) for the Grand Prize Participants between the Tampa airport and the Florida Hotel;
- (e) USD \$500 (total) in spending money (via cheque);
- (f) Four (4) Team-branded "replica" jerseys and four (4) Team-branded authentic baseball caps;
- (g) Two (2) Team and Sponsor branded baseballs;
- (h) Two (2) adult-sized baseball mitts;
- (i) One (1) Team and Sponsor branded duffel bag; and
- (j) CAD \$100 worth of Sponsor Products.

The total estimated retail value of this Grand Prize (i.e., Option #3) is CDN \$8,400. Actual retail value of this Grand Prize (i.e., Option #3) will depend on the winner's departure city (the estimated retail value of the Florida Airfare is based on the departure city of Toronto). Any difference in value will not be awarded.

**II. Secondary Prizes:** One hundred and twenty (120) eligible entrants will each win one (1) secondary prize (the "**Secondary Prize**") consisting of:

- (a) One (1) Team and Sponsor branded baseball;
- (k) Two (2) adult-sized baseball mitts;
- (b) Two (2) Team-branded "replica" baseball caps;
- (c) One (1) Team and Sponsor branded duffel bag; and
- (d) CAD \$25 worth of Sponsor Products.

The total estimated retail value of each Secondary Prize is CDN \$225.

The Grand Prize and the Secondary Prizes are hereafter collectively referred to as "**Prizes**".

## 5. PRIZE CONDITIONS:

- (a) If the Grand Prize winner chooses Grand Prize Option #1 and resides within 300 kilometres of the Stadium, the Toronto Airfare and the Toronto Ground Transportation will not be awarded and the Grand Prize Participants will be solely responsible for all costs of transportation (and no additional compensation or substitution will be awarded for any difference in prize value).
- (a) Notwithstanding anything to the contrary herein, should the winner of the Grand Prize choose Grand Prize Option #1, the winner must be available to attend each Home Game. If he/she is unable to attend either Home Game, the Grand Prize will be forfeited in its entirety and may be awarded to an alternate winner in accordance with these Official Rules. In addition, the Prize Participant who will throw the ceremonial first pitch will be required to meet with a representative of RBJBP prior to the September 21, 2018 Home Game to coordinate such person's throwing of the ceremonial first pitch prior to such Home Game. In advance of the September 21, 2018 Home Game, Sponsor or RBJBP will provide such person with instructions regarding where to meet and what time to meet the RBJBP representative on September 21, 2018 prior to the start of the September 21, 2018 Home Game. Should such person fail to meet the RBJBP representative prior to the September 21, 2018 Home Game as instructed, then notwithstanding anything to the contrary herein, the winner will be deemed to have forfeited the opportunity for a Grand Prize Participant to throw the ceremonial first pitch prior to the September 21, 2018 Home Game.
- (b) Any and all Prizes must be accepted as awarded and may not be transferred, assigned, or redeemed for cash except at Sponsor's sole and absolute discretion. Sponsor reserves the right to substitute any of each of the stated Prizes (or portions thereof) with an alternate prize of comparable or greater value at its sole and absolute discretion, for whatever the reason. Prizes may not be exactly as advertised, and except as expressly warranted herein, each prize is provided "as is" without further warranty of any kind.
- (c) All Grand Prize details, including flight and ground transportation times, if applicable, the location of the hotel, the game dates, the seat locations and, in the case of Grand Prize Option #1 the exact nature and duration of the First Pitch Opportunity, will be determined in the sole discretion of Sponsor and/or RBJBP. Some restrictions may apply. If the Grand Prize winner is entitled to airfare and ground transportation, travel arrangements must be made through Sponsor's agent on a carrier of Sponsor's choice and tickets will be subject to those terms and conditions specified by the ticket issuers. In addition, if the Grand Prize winner is entitled to airfare and ground transportation, the Grand Prize Participants must travel together on the same itinerary and are responsible for ensuring they have all necessary travel documents (e.g., valid passport). RBJBP, Sponsor and the MLB Entities are not responsible in the event any Grand Prize Participant is refused boarding at any time by any airline or airport security. Any unused portion of the Grand Prize will be forfeited. Each Grand Prize Participant must be of age of legal majority in his/her jurisdiction of residence, unless accompanied by a parent or legal guardian. Each Prize winner is fully responsible for any and all applicable federal, provincial, and municipal taxes (including income and withholding taxes).
- (d) Major League Baseball game, event and exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club, as applicable, and may be subject to change. The terms and conditions of the tickets awarded as part of the Grand Prize will govern in the event a legal game, event or exhibition, as defined by Major League Baseball, is not played or held, as applicable, due to weather conditions, an act of God, an act of terrorism, civil disturbance or any other reason. The Grand Prize Participants agree to comply with all applicable stadium and venue, as applicable, regulations in connection with the Grand Prize. The applicable MLB Entities reserve the right to remove or to deny entry to any Grand Prize Participant who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other

person at the applicable game, event or exhibition. The Released Parties (defined below) will not be responsible for acts of God, acts of terrorism, civil disturbances, work stoppages or any other natural disaster outside their control that may cause the cancellation or postponement of any Major League Baseball game, event or exhibition. Major League Baseball game, event and exhibition tickets awarded as part of the Grand Prize may not be resold or offered for resale or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and Grand Prize forfeiture, and may invalidate the licence granted by the game, event or exhibition tickets.

- (e) Any and all additional costs and expenses associated with accepting and using the Grand Prize that are not specified herein as being provided, including but not limited to travel and health insurance, transportation costs (including, as applicable, checked baggage fees, excess baggage fees), meals, gratuities and other expenses incurred by the Grand Prize winner (and any guests), in claiming, accepting and/or using the Grand Prize are the sole responsibility of the Grand Prize winner.

## 6. RANDOM DRAWS:

- (a) **Grand Prize Draw:** At approximately 10:00 a.m. ET on Wednesday, September 5, 2018, a RBJBP representative will select by random draw the potential Grand Prize winner from among all eligible Entries received during the Entry Period.

Odds of winning a Grand Prize depend on the number of eligible Entries submitted by an entrant and the total number of eligible Entries received during the Entry Period.

- (b) **Secondary Prize Draws:** At approximately 10:00 a.m. ET on each Tuesday occurring from June 19, 2018 to September 4, 2018 (inclusive) (each, a “**Secondary Prize Draw Date**”), a RBJBP representative will select by random draw ten (10) potential Secondary Prize winners from among all eligible Entries received up until 11:59 p.m. ET on the day before that Secondary Prize Draw Date or, in the case of the final Secondary Prize Draw Date, from among all eligible Entries received up until 4:59 p.m. ET on Friday, August 31, 2018.

All non-selected eligible Entries from one Secondary Prize Draw Date will automatically carry over to, and will remain eligible for, subsequent Secondary Prize Draw Date(s), if any.

Odds of winning a Secondary Prize on any Secondary Prize Draw Date depend on the number of eligible Entries submitted by an entrant and the total number of eligible Entries received by 11:59 p.m. on the day before the Secondary Prize Draw Date or, in the case of the final Secondary Prize Draw Date, the total number of eligible Entries received by 4:59 p.m. ET on August 31, 2018.

There is a limit of one (1) Secondary Prize per person. For certainty, each Secondary Prize winner remains eligible to win the Grand Prize.

- 7. **NOTIFICATION:** Each potential winner selected in accordance with the previous section will be contacted by a RBJBP representative by telephone at the telephone number indicated in his/her Entry to determine if he/she is eligible in the sole discretion of the RBJBP representative. In the event that any potential winner does not respond to such notification within three (3) days, incorrectly answers the skill testing question (described in more detail below), as determined by Sponsor or RBJBP in its sole discretion, or declines a Prize for any reason, he/she will be disqualified, the Prize will be forfeited and, at Sponsor’s discretion and time permitting, an alternate potential winner may be randomly selected, in the case of the potential Grand Prize winner, from among all remaining eligible Entries received during the Entry Period, or, in the case of a potential Secondary Prize winner, from among all remaining eligible Entries received in connection with the applicable Secondary Prize Draw Date.



## 8. DECLARING A WINNER:

- (a) To be declared a winner and claim the Prize awarded, each potential winner must (i) be eligible according to these Official Rules, (ii) correctly answer, without assistance of any kind, whether mechanical or otherwise, a time limited mathematical skill testing question which will be administered by telephone at a mutually agreeable time, and (iii) sign a duly completed Liability and, except where prohibited by law, Publicity Release form, and any other documentation as may reasonably be required by Sponsor and/or RBJBP, and return same to Sponsor (or if directed, RBJBP) by the date specified on the applicable documentation.
- (b) If all required documents are not properly executed and returned within the specified period of time, or the potential winner otherwise fails to comply with these Official Rules, a disqualification will result and the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential winner may be randomly selected, in the case of the potential Grand Prize winner, from among all remaining eligible Entries received during the Entry Period, or, in the case of a potential Secondary Prize winner, from among all remaining eligible Entries received in connection with the applicable Secondary Prize Draw Date. The Grand Prize winner's guests must also sign a duly completed Liability and, except where prohibited by law, Publicity Release form and return same to Sponsor (or, if directed, RBJBP) by the date specified in order to participate in the Grand Prize.

## 9. WAIVER OF LIABILITY/PUBLICITY RELEASE:
