Provider Closure Notification Form

Purpose

The Provider Closure Notification Form is used to ensure that all ODP waiver and system requirements are met for any provider who no longer intends to provide ODP Consolidated and/or Person/Family Directed (P/FDS) Waiver services.

Providers who no longer intend to provide ODP Consolidated and/or P/FDS Waiver services are required to provide written notification and to participate in transitioning activities in accordance with 55 Pa Code § 51.31 and the "Provider Agreement for Participation in Pennsylvania's Consolidated and Person/Family Directed Support Waivers". Providers should use the Provider Closure Notification Form to notify the department along with all AEs and SCOs with Individual Support Plan (ISP) authorizations of the intent to discontinue provision of ODP waiver services. Note that the provider should notify waiver participants via a separate letter that meets the requirements of 55 Pa Code § 51.31.

The Provider Closure Notification Form should be completed and used as follows:

- 1. PROVIDER: The provider informs the Assigned AE of the intent to discontinue ODP waiver service provision.
- 2. **ASSIGNED AE**: The Assigned AE completes Section 1 of the form and forwards it to the provider, using **Attachment #1** and copies the ODP Lead Regional Office.
- 3. **PROVIDER:** The provider completes Section 2 of the form and forwards it to all authorizing AEs, all SCOs of affected waiver participants, and the ODP Lead Regional Office at least 30 calendar days prior to the projected termination date.
- 4. **ODP**: Upon receipt of the Provider Closure Notification Form:
 - a. ODP Lead Regional Office:
 - 1) Runs the Provider Service Detail Report to determine the current service authorizations and affected AEs.
 - 2) Completes contact information in Section 3, determines the end-date, as described below, then forwards the form to the Provider Agreement mailbox; ODP Provider Qualification Lead(s) of all regions with authorizing AEs; and, if a licensed service is involved, the Licensing Entity and applicable Waiver Capacity Manager(s).
 - If there are no current service authorizations, the end-date is the provider's effective termination date.
 - If there are current service authorizations, the end-date is extended 30 calendar days beyond the provider's effective
 termination date, to assure that transitioning of waiver participants has been successfully completed prior to the end-date,
 at the discretion of the ODP Region in collaboration with ODP Central Office.
 - Note that this does not replace an SC's responsibility to end-date plans. SCs are still responsible to update ISPs to reflect transitioning activities.
 - 3) Sends response to provider and copies all authorizing AEs and corresponding ODP Regional Office Provider Qualification Leads (Attachment #2).
 - b. ODP Central Office:
 - 1) Runs the Service Impact Report to determine the impact of end-dating the provider's service offerings; and
 - 2) Pre-sets HCSIS to end-date provider service offerings, service contracts, and services on plans, based on the effective service end date provided by the ODP Regional Lead.
 - The ODP Region and Central Office may elect not to pre-set the end date based upon the results of the Service Impact Report.
- 5. <u>AUTHORIZING AE(s)</u>: Upon receipt of Attachment # 2 from ODP, authorizing AEs notify all SCOs with authorizations on ISPs of affected waiver participants to begin transitioning activities.
- 6. **ODP**: After the service end-date in HCSIS has elapsed, the ODP Regional Lead:
 - a. Runs a Provider Service Detail Report to confirm that the services have been end-dated;
 - b. Marks the provider's services as "Not Qualified" in HCSIS;
 - c. Notes the date that the provider's services were marked "Not Qualified" in Section 3 of the form; and
 - d. Forwards the form to the ODP Provider Agreement mailbox (RA-odpprovideragreem@pa.gov).
- 7: **ODP**: Upon receipt of the finalized form, ODP Central Office:
 - a. Removes the provider's information from HCSIS and PROMISe;
 - b. Forwards the form to the rate-setting mailbox for end-dating of the rates;
 - c. Notifies the appropriate licensing entity, if applicable;
 - d. Enters information onto the ODP Central Office tracking spreadsheet; and
 - e. Posts the Provider Closure Notification Form along with the tracking spreadsheet onto Docushare.
