

David Ben-Gurion

Introduction

From the 1920s through the 1960s the politics of the Jews of Eretz Yisrael were dominated by one man, David Ben-Gurion. The first prime minister of the State of Israel, Ben-Gurion was dominant as the Jews of Eretz Yisrael made crucial decisions about social, economic, military, religious, and foreign policy.

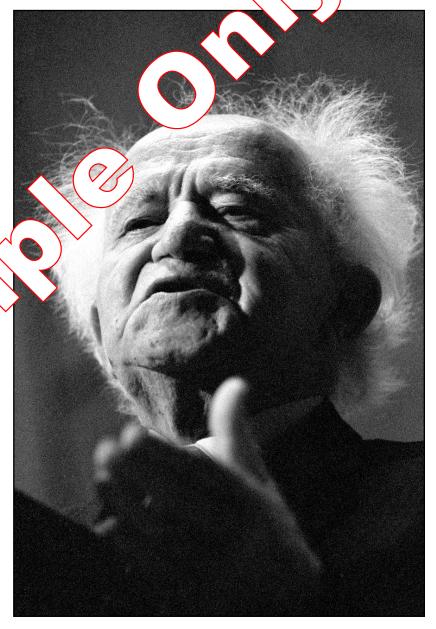
This instant lesson will explore Ben-Gurion's life and the contributions he may on the Jewish people both before and after the creation of the State of Israel.

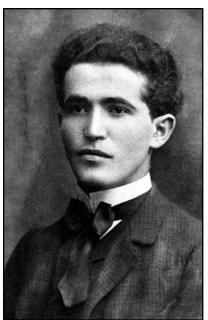
Early Life

David Gruen was born in 1886 in the small town of Plonsk, in Russia. He received a traditional Jewish education and learned about Zionism from his father, a lawyer who was a member of one of the first Russian Zionist organizations. As a young man Gruen organized his friends into a Zionist organization known as the Ezra Society to practice speaking Hebrew and learn more about Zionist ideas.

Gruen's brand of Zionism was Labor Zion et of ideas that combined Zionism (the idea at the Jews are a nation that should be a divided to eir homeland in Eretz Yisrael) with the idea that all people shoul coincidly conomically equal).

In 1903 a series of pogreainst Russian Jews distressed Gruen, who helped organize Jewish self-defense groups to fight back. He decided in 1906, at the age of twenty, that living in Russia was no longer acceptable for someone who believed so strongly in Zionism, and he undertook the arduous two-week journey to Palestine.

In Palestine

THE EARLY DAYS: Soon after arriving in Palestine Gruen settled in the farming community of Petah Tikvah and changed his name to Ben-Gurion—Hebrew for son of a lion cub. Although the farming life was hard and there often wasn't enough food, he was thrilled to be living out his ideals. He wrote his father, "My heart overflowed with happiness, as if I had entered the realm of legend. My dream had become reality."

While Ben-Gurion was hard at

work in the fields he was organizing other עוֹלִים olim (immigrants to Palestine) who shared his Labor Zionist ideas. He helped to found a Palestine chapter of the Labor Zionist movement, Poalei Zion, in 1907. Zionist movement Ben-Gurion quickly became the most prominent leader of the *yishuv*, and by 1935 he was the chairman of the Jewish Agency, which represented the *yishuv* before world governments. Ben-Gurion argued before the British authorities and others that as the Nazis endangered Jewish life in Europe, a homeland for the Jews in Palestine was needed more than ever. But the British had other priorities—such as the large and increasingly restless Arab population of Palestine.

THE WHITE PAPER: In 1979 the British issued the White Paper, which seve restricted the flow of Jewish immi ge and promised to cut it off altoget. fter five ars. The White Paper angere/ d the Jews of the *yishuv*, ared war on Germany sevbut when Jews faced a dilemma. The itish threatening to end the Zionist empt) stablish a homeland in Palestine, but mies, the Nazis, were threatening to end the Jewish people as a whole.

Ben-Gurion's solution was to combat both enemies simultaneously. "We shall fight the White Paper as if there was no war, and we shall fight the Nazi as if there was no White Paper," he said.

After the war Ben-Gurion visited concentration camp survivors in Europe and became convinced that it was time for the immediate establishment of a Jewish state. He encouraged illegal immigration into Palestine, and—concerned that Israel's Arab neighbors would attack any new Jewish State—helped the *yishuv* purchase heavy weapons from Europe and the United States.

1947: In 1947 he appeared before the United Nations Special Committee on Palestine and argued that while the Jews deserved a homeland in all of Palestine, a state in part of the land was better than no state at all. A few months later this committee advocated the partition (division) of Palestine into two states—one Jewish and one Arab. The United Nations voted in favor of that solution, and on the very day the British forces withdrew from Palestine David Ben-Gurion stood before three dozen of his colleagues in a Tel Aviv art museum and read Israel's Declaration of Independence. The State of Israel was born, with Ben-Gurion as its first Prime Minister.

WAR OF INDEPENDENCE: But the infant state was faced with immediate problems. Although within hours Israel was recognized by the United States, its immediate neighbors—Egypt, Syria, Jordan, and Lebanon, plus nearby Iraq—invaded the Jewish State.

After a month of intense fighting the Israelis repelled their enemies and agreed to a cease-fire. As both Prime Minister and Defense Minister, Ben-Gurion played a role in virtually every tactical and military decision.

Ben-Gurion insisted that the various political parties and private armies that had cooperated—and sometimes competed—in the pre-state era be brought together under the government of the State of Israel. His position displeased some Israelis who didn't agree with Ben-Gurion's Labor Zionism. For example, in the fighting soon after Israel's independence, supporters of the Irgun, a "revisionist" Zionist military force, landed a boat filled with arms on the beach at Tel Aviv. Ben-Gurion ordered that the arms on this boat, the Altalena, be handed over to the Israeli army (which was essentially the Haganah under state supervision). When the Irgun refused, Ben-Gurion's soldiers opened fire, and several Ir men died. The "Altalena Affair" infuriated Gurion's opponents, but it was effecti ing that the State of Israel would ment and one army.

The Altalena Affair is an ple he way Ben-Gurion approached go new country: "statism." Straement would have functions that were previously hops of the yishuv's many political parties. The Islands Force was one, but others included a government school system and government control of many health and welfare functions.

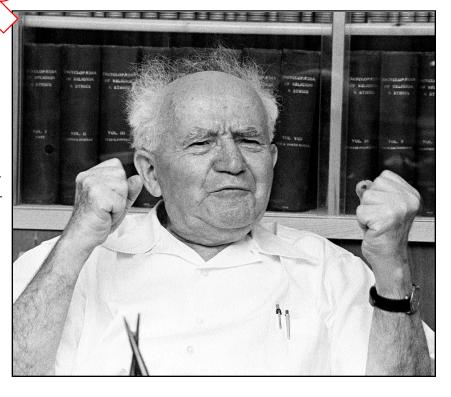
FIRST YEARS OF THE STATE: In Israel's first several years the most pressing issue other than physical security was immigration. Although high rates of immigration led to social and economic upheaval in the new country, Ben-Gurion saw no other choice for a country founded as a haven for

the Jews. These immigrants—including Holocaust survivors and many Jews from Arab lands—needed housing, jobs, and training in Hebrew and the Zionist way of life. Ben-Gurion realized that Israel had limited resources and ordered that food be rationed in this period. Although life was hard for many Israelis at this time, the ingathering of Jews from every corner of the world was inspiring.

Still, Israel needed money. Ben-Gurion pursued two main strategies to boost the state's economy. First, he invited North American Jews to invest in Israel's future by launching Israel Bonds. In 1951 Ben-Gurion flew to the United States to support the sale of Israel Bonds, which raised hundless of millions of dollars for Israel.

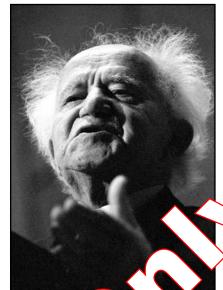
Ben-Gurion's Mapai (Workers of the Land of Israel) Party was forced to enter into a coalition with other parties in order to form a government. Ben-Gurion made a deal with Israel's religious parties to allow them control over religious policy in exchange for support for his government. This arrangement (repeated by every successive prime minister) explains why even today buses don't run in Jerusalem on Shabbat and Orthodox rabbis have control over weddings and conversions, even though Israelis are overwhelmingly secular.

RETIREMENT: After five years of vigorous leadership the 67-year-old prime minister was tired, and he announced his resignation to the shocked nation. The nature of his retirement, however, brilliantly illustrated Ben-Gurion's humility and his devotion to Zionist ideals. Ben-Gurion (known by then as ha-Zaken, the Old Man) settled on a kibbutz in the Negev called Sde Boker. In the mornings he worked on the kibbutz like any other member, tending to sheep. At night he read books and worked on his memoirs.

THE SINAI CAMPAIGN: But Israel still needed him. Two years after his retirement Israel tary situation was worsening as Egypt wa ing up its army in the Sinai Penins tance from the Soviet Union. After the Sinai Campaign Ben-Gurion remained as Prime Minister through 1963. He returned to Sde Boker, although he remained a member of the Knesset for seven more years. When he died in 1973 Israel was once again embattled—this time in the Yom Kippur War. Nonetheless, the country found time to mourn the man many called "The Father of His Country," David Ben-Gurion.

Text for Discussion



On July 3, 1950, David Ben-Gurion addressed the Knesset of the not-yet-two-year-old State of Israel. His words expressed his conception of what Zionism is all about. He said:

"The motives at work in the Jowish immigration to the d of Israel in all genera-including our own have been hany and varied.

Longings for redemption, ancient memories, religious

feelings, lo distress. With the foundation of the state, a new factor added whose strength will continually increase: the power of appeal and attraction embedded in the Israel. The pace and scope of the return of the exiles will all measure depend on our ability to augment this appeal and art the State of Israel into the center for the realization of he longings of the nation and for the satisfaction of its material and spiritual needs."
