Specifically, all subsequent conveyances of the lot hereby conveyed shall include the same restrictions, as required by the DEP Order.

Further subject to easements for the purpose of providing utilities, drainage and roadway access, which will ultimately be granted to and at such time as the Town of Gorham accepts the roadways and drainage.

If the land conveyed in this deed includes wetlands and/or buffers, the disturbance of buffer or wetland areas is prohibited.
