Diploma-Qualifying Test Proctor Guidelines

When the achievement test is administered, accepted procedures and protocol for administering standardized achievement tests must be followed. For the benefit of all students, the following guidelines have been established.

- 1. The individual family is responsible for locating a qualified proctor and arranging payment. Christian Light does not provide any payment to the proctor.
- 2. The proctor must not be the parent, legal guardian, or from another Homeschool Plus family. Someone living in the same home, from the immediate family, close relatives, or other close relationships will not qualify unless the person is a certified public or private schoolteacher.
- 3. A proctor should be able to provide a proper testing environment away from the student's home.
- 4. Christian Light will provide a proctor agreement form confirming that the proctor met these requirements and followed proper testing procedures. This form must be signed and returned to Christian Light with all testing materials, after the test is administered.
- 5. The testing materials are to be stored in a secure facility prior to the test and are not to be shown to anyone either before or after the test. All testing materials must be returned promptly to Christian Light and not given to the student or family. The student's parents may not review testing materials before or after the test. Christian Light will notify the parents of the results.
- 6. The proctor may not attempt to score the test. Christian Light will score the test.

Christian Light Education cannot accept or record the results of this test unless the proctor adheres to these guidelines.
