FREQUENTLY ASKED QUESTIONS

WHAT IS A BRACKET?

A bracket is comprised of teams that have qualified to participate in the NCAA Men's Basketball Tournament. The single-elimination tournament results in two teams competing in the Championship Game on Monday, April 8, 2019. To fill out your bracket, simply select the teams that you think will win each game during the tournament up to the Championship Game. If you are a basketball novice, you can use either our PICK FOR ME button to fill out your bracket with randomly selected teams or our FAVORITES button to fill out your bracket with the highest-seeded teams. Regardless of how you fill out your bracket, be sure to click SUBMIT after you are done to ensure that your bracket is recorded in the system.

WHAT IS THE "BUSTED BRACKET BONUS"?

As is often the case in any tournament, upsets take place that make subsequent bracket picks wrong. The term used for when this happens is that a bracket is "busted." Because we expect this to happen for many players, we created the Busted Bracket Bonus, which allows you to fill out a new bracket that includes all of the remaining teams and games in the tournament up to the Championship Game. This new bracket gives you another chance to win, with a separate prize pool for the highest-scoring brackets at the end of the tournament.

SHOULD I CONTINUE TO PLAY THE ONLINE GAMES DAILY, EVEN IF MY BRACKETS ARE "BUSTED"?

Absolutely! By playing the *Million Dollar March Mania Challenge* online games daily, you will earn entries into the Championship Game Drawing at 6pm on April 8 at Rampart Casino. The more you play, the entries you earn!

WHY CAN'T I FIND A REWARD I RECEIVED FROM THE MILLION DOLLAR MARCH MANIA CHALLENGE?

You received your Instant Reward by email or you printed it out. If you misplaced your reward, you can still get it on the *Million Dollar March Mania Challenge* website. After you log into the site, click on the PRIZE INFO button in the navigation bar, then click on the MY PRIZES button at the top of the page. Your non-redeemed rewards will be listed there, and you can get them again by email or you can print it out.

WHY DO I SEE “YOUR SESSION HAS EXPIRED. PLEASE REFRESH YOUR PAGE AND TRY AGAIN”?

In most cases this is due to more than one rampart.marchmaniaonline.com browser window open at a time while logged into the Million Dollar March Mania Challenge. Please close any duplicate tabs. You can also completely start over by closing all your browser windows, opening a new window, and typing in the *Million Dollar March Mania Challenge* URL again.

HOW DO I CHANGE MY PASSWORD?

To change your password, click the arrow next to your name, click the MY PROFILE button and enter your new password in the designated fields. You can also log out of the *Million Dollar March Mania Challenge* website, click on the FORGOT PASSWORD button on the login page, and then follow the steps to reset your password.

WHY HAVEN'T I RECEIVED A RESPONSE TO MY REQUEST TO CHANGE MY PASSWORD?

Password reset requests are emailed to the address you used to register your account. Make sure to check your SPAM folder to see if it is there. Additionally, you can add our domain name to your safe senders list to ensure you receive emails from us. It is also possible that your email provider has blocked the email. Some providers enforce strict blocking lists or delete emails they deem to be SPAM. You can check with your provider and ask them to add our domain name to their safe sender list to allow the email to come through. If you still do not receive the password reset email, you can use the site feedback form by clicking on the HELP button on the MY PROFILE page and our customer support team can help you.

OFFICIAL PROMOTION RULES

The *Million Dollar March Mania Challenge* promotional period is March 7 to April 8, 2019.

MILLION DOLLAR BRACKETS

This is an online promotion. Players must have a unique email address and are encouraged to update their email addresses with the Rampart Rewards Player's Club.

Players receive ONE FREE bracket entry on Sunday, March 17, 2019.

Players may earn or purchase additional brackets, one per day, between March 7 and March 14, 2019, by:

- a. earning 1,000 same-day base points for one bracket entry, one time each day during the earning period
- b. redeeming 1,500 points for one bracket entry, with a limit of one redemption each day during the redeeming period

Players may begin submitting their bracket picks on Sunday, March 17, 2019.

The deadline to submit bracket picks is 11:59pm on March 20, 2019.

Once brackets are submitted, they **must be activated** at any Rampart Casino kiosk between March 18 and March 24, 2019, **to be eligible to win**.

BRACKET SCORING

Each correctly picked winner of a tournament game will award point(s). The brackets with the most points at the end of the tournament will win. Bracket points per win are as follows:

- a. Round of 64: 1 point per each correct winning team
- b. Round of 32: 2 points per each correct winning team
- c. Round of 16: 4 points per each correct winning team
- d. Round of 8: 8 points per each correct winning team
- e. Round of 4: 16 points per each correct winning team
- f. Championship: 32 points for selecting the national champion

BUSTED BRACKET BONUS

Players receive a second chance at a separate prize pool with the Busted Bracket Bonus.

Players will have the same number of Super 16 Brackets that they had in Million Dollar Brackets. These new brackets start with all the teams that advanced to the Round of 16.

Players may begin submitting their Busted Bracket Bonus picks in their Super 16 Bracket(s) on Monday, March 25, 2019.

The deadline to submit Busted Bracket Bonus picks is 11:59pm on March 27, 2019.

WAYS TO WIN AND PRIZING

The promotion offers five ways to win prizes:

1. Best Million Dollar Bracket Overall Prizes

The *Million Dollar March Mania Challenge* awards \$1,000,000 for a perfect, activated bracket. A "perfect bracket" is defined as a player correctly picking every winning team for every game and scoring 192 points. The bracket must have been activated at a Rampart Casino kiosk by 11:59pm on Sunday, March 24, 2019. There is a maximum of ONE prize of \$1,000,000 cash available.

All games from Thursday, March 21, through the Championship Game on April 8, 2019, will be scored for the Best Million Dollar Bracket Overall Prizes. All bracket prizes must be claimed within seven (7) days of being announced.

In the event there is not a winner with a perfect bracket, the player with the most points during the tournament will become the winner and receives \$3,000 in cash.

- 3rd Place: \$1,000 Free Slot Play

2. Best Million Dollar Bracket Weekly Prizes

- a. **Week 1:** All games from Thursday, March 21, to Sunday, March 24, will be scored as a total with weekly prizes awarded on Monday, March 25, 2019. All Week 1 bracket prizes must be claimed by Sunday, March 31, 2019.

1st Place: \$300 Cash

2nd Place: \$200 Cash

3rd Place: \$100 Cash

- b. **Week 2:** All games from Thursday, March 21 to Sunday, March 31, will be scored as a total with weekly prizes awarded on Monday, April 1, 2019. All Week 2 bracket prizes must be claimed by Sunday, April 7, 2019.

1st Place: \$300 Cash

2nd Place: \$200 Cash

3rd Place: \$100 Cash

3. Busted Bracket Bonus Prize

All games from Thursday, March 28 up to the Championship Game on April 8, 2019, will be scored for Busted Bracket Bonus Prizes. All bracket prizes must be claimed within seven (7) days of being announced.

1st Place: \$1,000 Cash

2nd Place: \$500 Cash

3rd Place: \$250 Free Slot Play

4rd Place: \$200 Free Slot Play

5rd Place: \$100 Free Slot Play

Tie-Breaker

In the case of a tie between players' brackets, the winner will be determined by date and time of submission. The player with the earliest time of submission will be deemed the winner. Example: Two brackets total 52 points each, one submitted at 5:30pm on March 18, 2019, and the other at 11:50am on March 19, 2019. The earlier of the two (5:30pm, March 18, 2019) will be declared the winner. In the event of a submission-time tie, the prizes will be combined and split equally.

This tie-breaker rule will apply to all ties.

Guests are only eligible to win once per week. Therefore, if multiple brackets are eligible, only the best performing bracket will be used and shown on the leaderboard after each week's games have been played. The highest-ranked bracket may change from week to week.

4. Championship Game Drawing

Players earn drawing entries by playing free online games and activities throughout the promotion from March 13 to April 8, 2019.

From March 7, to April 8, 2019, at 6:00pm, players can earn additional drawing entries for playing Slots, Bingo, and Table Games using their Rampart Rewards cards. One entry is awarded for every 100 points earned and for every one hour of playing table games with a minimum average bet of \$10.

The Championship Game Drawing will be held on April 8, 2019 at 6:00pm. Players must be present to win. Players must swipe at any Rampart kiosk to activate their entries between 3:00pm and 6:00pm on April 8, 2019. Winners will have three (3) minutes to claim their prizes.

Five (5) winners will be drawn. Each winner will choose one (1) envelope with his/her prize amount inside.

BEAT THE BOOKIE PROMOTION RULES
