

End-User License Agreement (EULA) of KIN

This End-User License Agreement ("EULA") is a legal agreement between you and House of Secrets.

This EULA agreement governs your acquisition and use of our KIN application ("Game") directly from House of Secrets or indirectly through a House of Secrets authorized reseller or distributor (a "Reseller").

Please read this EULA agreement carefully before completing the installation process and using the KIN application. It provides a license to use KIN and contains warranty information and liability disclaimers.

1. Terms

If you register for a free (review) demo of the KIN Game, this EULA agreement will also govern that demo. By clicking "accept" or installing and/or using the Game, you are confirming your acceptance of and agreeing to become bound by the terms of this EULA agreement.

If you are entering into this EULA agreement on behalf of a company or other legal entity, you represent that you have the authority to bind such entity and its affiliates to these terms and conditions. If you do not have such authority or if you do not agree with the terms and conditions of this EULA agreement, do not install or use the Game, and you must not accept this EULA agreement.

This EULA agreement shall apply only to the Game supplied by House of Secrets herewith regardless of whether other software is referred to or described herein. The terms also apply to any House of Secrets' updates, supplements, Internet-based services, and support services for the Game, unless other terms accompany those items on delivery. If so, those terms apply.

2. License Grant

House of Secrets hereby grants you a personal, non-transferable, non-exclusive licence to use KIN on your device in accordance with the terms of this EULA agreement.

You are permitted to load the Game (for example a PC, laptop, mobile or tablet) under your control. You are responsible for ensuring your device meets the minimum requirements for the application.

You are not permitted to:

- Edit, alter, modify, adapt, translate or otherwise change the whole or any part of the Game nor permit the whole or any part of the Game to be combined with or become incorporated in any other Game, nor decompile, disassemble or reverse engineer the Game or attempt to do any such things
- Reproduce, copy, distribute, resell or otherwise use the Game for any commercial purpose
- Allow any third party to use the Game on behalf of or for the benefit of any third party
- Use the Game in any way which breaches any applicable local, national or international law
- use the Game for any purpose that House of Secrets considers is a breach of this EULA agreement

3. Intellectual Property and Ownership

House of Secrets shall at all times retain ownership of the Game as originally downloaded by you and all subsequent downloads of the Game by you. The Game (and the copyright, and other intellectual property rights of whatever nature in the Game, including any modifications made thereto) are and shall remain the property of House of Secrets.

House of Secrets reserves the right to grant licences to use the Game to third parties.

4. Termination

This EULA agreement is effective from the date you first use the Game and shall continue until terminated. You may terminate it at any time upon written notice to House of Secrets.

It will also terminate immediately if you fail to comply with any term of this EULA agreement. Upon such termination, the licenses granted by this EULA agreement will immediately terminate and you agree to stop all access and use of the Game. The provisions that by their nature continue and survive will survive any termination of this EULA agreement.

5. Modifications

House of Secrets may revise this EULA for its application at any time without notice. By using this application you are agreeing to be bound by the then current version of these terms of service.

6. Governing Law

This EULA agreement, and any dispute arising out of or in connection with this EULA agreement, shall be governed by and construed in accordance with the laws of the Netherlands.
