

Rights of Nature Legal case in Ecuador could set a world precedent for forests during this climate and biodiversity emergency

Dear Sirs,

The highest court in Ecuador, the Constitutional Court, has agreed to hear a Rights of Nature case for the Protected Forest Reserva Los Cedros, against mining concessions that were illegally placed by the government in 2017 on 2.4 million hectares (six million acres), including 186 protected forests. This case has implications for the climate emergency as well as for stunning biodiversity, including hundreds of endangered species.

In 2000, it was estimated that more than 96% of the forests in western Ecuador had been deforested¹, more has been lost since then, and now the few remaining protected areas are being threatened. Mining represents a short-term investment with great long-term costs to the people of Ecuador. We cannot maintain the illusion that mining can be done without grave ecological and human health consequences, consequences that are well documented in scientific literature²⁻⁹. Furthermore, as the climate changes and water resources throughout the world come increasingly under pressure, unlogged watersheds such as that of the Los Cedros Reserve and the other protected forests are accordingly precious.

Protected forests (Bosques Protectores) in Ecuador harbor exceptional biodiversity, much of which is becoming rare. For example, Reserva Los Cedros is well known for its globally critically endangered brown-headed spider monkeys^{10,11} and endangered spectacled bears^{12,13}, but there are 207 species at Los Cedros that are under threat according to Ecuador's red lists, including 70 near threatened, 103 vulnerable to extinction, 29 endangered and 5 critically endangered¹⁴⁻¹⁶. In addition, the reserve encompasses the headwaters of four rivers.

We, the undersigned scientists, hope that Ecuador understands and seizes this opportunity to honor their commitment to the natural world, and to future generations of Ecuadorians. We specifically request that (1) that all mining concessions be removed from Bosques Protectores (protected forests), including Reserva Los Cedros and (2) and that the exceptional Reserva Los Cedros be included in the National Park, Cotacachi-Cayapas Ecological Reserve, with which it shares a border.
