

"Reload and Win" Contest Rules

"Reload and Win" CONTEST - OFFICIAL RULES

THIS CONTEST IS INTENDED FOR RESIDENTS OF CANADA, EXCLUDING NUNAVUT, AND WILL BE GOVERNED BY CANADIAN LAW.

NO PURCHASE NECESSARY. A purchase will not improve your chances of winning.

HOW TO ENTER:

The contest begins on February 4, 2019, at 12:00:01 a.m. Mountain Standard Time and ends on June 2, 2019, at 11:59:59 p.m. Mountain Daylight Time (the "Contest Period"). To be entered automatically in the contest, visit one of 6,300 participating Canada Post retail locations in Canada and reload (for a \$3 fee) \$25 or more onto your H&R Block® Advantage Prepaid VISA® card. You will receive an automatic entry into the contest each time you reload your card with \$25 or more, to a maximum of two entries per day. Reloads made from tax refunds in our Instant Refund® and H&R Block Pay With Refund™ services are not eligible for contest entry.

No Purchase Entry: Hand write your name, address, telephone number, age and e-mail address (optional) on a plain piece of paper and mail it in a separate envelope with sufficient postage to: "Reload and Win Contest", H&R Block Canada, Inc., 2500, 700 – 2nd Street SW Calgary, AB, T2P 2W2. Mail-in entries must be postmarked by June 2, 2019 and received before June 5, 2019. Maximum total of two entries per person per day by any method. Eligible entries will be entered in the weekly national draws as described below.

ELIGIBILITY:

This contest is open to all residents of Canada, excluding Nunavut, who have reached the age of majority in their province or territory of residence at the time of entry, excluding employees, officers, directors, contractors, franchisees and agents (and those with whom such employees, officers, directors, contractors, franchisees and agents are domiciled) of H&R Block Canada, Inc. (the "Sponsor"), and its parents, subsidiaries, affiliates, franchisees, advertising and promotion agencies and the contest judges.

THE PRIZES AND APPROXIMATE RETAIL VALUE:

Each prize consists of \$500 loaded onto the winner's H&R Block Advantage Prepaid VISA® card. There will be seventeen (17) prizes in total available to be won; each awarded through a random, national draw held weekly from February 13, 2019 through June 5, 2019. ODDS:

DRAW AND WINNER SELECTION:

Potential winners will be selected from among all eligible entries received in a weekly random national draw (as described above) by a representative of the Sponsor in Calgary, Alberta at 1:00 p.m. local time each Wednesday beginning February 13, 2019, and ending on June 5, 2019. One name will be drawn each Wednesday from all entries received by 11:59:59 pm (Mountain Time) the immediately preceding Sunday. Entries not selected in a weekly draw will remain in the pool of eligible entries for subsequent weekly draws. Selected entrants will be contacted by phone, mail or email. If the selected entrant cannot be contacted within 14 days of selection or there is a return of any prior notification as undeliverable, that entrant will be disqualified and an alternate entrant will be selected from among the remaining eligible entries. Before being declared a winner, the selected entrant must first: (i) correctly answer, unaided, a time-limited mathematical skill testing question to be administered by telephone, mail or email at a prearranged mutually convenient time; (ii) otherwise comply with these official rules; and (iii) sign a declaration and release form confirming compliance with these official rules, acceptance of the prize as awarded and releasing and agreeing to hold harmless the Sponsor, the contest judges, the prize suppliers and their respective parents, subsidiaries, affiliates, franchisees, advertising and promotion agencies, and the officers, directors, employees,

By accepting the prize, the winner agrees to the Sponsor's and its designee's use of his/her name, city, province or territory of residence and/or photograph or other likeness for advertising and publicity purposes without notice or compensation. In the event of any discrepancy or inconsistency between the terms and conditions of these English Rules and disclosures or other statements contained in any Contest-related materials, including, but not limited to: the Entry Form, Website, French version of these Rules, and/or point of sale, television, print or online advertising; the terms and conditions of these English Rules shall prevail, govern and control to the fullest extent permitted by law.
