**PERMISSION TO PARTICIPATE**

I hereby assume these risks and grant permission for my child/Player to participate in the Roeper Athletic Program. I further understand and agree that Roeper is not liable for injuries that may occur while participating in these sports, whether games or practice.

I give permission for my child to ride on Roeper-provided school buses to and from games when available.
