Career

Coach Bacon got his 600th career win on January 5th as the Rebels defeated FW Poly 52-48. Coach Bacon was also selected to coach in Texas Association of Basketball Coaches All-Star game in May. Coach Bacon will be entering his **22nd** year as the Head Boys Basketball Coach at Richland High School in the fall. The Rebels entered the play-offs for the **11th** consecutive year but lose to a very talented Trimble Tech team in the Bi-District game.

Coach Bacon's play-off record in 20 play-off appearances is an astonishing 34-18 (.653 pct.). He led the Seagoville Dragons to their first and only trip to the Final Four in Austin in 1985. He guided Dallas Lincoln to five straight Regional Finals and two State Championships 1990 and 1993. Before arriving at Richland High School, Coach Bacon served as Assistant Men's Basketball Coach at Texas Christian University for three years. In 2003 Coach Bacon was named as an assistant coach for team USA in the US Global Games which won a silver medal. Coach Bacon is Also the Director of the DFW East/West All-Star Game. Coach Bacon is dedicated to the improvement of basketball in Tarrant County.

Camp Experience

Coach Bacon has directed basketball camps throughout the United States including New York City, Houston, TX. and St. Louis, MO. He has also held these same camps in

Berlin and Frankfurt, Germany; Colon and Panama City, Panama.

Camp Goals

This camp will focus on the fundamentals of basketball, passing, shooting, ball handling, rebounding, team play, sportsmanship, and being competitive on the basketball floor. We will have demonstrations on running the fast break, pick and roll, help and recover and other very important facets of the game. **Our main goal is to TEACH.**

Coach Bacon and the entire Richland High School staff will direct the camp, along with highly qualified coaches from all over the Dallas/Ft. Worth Metroplex. The camp may also have special guest appearances from current or former NBA and ABA players.
