### AUTHORIZATION FOR STUDENT TO TRAVEL TO AND FROM ATHLETIC PRACTICES BY PRIVATE TRANSPORTATION AND REIMBURESEMENT AND INDEMNIFICATION AGREEMENT

I, the undersigned, parent/guardian of \_\_\_\_\_ dob: \_\_\_\_\_, a \_\_\_\_\_ grade student in Geary County Unified School District No. 475, do hereby authorize my \_\_\_\_\_, to travel to and from any and all athletic practices or events in which my child may participate, by private transportation of which my child is the sole operator . My child shall not provide transportation for anyone else to and from any and all athletic practices or events. It is understood that my son/daughter will make certain that these rules are upheld or consequences will follow. It is specifically acknowledged that the District would provide the needed transportation to and from the District's facilities to the place of practice or event and return but such is declined.

Further, I do hereby release, discharge and forever acquit Geary County Unified School District No. 475, its board members, officers, agents, representatives and employees from any and all liability or responsibility of whatever nature or description for any and all claims of whatever nature or description, whether the same sound in tort, contract, or a violation of any state or federal statute, that might arise or be incurred while my child is traveling to, or is at, or returning from any practice or event or other circumstance when my child does not travel by District provided transportation regardless as to whether or not the transportation was an essential element of the circumstances giving rise to the claim or cause of action.

Further, I agree not to assert for myself or my child any claim or cause of action of whatever nature or description, whether in tort, contract or for alleged violation of any state or federal statute, and further, I agree that if my child, or anyone on behalf of my child or for the benefit of another, asserts any claims or cause of action against Geary County Unified School District No. 475, its board members, officers, agents, representatives or employees for any cause of action or claims arising out of any circumstances involving the travel to, or presence at, (this is no intended to apply to occurrence during the practice or rehearsal when the student is subject to supervision of school district staff) or return travel to or other event where my child did not travel by school district provided transportation that I will reimburse, indemnify and hold the school district harmless from any and all expenses it may incur for the cost of resisting or defending such claim before any administrative body or agency or any state or federal court including attorney fees and expenses, witness expense, investigatory expenses, the reasonable value of the time or expenses of district board members, officers, agents, representatives or employees expended in resisting or defending against such claims or cause of action and will reimburse or indemnify the district for any judgment, order or other directive which resulted in the district being determined and required to make any payment to my child or any one else as a result of any of the circumstances described above.

For and in consideration of the Geary County Unified School District No. 475 agreeing and permitting my child to travel by private transportation, as described above, to places, events and circumstances described above, I do hereby execute this Authorization for Student to Travel to and from Athletic Practices and Events by Private Transportation and Reimbursement and Indemnification Agreement.
