Call to Order: 7:01, no prayer

Members/Visitors Signed In: 9 members, 4 visitors

Previous Meeting Minutes

- Correction made at end of meeting for November to change \$1,000 for reconditioning football helmets to \$12,000
- first motion to pass: Mr. Fox; 2nd:Marsha Yarborough all in favor: Motion Carried (none opposed)

Treasurer Report: JoLynn Dougherty

- Areas verbally noted: \$1,200 to pay for donkeys for donkey basketball, \$1,100 in payouts.
- Approval of Treasurer's report: first by Heather Campbell; 2nd by Kim Ross: all in favor: Motion Carried (no opposed)
- Request: old wrestling bill at Rudi's, from prior to current Athletic Director for uniforms. Bill is outstanding and about to be sent to collections. Much discussion was made regarding this area: Coach Horton was told the money was deposited in school fund but not credited to wrestling and was used by other sports. No documentation given/no old P.O. accounted for, but bottom line, it is in Booster's name and company wants paid. Discussion regarding booster not usually paying for uniforms and that cheer is not given any slack for their arrears. Motion by JoLynn Dougherty to pay remainder (\$2,135) and have money earned from wrestling's share of football concessions go towards that amount. Another motion was made by Rob Pila but retracted. Rob Pila seconded JoLynn's motion. All in favor: 5; no opposed (others abstained). Motion carried.

Membership:

- No new memberships: deadline was Sept. 30th unless member is new (enrolling in school during school year).

Programs (Marsha Yarborough)

- Nothing new at this time, spring sport program deadline not decided

Concessions: (Cheryl Bowling and Heather Campbell)

- Heather/JoLynn: payouts will be done from concessions in January meeting (with vote). Middle school has yet to give the high school booster their figures, and finishing up paying Sam's Club for totals. Heather audited left over items and Basketball is using some, as will baseball (with credit).

Old Business:

- Heather Campbell mentioned that in last meeting, we noted that we wanted to change the bylaws to have three dates for fund requests to coordinate with each sport season, instead of the old bylaw which gave one deadline in the summer. Motion by Heather Campbell, seconded by JoLynn Dougherty (and motioned passed 7-0).
