Levels of Operation

Twin Falls School District #411 will operate under one of the following designations as long as Coronavirus is a concern in our community. The designation will be determined by the level of community spread utilizing metrics created by South Central Public Health District (SCPHD). Any change in level will be determined in conjunction with SCPHD and announced with as much preparation time for parents, students, and staff as is possible with safety being the highest priority.

Green: Traditional Schedule (No Community Spread)

- 5. Staff will limit visitors/volunteers from non-school related persons-require face covering for all visitors in cases where social distancing cannot be maintained
- 6. Sick or symptomatic staff and students (Separation and/or sent/stay home criteria) will not be allowed at school until return to school status (Return to School) is met. Each site must have a plan in place to allow for the immediate separation of students/staff who present COVID-19 symptoms at school in a designated "health room" until arrangements are made for the person to be picked up
- 7. Post signs in highly visible locations (school entrances, bathrooms, etc.) that promote everyday protective measures. Signs from the CDC can be found here: CDC Coronavirus Print Resources

Yellow: Enhanced Traditional (Minimal Community/School Spread)

- 1. Cleaning/disinfection-plan approved by SCPHD (Maintenance- Cleaning/Disinfection section)

Orange: Modified Schedule (Moderate Community/School Spread)

- 1. Cleaning/disinfection-plan approved by SCPHD (see Maintenance- Cleaning/ Disinfection section)
- Encourage parents to screen students every morning before attending school and keep symptomatic students home

- 4. School schedule designed to limit contact by reducing the number of students in the building at any one time.
 - a. Elementary

Students whose last names begin with A-K will be the A group.

Students whose last names begin with L-Z will be the B group.

Administrators will work with blended families with different last names to keep family members on a common schedule.

- 5. Protocols for social distancing

- Considerations/exceptions will be made for staff and students who provide documentation from a state licensed medical professional stating the wearing of a face covering could be a health risk for that individual.

- 7. No visitors/volunteers allowed unless it is determined to be critically necessary by school administration. All admitted visitors/volunteers must have prior approval from the school administration or designee and are required to wear a face covering at all times.
- 8. Sick or symptomatic staff and students (Separation and/or sent/stay home criteria) will not be allowed at school until return to school status (see Return to School) is met. Each site must have a plan in place to allow for the immediate separation of students/staff who present COVID-19 symptoms at school in a designated "health room" until arrangements are made for the person to be picked up
- 9. An off-site education delivery plan will be available in the event students remain home for extended periods of time and/or schools are closed

Red: Full Distance Schedule (Substantial Community/School Spread)

- 1. Fully remote learning utilizing distance learning delivery strategies
- 2. No in-person school related activities (including extracurricular) allowed
- 3. A decision about staff work schedule (home vs school/office) will be made based on factors such as stay at home orders, etc.
- 4. School Safety protocols
 - a. Elementary Protocols
 - b. Secondary Protocols
 - c. Special Education Protocols



Confirmed COVID Case Protocols

Regardless of the level, the following outlines how the TFSD will respond to a confirmed case(s) of COVID-19 in a school or schools.

1. Confirmed related case(s) in a school (same group of students)

- a. Utilize communication plan
- b. Notify parents and staff of minimal, moderate, or high exposure while ensuring HIPAA compliance
- c. Potential closure of individual school or classroom (including all in-person activities) for up to 5 days in coordination with SCPHD and on a case by case basis
- d. Contact trace students/staff using the <u>exposure checklist</u> to identify students and staff with minimal, moderate, and high exposure. Those with close contact (high exposure) will be highly recommended to quarantine for 14 days (staff will be required to quarantine). This includes close contacts who may be in other schools. The CDC defines close contact as a person that has been within 6 feet of the infected person for a prolonged period of time (about 15 minutes) within two days of the onset of symptoms. Wearing a face covering while within 6 feet does not eliminate consideration as a close contact.
- e. Deep cleaning of the school

2. Two or more unrelated cases in the same period of time

- a. Utilize communication plan
- b. Notify parents and staff of minimal, moderate, or high exposure while ensuring HIPAA compliance
- Potential indefinite closure of school building or classroom (including all in-person activities)-no new cases for up to 15 days in coordination with SCPHD and on a case by case basis
- d. Contact trace students/staff using the <u>exposure checklist</u> to identify students and staff with minimal, moderate, and high exposure. Those with close contact (high exposure) will be highly recommended to quarantine for 14 days (staff will be required to quarantine). This includes close contacts who may be in other schools. The CDC defines close contact as a person that has been within 6 feet of the infected person for a prolonged period of time (about 15 minutes) within two days of the onset of symptoms. Wearing a face covering while within 6 feet does not eliminate consideration as a close contact.
- e. Deep cleaning of the school

3. <u>Multiple cases in several schools with significant number of contacts</u>

- a. Utilize communication plan
- b. Notify parents and staff of minimal, moderate, or high exposure while ensuring HIPAA compliance

- Potential indefinite closure of district or school (including all in-person activities)-no new cases for up to 15 days in coordination with SCPHD and on a case by case basis
- d. Contact trace students/staff using the <u>exposure checklist</u> to identify students and staff with minimal, moderate, and high exposure. Those with close contact (high exposure) will be highly recommended to quarantine for 14 days (staff will be required to quarantine). This includes close contacts who may be in other schools. The CDC defines close contact as a person that has been within 6 feet of the infected person for a prolonged period of time (about 15 minutes) within two days of the onset of symptoms. Wearing a face covering while within 6 feet does not eliminate consideration as a close contact.
- e. Deep cleaning of facilities

What increases the chance of school closures?

- 1. Experiencing a positive case or cluster of cases where physical distancing strategies are not in place, or
- 2. Experiencing a positive case or cluster of cases where students and staff do not consistently wear face coverings
- 3. Not cleaning and disinfecting appropriately
- 4. Not washing and/or sanitizing hands frequently
- 5. Not limiting the mixing of students
- 6. Holding mass gatherings, especially with attendees outside of your local community
- 7. Sick staff and/or students on campus when symptomatic
- 8. Rapid rise in positive cases in the local community that meet or exceed hospital capacity to manage

Separation and/or sent/stay home criteria

- 1. Students who exhibit the listed symptoms will not be allowed in school. Should the symptoms develop at school, the student will be isolated until he or she can be picked up.
 - a. A cough or shortness of breath or difficulty breathing
 - b. Two or more of the following:_
 - i. Chills
 - ii. Fever
 - iii. Fatique
 - iv. Repeated shaking with chills
 - v. Muscle or Body Ache
 - vi. Congestion or runny nose
 - vii. Nausea or Vomiting
 - viii. Headache
 - ix. Diarrhea
 - x. Sore throat

- xi. New loss of taste or smell
- 2. Students will not be allowed to return to school until:
 - a. The student is cleared to return to school by the student's physician, or
 - b. It has been 10 calendar days since symptoms first appeared with 3 days of no fever without the use of fever reducing medication and 3 days of symptom improvement.

Return to School (Staff and Students)-Confirmed Case of COVID-19

- 1. Follow guidance from SCPHD. All surveillance of positive cases or probable cases will be done by the Health Department and they will provide guidance. Presently, the standards for returning are:
 - a. If student/staff member tested positive or was presumed positive for COVID-19 *and had symptoms*, they can return to school after:
 - i. It has been 10 days since symptoms first appeared, and
 - ii. 24 hours with no fever without the use of fever reducing medication, and/or
 - iii. 24 hours of symptom improvement
 - b. If a student/staff member tested positive for COVID-19 *but did not have symptoms*, they can return to school after:
 - i. 10 days have passed since the test date
 - ii. No symptoms within those 10 days
 - c. If a student/staff member has had close contact (high exposure) with a person that has COVID-19, they should:
 - Stay home 14 days after the date of last contact and monitor for symptoms



Maintenance--Cleaning/Disinfection (Approved by SCPHD)

- 1. Cleaning Throughout the Day
 - a. Check all soap dispensers to make sure they are supplied with soap.
 - b. Check paper towel dispensers throughout the day to make sure they are adequately supplied
 - c. Check all hand sanitizer dispensers in hallways and classrooms to make sure they are supplied with hand sanitizer
 - d. Wipe down door handles and vending machines as much as possible with disinfectant
 - e. Restrooms will be cleaned and sanitized throughout the day as needed in each building.
- 2. Daily Cleaning Classroom
 - a. Empty all trash and replace liners as needed
 - b. Clean whiteboards (Use proper whiteboard cleaner)
 - c. Disinfect sinks, countertops, and all hard surfaces. (approved disinfectant)
 - d. Teachers and staff wipe down hard surfaces, manipulatives, supplies, etc. throughout the day with disinfectant. Limit shared items that may be difficult to clean or disinfect.
- 3. Daily Cleaning Restrooms
 - a. Clean toilets and urinals with toilet bowl cleaner. (nightly)
 - b. Clean and disinfect sinks, walls behind sinks, and stall doors. (nightly)
 - c. Sweep and mop with disinfectant. (nightly)
 - d. Clean all mirrors with window cleaner. (nightly)
- 4. Daily Cleaning Hallways
 - a. Clean and disinfect all entryway doors, door hardware, and door glass, as well as all hard surfaces in that area. (nightly)
 - b. Clean and disinfect all hallway surfaces with disinfectant. (nightly)
 - c. Sweep or vacuum hallways. (nightly)
 - d. Clean, polish, and disinfect drinking fountains. (nightly)
 - e. Wet mop hallways. (nightly with disinfectant)
- 5. Daily Cleaning Weight Room
 - a. Wipe down all equipment after it is used by an individual with disinfectant.
 - b. Clean and disinfect weight room and all equipment each evening
- 6. Daily Cleaning Gym and Locker Rooms
 - a. Gym floors and all hard surfaces will be disinfected at least nightly.
 Disinfectants will be available to the teacher to wipe down hard surfaces and equipment throughout the day.

- b. Locker rooms will be cleaned and sanitized each evening and on weekends after use. Floors will be mopped and sanitized nightly.
- 7. Daily Cleaning Computer labs
 - a. Keyboard and mouse will be wiped down with sanitizer after each use.

*In the case of a confirmed case, impacted school/classroom/area will be cleaned and sanitized. The impacted school/area will be allowed to sit for 24 hours per CDC recommendations before this process begins.

**All classrooms will be supplied with a dispenser full of hand sanitizer for all to use.

***Disinfectant bottles will be provided for all classrooms to use to wipe down surfaces as needed throughout the school day.

Health Protocols

- 1. Per CDC recommendation
 - a. Educate staff and families about when they/their child(ren) should stay home and when they can return to school.
 - b. Teach and reinforce handwashing with soap and water for at least 20 seconds.
 - c. Encourage staff and students to cover coughs and sneezes with a tissue. Used tissues should be thrown in trash and hands washed immediately.
 - d. Establish a "health room" in each building.

Food Service

- 1. Cafeteria:
 - a. Regular hot menu served in the cafeteria
 - b. Lunch time staggered to reduce occupants in the cafeteria
 - c. Offer options to eat outside and in other locations to maintain social distancing
 - d. Hand sanitizer at start of all serving lines
 - e. Self-service of items of pre-packaged items only
 - f. Food Service procedures
 - i. No student servers
 - ii. Masks and gloves will be worn by all food personnel
 - iii. Clean and sanitize between lines
 - iv. Face shields to be worn by cashier
 - v. Elementary Student list will be used for point of service.
 - vi. Secondary Students will use number or name at point of service
 - vii. Two lines at middle and HS locations
 - viii. No Bar lines
 - ix. Transport containers and/or sacks will be used for all meals (disposable)
- 2. Schools will need to do the following

- a. Develop staggered schedules in order to meet social distancing guidelines
- b. Select outside and alternate locations for students to eat when cafeteria seating is not available

<u>Transportation</u>

- 1. All buses will be sanitized by an approved disinfectant provided by Mid-Columbia Bus Company.
 - a. Prior to students riding the bus
 - b. After each group of students ride the bus
- 2. All students will be required to wear a face covering while riding on the bus. Students will be asked to provide a personal face covering, however, a supply of face coverings will be on each bus for those students who do not have one. Exceptions to wearing face coverings are granted only if an IEP team or health plan is developed stating otherwise.
- 3. Hand sanitizer will be available on each bus.
- 4. No more than two students to a seat for secondary students and no more than three for elementary students.
- 5. Students will fill the bus from back to front and unload front to back when possible (when picking up at schools in big groups and for delivery of bus loads to school).

<u>Elementary Safety/Education Protocols for 20-21 School Year</u> <u>This document is linked to the district protocols in the district plan.</u>

Gatherings:

Schools will create plans for Open Houses that will allow for smaller gatherings to meet the teacher and hear classroom plans and procedures for the school year.

Schools will not hold activities that create large group gatherings in yellow, orange, or red, such as concerts, programs, parent involvement nights, school assemblies, field trips, etc.

Recess:

Schools will provide students with recess time and will take precautions such as not allowing the use of the big playground equipment (very hard to social distance), encouraging activities that do not require sharing of equipment, encouraging social distancing as much as possible(knowing that 6 feet distance will not be in place at all times), providing hand sanitizing stations in the classrooms and having students sanitize hands before going to recess and upon their return from recess, etc. Face covering are recommended, not required for recess time.

Schools will work to minimize large group gatherings during arrival and departure to and from school as much as possible, (knowing that 6 feet distance will not be able to be achieved at all times).

Breakfast and Lunch:

Schools will stagger schedules as much as feasible, work to limit the number of students in the cafeteria at one time as much as possible, encourage as much social distancing (not necessarily 6 feet apart) as possible, have students sit at tables assigned to their classrooms to make contact tracing easier, will not use the touchpoint but will track student meals served through staff keeping paper/pencil records, providing hand sanitizer stations in cafeterias, etc. Face coverings will not be required for meals.

Schools will limit visitors (including volunteers and parents) who are not staff or students in yellow and orange. Protocols for visitors are noted in the district protocol document for each color level.

Green/Yellow/Orange/Red

Teachers will communicate with parents and let them know which communication mode they will use on a regular basis (Class DOJO, Remind, e-mail, etc.)

Teachers will respond to parent communications within 1 work day of received e-mail and/or voicemail whenever possible.

Students will be assigned a digital device that will be for their use only. Students will use this for in-class work when needed, and to take home for online work when in orange (as assigned by the teacher) or red. Students will be taught the importance of only using their assigned devices. Students will be taught how to access google classroom and/or Seesaw on their devices and how to use these to complete distance learning while they are at school in person, for those times when distance learning is required.

The district provides an opportunity for students K-8 to attend the Venture Upward School, online, for the school year, if a family is concerned about their child attending brick and mortar school. Families must register their child by September 1 in order to attend this school. This school is a part of the Twin Falls School District and is free. A limited number of students will be able to attend. The district is working to provide a second option if more students request online than we have room for in this program.

Orange Schedule

Students will be assigned to the A (last name begin with letters A-K) or B (last name begins with letters L-Z) group and will follow that schedule during Orange. For Kindergarten, specific information will be provided by your child's school in regards to their attendance on the alternating Mondays. The half-day on Mondays for elementary was designed to provide teachers an opportunity to assess student learning and progression, without impacting the 2 in-person instructional days, affording as much in-person instruction as possible for students. Monday student times will be 8:00-11:30, with students coming on alternating Mondays. All other days of

the week will be full school days. Teachers will use Monday afternoons for planning and preparation for the week's instruction.

**Building administrators will work with families who have children with different last names to place all children in 1 family on the same schedule and will work with families who need a schedule other than the one assigned due to work schedules etc.

Classroom/School Safety Protocols (Yellow/Orange):

Families will be expected to monitor student use of devices in the home and to help children take care of devices and help assure that devices are transported from home to school for their use at school when students are in session.

Precautions will be taken by teachers by disinfecting any school supplies that students may need to share between uses. This will include manipulatives and classroom supplies like scissors, etc. Schools will minimize the sharing of materials from student to student as much as possible.

Seating charts will be kept by teachers so that we have a record of who students are in close proximity to, to assist with contact tracing in the event of a confirmed case in a school.

Classrooms will be arranged to allow for the most social distancing possible among student desks. If classrooms use tables instead of desks, efforts will be made to social distance and not have kids facing each other as much as possible.

Classroom doors will be kept open whenever possible to minimize the use of doorknobs by staff and students and to help with airflow.

Staff and students are required to utilize a face covering (mask or shield that covers nose and mouth) within the school building. Exceptions will be made for breakfast/lunch while eating and other instances designated by school administration where social distancing can be maintained (not less than six feet for 15 minutes). All staff and students will be provided with washable masks for their use. Face shields will be provided upon request and availability. Disposable masks will also be made available. Staff will ensure students have the opportunity for a "covering break" every hour with social distancing maintained. Considerations/exceptions will be made for staff and students who provide documentation from a state licensed medical professional stating the wearing of a face covering could be a health risk for that individual. Considerations/exceptions will also be made per IEP/504 team recommendation.

Masks breaks will be provided each hour.

Teachers will use a face shield if the use of a mask may impede the educational process. This includes whole group and small group work. Clear study carrels will also be made available for students when working in small groups with teachers at a group table.

Visitors and parents will be required to make an appointment to come into the school. Visitors and parents will be required to wear a face covering when in the school for their scheduled appointment.

Block Teachers (PE/Music/Computer Lab and Library) will provide services to students in the general education classroom, rather than students

visiting the gym, music room, computer lab, and library during both yellow and orange. Classes will not be combined for these activities in an effort to keep kids as safe as possible by not sharing spaces for these classes. PE will conduct their classes outside whenever weather permits.

Interventions and Special Education

Students may be pulled into small group settings for various intervention times. This will be limited to situations where needs cannot be met with push in interventions. Intervention and special ed teachers will document seating charts and keep them in case of need for contact tracing.

Orange/Red

Students will be expected to participate in distance learning and/or to complete packet work provided during distance learning days. Teachers will be teaching the standards and grading students with standards-based grading, based on completed work whether in person, online, or through packet work.

All students who are assigned Chromebooks as their device will have weekly lessons and assignments pushed out to families through Google Classroom.

All students who are assigned ipads as their device will have weekly lessons and assignments pushed out to families through Seesaw.

Teachers will provide guidance to parents and students about how to access the online instruction.

Families will need to help their child in accessing their distance learning, and will be expected to read communications sent out from the school and assist their child in their distance learning to the best of their abilities.

Students will have breakfast and lunch available (as in a normal school year) when they are attending school in person, even for the Mondays during orange.

Parents will be expected to help their children take care of the devices they are provided.

Red

When in RED, which is full distance learning, students will be provided a minimum of two google meets opportunities each week, where they can interact with their peers and their teacher in an online format. These meetings will be recorded so that they can be provided to students who are unable to attend the live session.

Teachers will also provide students and parents with instruction and assignments every week. Students will be held accountable for the work assigned, but it will not be required that the work be completed on the very day that it is scheduled by the teachers. Teachers will monitor student participation and completion of work each week, to determine student learning and provide extra assistance to families as needed to assure students are being active participants in their learning.

Teachers will communicate with parents so that they know which day of the week and what time the weekly lessons and assignments will be disseminated to parents/students.

Teachers will provide a minimum of 1 hour for office hours, through google meets, each week day and will communicate those to parents so that parents know the specific times that they will be able to get in direct contact with teachers for assistance.

Buildings will have plans for how packet work will be disseminated and returned if in extended closure. Packet work will be used as appropriate to determine grades on specific standards.

Families will be expected to make arrangements to pick up packets for their child and support their children in completing both packet and online work.

Secondary Safety/Education Protocols for 20-21 School Year

Gatherings:

Staff and students are required to utilize a face covering (mask or shield that covers nose and mouth) within the school building. Exceptions will be made for breakfast/lunch while eating and other instances designated by school administration where social distancing can be maintained (not less than six feet for 15 minutes). All staff and students will be provided with washable masks for use. Face shields will be provided upon request and availability. In addition, disposable masks will also be made available. Staff will ensure students have the opportunity for a "covering break" every hour with social distancing maintained. Considerations/exceptions will be made for staff and students who provide documentation from a state licensed medical professional stating the wearing of a face covering could be a health risk for that individual. Considerations/exceptions will also be made per IEP/504 team recommendation.

Schools will create plans for Open Houses that will allow for smaller gatherings to meet teachers and hear classroom plans and procedures for the school year.

Schools will not hold activities that create large group gatherings in yellow, orange, or red, such as dances, programs, parent involvement nights, school assemblies, field trips, etc.

Schools will work to minimize large group gatherings during arrival and departure to and from school and during lunch.

Breakfast and Lunch:

Schools will stagger schedules as much as feasible, work to limit the number of students in the cafeteria at one time as much as possible, encourage as much social distancing as possible, have students sit at tables in a way that allows them to social distance as much as possible, providing hand sanitizer stations in cafeterias, etc.

Schools will limit visitors (including volunteers and parents) who are not staff or students in yellow and orange. Protocols for visitors are noted in the district protocol document for each color level.

Green/Yellow/Orange/Red

Teachers will communicate with parents and let them know which communication mode they will use on a regular basis (Remind, e-mail, etc.)

Teachers will respond to parent communications within 2 work days of received email and/or voicemail whenever possible.

Students will be assigned a digital device that will be for their use only. Students will use this for in-class work when needed, and to take home for online work when in

orange or red. Students will be taught the importance of only using their assigned devices.

The district provides an opportunity for a students K-8 to attend the Venture Upward School, online, for the school year, if a family is concerned about their child attending brick and mortar school. Families must register their child by September 1 in order to attend this school. This school is a Twin Falls School District school.

Orange Schedule

Students will be assigned to Group A (last name begin with letters A-K) or Group B (last name begins with letters L-Z) and will follow that schedule during the Orange Schedule.

Mondays will be an online learning day for all secondary students. Teachers will use the Monday Collaboration time for collaborating, planning, and preparing for the upcoming week.

**Building administrators will work with families who have children with different last names to place all children (elementary, middle, and high school) in one family on the same schedule.

Classroom/School Safety Protocols (Yellow/Orange):

Families will be expected to monitor student use of devices in the home and to help children take care of devices and help assure that devices are transported from home to school for their use at school when students are in session.

Teachers will take precautions by disinfecting any school supplies that students may need to share between uses. This will include classroom supplies, lab equipment,

calculators, etc. Schools will make every effort to minimize the sharing of materials from student to student.

Teachers will keep seating charts so that we have a record of who students are in close proximity to, to assist with contact tracing in the event of a confirmed case in a school.

Classrooms will be arranged to allow for the most social distancing possible among student desks. If classrooms use tables instead of desks, efforts will be made to social distance and not have kids facing each other as much as possible.

When staff are working with students and are not able to social distance they will wear face masks or shields when they need to work with a student at a distance closer than 6 feet. This will include for small group intervention instruction or when students need 1-1 help.

Visitors and parents will be required to make an appointment to come into the school. Visitors and parents will be required to wear a mask when in the school for their scheduled appointment.

The music department is working on a safety plan for choir, performance choirs, orchestra, and band classes. They are still waiting on guidance from the state and national music teachers' organizations.

Interventions and Special Education

Students may be pulled into small group settings for various intervention times. This will be limited to situations where needs cannot be met with push in interventions. Intervention and special ed teachers will document seating charts and keep in case of need for contact tracing.

Orange/Red

Students will be expected to participate in distance learning and/or to complete packet work provided during distance learning days. See the student/parent/teacher expectations document for specific information.

All students who are assigned Chromebooks as their device will have weekly lessons and assignments pushed out to students and families through Google Classroom, Schoology, Moodle, and Buzz.

Teachers will provide guidance to parents and students about how to access the online instruction and assessments.

Families will need to help their child in accessing their distance learning, and are asked to read communications sent out from the school and assist their child in their distance learning to the best of their abilities.

Red

General Guidance:

- We are committed to providing free and appropriate educational opportunities for students with disabilities, to the greatest extent possible in alignment with public health guidelines. Additionally, collaboration with families continues to be essential during this time.
- Ultimately all decisions are up to the IEP or 504 team, and each student's individual needs should be considered.
- In all levels of operation students in special education or on 504 plans should receive services comparable to what their general education peers are receiving.
- Students with IEPs/504s will be provided with materials in the same manner as general education students and have access to same instructional support via virtual platforms as their peers.
- IDEA and 504 Timelines are still in place in all levels of operation.
- Modifications and accommodations, as noted in student IEPs/504s will be provided to the extent possible and necessary, based on the type of instruction.
 - o General Education Teachers:
 - Will be cognizant of IEP and 504 accommodations, and implement the extent that they can be applied.
 - Coordinate with the IEP and 504 case managers to implement accommodations.
 - Ensure that all materials are accessible to all their students.
 - o 504 Case Managers:
 - Support general education teachers with lesson planning as needed to implement accommodations and modifications.
 - Support general education teachers with lesson planning as needed to ensure materials are accessible.
 - Will work on 504 paperwork, and meet required timelines.
 - Will communicate with parents regarding task options as needed.
 - o Special Education Teachers and Related Service Providers:
 - Support general education teachers with lesson planning as needed to implement accommodations and modifications.
 - Support general education teachers with lesson planning as needed to ensure materials are accessible.
 - Design activities for their own classes using alternate forms of instruction; virtual, phone calls, work packets, parent instruction etc...
 Activities will be related to IEP goals outlined in each student's IEP.

- Special Education and 504 Paperwork
 - o Timelines are still in place no matter if we are in green, yellow, orange or red level. Special education teachers and related service providers will continue to work on IEP/504 and evaluation paperwork within required timelines.
 - o Case managers will work with individual teams and parents if IEP/504 meetings are going to be held via phone or other virtual option.

- o all participants who are required to attend an in-person meeting, must attend in the virtual format.
- All initial or reevaluations that were put on hold during the school closure during the 2019-2020 school year will be completed within 45 calendar days if face-face assessments are safe.
- As annual reviews occur IEP and 504 teams need to consider and draft an <u>Individual Distance Learning Plan</u> that will address the red level and a potential school closure.
 - It is highly encouraged that those with smaller caseloads make contingency plans earlier.
- IEP and 504 plans will be written as if students will be attending school during the green level. The <u>Individual Distance Learning Plan</u> will outline what a students program will look like in the event of a red zone school closure.

• FAPE REQUIREMENTS Providing FAPE During School Closure

- Service times and instruction do not have to be exactly the amount as written in the IEP, but log all minutes of services will be provided.
- Alternate modes of services still need to allow progress toward IEP goals.
- Not required to amend or rewrite the IEP to include the alternate mode of providing services.
- After extended closures, case managers are responsible for reviewing how the closure impacted the delivery of special education and related services to students with IEPS on a case by case basis to determine if compensatory services are required.
- Service log and progress monitoring data will be critical for IEP and 504 teams to make future program decisions.

activities conducted by appropriate personnel for a student with a disability who has a plan developed under Section 504, or who is being evaluated under Section 504.

- All evaluations that were postponed will need to be completed within 45 days once it is deemed safe to conduct face to face assessments.
