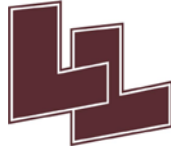


2018 LOCKHART LION PRIDE FOOTBALL CAMP

Participant agrees to indemnify and hold harmless Lockhart I.S.D., its officials, employees or volunteers from all costs and expenses of defending against such claims.

The release and indemnity obligations of Participant shall apply without regard to whether the bodily injury, property damage, or other legal injury complained of were caused, in whole or in part, by the Lockhart I.S.D., its officers, employees or volunteers. I as parent or guardian, hereby give permission for my child to participate in any and all Lockhart ISD high school camps. I hereby authorize the coaches of any and all camps to act for me according to their best judgment in any emergency requiring medical attention and acknowledge that I will be responsible for any cost incurred due to sickness or injury to my child.

This release does not waive any claim of governmental or statutory immunity or any other legal defense available to the Lockhart I.S.D. or its officials, employees or volunteers under Texas or federal law.
