Dear Brett & Carly:

Upon receipt and review of your client's responses to our Request for Production of Documents submitted to you on or about February 10, 2015, I have concluded that certain inadequacies exist, and the responses are therefore incomplete, non-responsive or offer inappropriate objections that are not supported by the Mississippi Rules of Civil Procedure.

In an effort to avoid a Motion to Compel, please accept this letter as my good faith notice, pursuant to Uniform Circuit and County Court Rule 4.04, and demand for adequate, supplemental responses to the following Requests for Production. I request supplementation with adequate responses forthwith, as they are months overdue.

Further, we take strong objection to your supplying documents and not stipulating the requests in which you are responding, which is pertinent to the document, and the discovery.

Specifically, I consider the blanket response of "This request is overbroad, unduly burdensome, irrelevant, [seeks confidential information] and is not likely to lead to the discovery of admissible evidence" on all 92 Requests for Production to be inadequate, incomplete, and unresponsive. (Attached hereto as Exhibit "A")

In addition, I received the first set of discovery responses from you, none of which have been marked or identified specifically as to the corresponding Request for Production number as required by MRCP 34(b), yet Defendant filed a Notice of Service of Discovery Responses with this Court on May 27, 2015, attached hereto as Exhibit "B." Counsel for Defendant simply lumped Discovery Requests for Plaintiffs *Almond, Lay* and *Broun* together, when in fact, *Almond*

has not only a Bill for Discovery and for Accounting before this Court, but has propounded discovery in the form of two (2) Subpoenas Duces Tecum, and a Request for Production.

For clarification, during the May 12, 2015, hearing, the Judge ordered that within ten (10) days the Defendant, SRHS provide all requested documents that a) are discoverable and b) all documents that are generated for the purposes of the Board of Supervisors Audit. Our requests were not answered, and if some of them were, they were not properly identified so that we would know to which request the response corresponded (See transcript excerpts Exhibit "C" attached hereto).

Further, on page 14 of the May 12, 2015, hearing, Judge Hilburn stated:

"I am going to require the defendant disclose sufficient discovery to adequately explain the current posture of the employee retirement system and the transactions that occurred in that system which have brought it to the circumstance it is in at this time. That is the only fair way to resolve the question about what has gone on with this retirement system is for the defendant to make a full and adequate disclosure of the transactions that have occurred and the transactions particularly that brought the retirement system into the point where the defendant feels that it is necessary that the plan be abandoned. (Exhibit "D")

Any and all billing from Morrison's to SRHS from 2009 to present, to include but not be limited to any catering events, liquor purchases, internal hospital events, external hospital events, reimbursements, specifically including the Ocean Springs Educational Foundation function held in or about 2010, and the Morrison's audit associated with that year and event as well as the check associated and proof of deposit for said payment;
- 92. Any and all correspondence between Heath Thompson and any member of SRHS and/or Morrison's regarding the catering of the Ocean Springs Education Foundation function held in or about 2010, to include, but not be limited to texts, emails, letters, or phone records.

COMES NOW the Defendant, Singing River Health System, (hereinafter referred to as "SRHS"), a community owned hospital system, by and through its Attorneys, files this its Motion To Quash the Subpoena Duces Tecum issued in the above, for a Protective Order, and for an Order staying all proceedings until the Court rules on the Motion To Recuse, and in support of said Motion would show unto the Court as follows, to-wit:


I. BACKGROUND

On January 26, 2015, Plaintiff caused a Subpoena Duces Tecum to be issued from the Chancery Clerk's office. See Subpeona Duces Tecum attached to the Motion as Exhibit 1.

On Tuesday, January 27, 2015, SRHS's General Counsel, Celeste Oglesby, was served with the Subpoena Duces Tecum. The Subpoena Duces Tecum contains fifty-eight (58) separate requests for documents and other information and commands compliance by Friday, February 6, 2015.

Prior to the issuance of this Subpoena, SRHS filed a Motion To Recuse The Honorable D. Neil Harris on January 16, 2015. The Motion To Recuse is set for hearing on February 12, 2015 before this Honorable Court.

Without waiving the matters and arguments set forth in its Motion To Recuse, SRHS moves this Honorable Court to quash the Subpoena Duces Tecum, enter a Protective Order prohibiting



production of said documents and things pursuant to MRCP 26(d), and enter an Order staying all proceedings pending the hearing on the Motion To Recuse.

II. ARGUMENT

SRHS has moved this Honorable Court to recuse itself from all actions pending against SRHS. Despite this fact, Plaintiff has served SRHS with an overly burdensome document request and requests compliance prior to the hearing on the Motion to Recuse. SRHS submits that the Court must decide the threshold Motion To Recuse prior to any further activity in this case. Plaintiffs' Subpoena Duces Tecum is premature and should be quashed.

SRHS is a party to this litigation and Plaintiff must resort to MRCP 34 to obtain requested documents rather than under MRCP 45. Plaintiff is trying to circumvent the normal discovery procedures by issuing a subpoena directly to the Defendant. Moreover, instead of serving Defendant's Attorneys with a typical request for production of documents, Plaintiff's counsel chose to personally serve SRHS's General Counsel with the subpoena when they knew the Defendant was represented by Counsel. Plaintiffs' attempt to subpoena a party, rather than a non-party contemplated by the Rule, must not be condoned.

"The leading treatises agree that although [Federal] Rule 45 may apply to both parties and non-parties, resort to Rule 45 should not be allowed when it circumvents the requirements and protection of Rule 34 for the production of documents belonging to a party.

"Although Rule 45 is not limited by its terms to non-parties, it should not be used to obtain pre-trial production of documents or things, or inspection of premises, from a party in circumvention of discovery rules or orders. Discovery from a party, as distinct from a non-party, is governed by Rule 34, not Rule 45." 7 Moore's Federal Practice, Section 34.02[5][e] (3d ed.) (citing Hasbro, Inc. v. Serafino, 168 F.R.D. 99 (D. Mass. 1996.

Stokes v. Xerox Corporation, 2006 WL 6686584 (E.D. Mich 2006) and (Construing Federal Rules of Civil Procedure which are similar to Mississippi Rules of Civil Procedure).

SRHS shows that the Subpoena Duces Tecum, containing over fifty-eight (58) enumerated requests for documents and other materials, spanning many years and involving many separate corporations, individuals and other entities, should be quashed. Pursuant to Mississippi Rule of Civil Procedure 45(d)(1)(A), SRHS contends that the Subpoena Duces Tecum requiring production within ten (10) days fails to allow a reasonable time for compliance. SRHS is entitled to the time provided in MRCP 34 and its providing for at least thirty (30) days in which to respond. SRHS is also entitled to the limitations on discoverable information as provided under MRCP 26 and case law interpreting same. The Subpoena Duces Tecum also seeks disclosure of privileged or other protected matter for which there is no exception or waiver that is applicable and also subjects SRHS to undue burden and expense in responding to same.

III. WRITTEN OBJECTIONS

Plaintiff is impermissibly trying to circumvent the Mississippi Rules of Civil Procedure governing request for production of documents and the protections afforded responding parties therein. SRHS requests that the Court enter a Protective Order precluding any compliance with Plaintiff's Subpoena Duces Tecum.

WHEREFORE, PREMISES CONSIDERED, SRHS requests that the Court quash Plaintiff's Subpoena Duces Tecum, enter a Protective Order precluding Plaintiff from obtaining the documents and information requested within said Subpoena Duces Tecum,

stay all proceedings pending the Court's ruling on the Motion to Recuse, and for such other and further relief which the Court may deem appropriate.




