# SUPPLEMENTAL REQUESTS FOR PRODUCTION OF DOCUMENTS AND THINGS PROPOUNDED TO DEFENDANT, SINGING RIVER HEALTH SYSTEM

COMES NOW the Plaintiff, CYNTHIA N. ALMOND, et al, by and through her attorneys of record, BARTON LAW FIRM, PLLC and DENHAM LAW FIRM, PLLC, and would propound the following Supplemental Requests for Production of Documents and Things, to be answered under oath by the Defendant, SINGING RIVER HEALTH SYSTEM. In answering this Supplemental Requests for Production of Documents and Things, you are required to furnish all information available to you, including information in the possession of your attorney, or any other person acting in you or your attorney's behalf, and not merely such information known of your own personal knowledge. If you cannot answer any particular interrogatory or request for production in full, after exercising due diligence to secure the information sought, so state and answer to the extent possible, specifying your inability to answer the remainder.

You are reminded that under the provisions of Mississippi Rules of Civil Procedure you are:

- (1) Under a duty to seasonably supplement your response with respect to any question directly addressed to:
  - (a) The identity and location of persons having knowledge of any discoverable matter; and

- (b) The identity of each person expected to be called as an expert witness at trial, the subject matter on which each expert witness is expected to testify, the substance of the facts and opinion of each expert witness, and a summary of the grounds for each opinion.
- (2) You are under a duty to seasonably amend a prior response if you obtain information upon the basis of which:
  - (a) You know that the response was incorrect when made; or
  - (b) You know that the response, though correct when made, is no longer true, and the circumstances are such that a failure to amend the response is, in substance, a knowing concealment.

### **DEFINITIONS**

Unless otherwise indicated, the following definitions shall be applicable to these interrogatories:

- (1) "You" or "Your" shall mean the Defendant and each of their attorneys, employees, agents or representatives, and all other persons acting on their behalf.
- (2) "Person" shall mean any individual, partnership, firm, association, corporation or other business, governmental or legal entity.
- (3) "Document" means any and each non-identical copy, whether non-identical because of alterations, attachments, blanks, comments, notes, underlining or otherwise of any writing or record whether it be a letter, email, memoranda, report, personal or handwritten note, tape, recording, videotape, digital photograph, photograph, telegram, telex, data files on computers or computer records of any kind or nature, transcript, or otherwise in the possession, custody or control of you and/or your representative, wherever the document or thing is located, however produced or reproduced, whether draft or final version. If any information requested herein is claimed to be privileged or otherwise protected from discovery, you are requested to identify in writing, with particularity, the basis for such claim, and, in the case of any document not produced, to identify in writing, its author, the date of its creation, the names, positions and capacities of all persons to whom it was addressed or by whom it has been seen, its general nature and subject matter, its present location and custodian, and the basis upon which it is claimed to be privileged or otherwise protected from discovery.
- (4) "Address" shall mean the mailing address and street address (if different from the mailing address), and include the street number and name, post office box, city, state and zip code of each subject person, business or other entity.

- (5) "Identify" or "Identification," when used with reference to a person, business, or other entity, shall mean to state the full name and present or last known address and telephone number of said person, business or other entity.
- (6) "Identify" or "Identification," when used with reference to a document, shall mean to state its date, author or signer, his address, type of document and all other means of identifying it, and its present or last known location or custodian; if any document was, but is no longer, in your possession, custody or control, state what disposition was made of it and the reason for its disposition.

- 94. Any and all corporate documents touching on or concerning the creation of Ambulatory Services, including any property purchases and sales, bank account listing, credit lines, board members, and statements of any and all accounts since the inception of Ambulatory Services to the present.
