# HDSD-2299 – Include AVI environment in AVI email subject line for new users to set up a password

#### HDSD-2749 – When setting up a new ORG, 'County' is not initially selectable

**Description:** When setting up a new ORG, 'County' is not initially selectable. A new ORG is created by entering in all required information, but 'County' has no drop down options to choose. User must attempt to save ORG and receive an error message 'Error: County is required' in order to prompt the 'County' drop down menu options to appear.

**Resolution:** 'County' drop down menu is functional to create a new ORG.

#### HDSD-2762 - View Accountability Records function is not functional

**Description:** The Daily Inventory Report is updated at midnight each night, but generating the Daily Inventory Report throughout the day can show inconsistent data.

**Resolution**: The Daily Inventory Report is now in real time.

## HDSD-3501 – Double clicking the Create Transfer or Delete Transfer or will incorrectly decrement or add inventory

**Description:** When the Create Transfer or Delete Transfer buttons are double clicked, inventory

will be incorrectly decremented or added back into inventory.

Resolution: A delay has been added to prevent double clicking for the Create Transfer and

#### HDSD-3596 - Add Serum Institute of India (SII) as manufacturer

HDSD-4179 – Change transaction type from deleted transfers from 'Received from another provider' to 'Transfer cancelled by provider'

**Description:** Add 'Transfer cancelled by provider' as a transaction type to the Lot Number Inventory Log and the Inventory Transaction Report for deleted transfers. This will help differentiate incoming transfers 'Received from another provider' versus deleted transfers 'Transfer cancelled by provider'.

**Resolution**: 'Transfer cancelled by provider' added to differentiate deleted transfers in the Lot Number Inventory Log and the Inventory Transaction Report.

Wastage Report Change Request - Add new adjustment reason: Wastage Correction

**Description:** Add positive adjustment reconciliation reason codes to the database to allow users to make lot adjustments for vaccines wastage reconciliation errors. The new Wastage Correction reason codes will be added to the Add Doses Adjustment screen on the Lot Number Maintenance Page [Update] and the Reconciliation screen. The Aggregate Wastage Report will be updated to allow incorporation of lot adjustments with the new Wastage Correction reason codes and exclude Wastage Correction from the total wastage counts. For the Expired, Spoiled, and Recall Categories, Wastage Correction – Return is to be used. For reconciliation errors involving the Wastage Category, Wastage Correction – Disposed is to be used.

**Resolution**: Added the new reconciliation reasons: Wastage Correction – Return and Wastage Correction – Disposed.

## HDSD-4172 - Internet Explorer Wastage Correction - Return pop up not functional

**Description:** When using Internet Explorer for AVI, the Wastage Correction – Return pop up is

not functional and no Doses Wasted and Returned option can be selected.

**Resolution**: The pop-up for the Wastage Correction – Return reconciliation reason is functional.

#### HDSD-4181 - Wastage Correction - Return pop up contains a spelling error

**Description:** The Wastage Correction – Return pop-up has a spelling error in the Reconciliation screen when there are no wastage return events available for selection. The pop-up says: 'There are no wastage return event to be corrected. Please select a different reason.'

**Resolution**: The 'wasatage' spelling error in the Wastage Correction – Return pop-up has been corrected.
