

**STELLA MAKE SUMMER A VACATION SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER FOR A CHANCE TO WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE SWEEPSTAKES IS INTENDED FOR VIEWING IN THE UNITED STATES ONLY AND WILL BE GOVERNED BY UNITED STATES LAW. VOID WHERE PROHIBITED.

1. ELIGIBILITY:

The “Stella Make Summer a Vacation Sweepstakes” (“Sweepstakes”) is open to legal residents of the fifty (50) United States and District of Columbia who are twenty-one (21) years of age or older at the time of entry. Employees, contractors, directors, officers and agents of Anheuser-Busch, LLC, its affiliates and subsidiaries, advertising and promotion agencies, wholesale distributors, retail licensees, and all other service agencies involved with the Sweepstakes, and members of their immediate family (spouse, parent, child and sibling) are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s and Administrator’s decisions which are final and binding in all matters related to this Sweepstakes. 2. SWEEPSTAKES PERIOD:

Sweepstakes begins at 12:00:00 a.m. Central Daylight Time (“CDT”) on May 1, 2020 and ends at 11:59:59 p.m. CDT on September 6, 2021 (“Sweepstakes Period”). The Sweepstakes Period is divided into eighteen (18) First Prize entry periods (each a “First Prize Entry Period”) and one (1) Grand Prize entry period (“Grand Prize Entry Period”) as defined in the charts below. Administrator’s computer is the official time keeping device for this Sweepstakes.

3. HOW TO ENTER:

Visit <http://stellasummersweepstakes.com/> (“Website”) and follow the online instructions to complete and submit your registration. Once you have submitted your registration, follow the online instructions to play one (1) or all four (4) games (each a “Game”) as described below. For all Entries: All Entries must be received and recorded during the Sweepstakes Period. No other forms of entry are valid.

4. SWEEPSTAKES DRAWING:

First Prize Entry Period: One (1) potential winner will be selected in a random drawing to be held on or about each First Prize Drawing Date as defined in Rule #2, from among all eligible entries received for the applicable First Prize Entry Period.

Grand Prize Entry Period: One (1) potential winner will be selected in a random drawing to be held on or about September 7, 2021 from among all eligible Entries received during the Grand Prize Entry Period as defined in Rule #2.

Non-winning First Prize Entries will carry forward to subsequent First Prize Entry Period drawings. All Entries will be eligible for the Grand Prize Entry Period drawing. All drawings will be conducted by Administrator whose decisions are final in all matters relating to this Sweepstakes. Odds of winning depend on the number of eligible Entries received during the corresponding Entry Period. Potential winners will be notified by email or phone call and will be required to respond to the notification within forty-eight (48) hours indicating whether he/she can accept the prize. If a potential winner does not respond to the notification within the forty-eight (48) hour time period, the prize will be forfeited and an alternate potential winner will be randomly selected. Any alternate potential winner selected will also be required to respond to the notification within the time frame stated above.

Potential Grand Prize winner will be required to complete, sign, and return an affidavit of eligibility and liability and, unless prohibited by law, publicity release to Sponsor or Sponsor's representative within three (3) days of prize acceptance.
