Who are we, and how do we work together?

Service Provider shall not rent, resell, or in any other way release the Customer list information or content.

Service Provider does not guaranty that the transmissions will result in any anticipated result. Service Provider does not guaranty that the provided by the Customer will operate error-free with Service Provider's messaging programs. In no event shall Service Provider's liability for any damages, regardless of the form of action, exceed the monies paid by Customer to Service Provider. Under no circumstances shall Service Provider be flable for incidental, consequential, special, or exemplary damages of any kind or for lost profits.

No employee of the Service Provider is authorized to express any opinion as to whether any content or any messaging is in compliance with any applicable law, if any such opinion is expressed, the Customer agrees that Customer will not rely upon any such opinion.

What are the Customer's Responsibilities?

Customer is responsible for all messaging using Service Provider's web based interface and client-based interface and agrees to be responsible to insure that documents uploaded and their transmission to the intended recipients, are reviewed for compliance with applicable laws, before sent messaging. Customer also warrants that neither the content nor the transmission of that content provided by the Customer violates any state of federal copyright law.

Customer may from time to time load for request assistance of loading) its content and its lists of names, addresses, telephone numbers, fax numbers, or e-mail addresses ("lists") onto the Service Provider's facilities and cause such content to be transmitted or distributed via Service Provider's massaging facilities. Whether such lists or content are created by the Customer or procured by the Customer from third parties, such lists and contents shall be deemed to have been provided by the Customer. The prevailing party in any dispute concerning this Contract shall be entitled to an award of costs and reasonable attorneys' fees incurred in enforcing same. 

MEMORANDUM OF UNDERSTANDING

Twin Falls School District Nursing Support

THIS MEMORANDUM OF UNDERSTANDING ("Memorandum") is made and entered into as of the 2th day of September 2013, between St. Luke's Magic Valley Regional Medical Center, Ltd. ("the Hospital") and Twin Falls School District, a public school district located in Twin Falls County, Idaho ("the School District").

RECITALS:

- A. WHEREAS, the Hospital is a sole community hospital that was organized and operates primarily for the benefit of Magic Valley residents.
- B. WHEREAS, the School District operates numerous public schools throughout the City of Twin Falls and a number of the primary and secondary school-age children who attend the schools require nursing services throughout the day or would benefit from a qualified school nurse being present at school.
- C. WHEREAS, as part of the Hospital's commitment to promoting a healthy community the Hospital will ensure that the School District has the school nursing services described in this Memorandum pursuant to the terms hereof.

NOW THEREFORE, in consideration of the foregoing recitals and the mutual promises and covenants hereinafter contained, the parties agree as follows:

1. Recitals.

The recitals set forth above are hereby incorporated by reference into this Memorandum as a material and substantive part of this Memorandum.

2. Hospital Responsibilities.

- 2.1 Services. The Hospital agrees to provide two duly trained and licensed registered nurses to the School District's elementary and secondary students who will each work twenty five (25) hours per week to provide the following services in cooperation with School District personnel, (collectively the "Services") during the each school year (excluding summer sessions, if any) during which this Agreement is effective:
 - a. Coordinating school health services being provided within the elementary and secondary schools;
 - b. Receiving and triaging all general school nursing questions that may be identified on a daily basis and providing appropriate referral and follow-
 - c. Providing vision screening, referral and follow-up;
 - d. Providing scoliosis screening, referral and follow-up;
 - e. Providing puberty classes to students in grades 5 and 6;

- f. Providing supervision of prescription and non-prescription medication and delivery systems;
- g. Supporting students identified by the School District needing to have health care plans in place.
- h. Responding to health care concerns as identified by school personnel;
- i. Providing health-related education presentations as requested for both students and faculty.
- j. Maintaining open lines of communication with St. Luke's Magic Valley Medical Center, South Central District Health and other District contracted nursing personnel.
- k. Providing drug testing services as requested by School District personnel.
- **2.2 Personnel.** Effective as of the date of this Agreement, two (2) duly qualified and licensed registered nurses employed by Hospital, who is mutually approved by Hospital and the School District ("Nurses"), will provide one-half the Services. This Agreement shall not in any way be construed as an employment agreement between the Hospital and the nurses who are employed to provide the Services. The Nurses will continue to be "at-will" employees.
- **2.3 Medical Supplies.** The Hospital will provide the Nurses with the supplies necessary to ensure that the Nurses can adequately provide the Services.
- **2.4 Service Locations.** The Services will be provided to the seven elementary schools, three middle schools, and three secondary schools within Twin Falls School District # 411.
- **2.5** Compensation. The Hospital agrees to employ the Nurses and pay the cost of wages and benefits in accordance with applicable Hospital policies, subject to Section 3.2 of this Agreement.

3. School District Responsibilities.

3.1 Space. The School District shall provide a suitable place for the Nurses to provide Services and perform administrative duties. The space will be equipped and insured by the School District, but the Hospital will be responsible for personal items, if any, that are stored in the space. The space provided by the School District will only be used for purposes related to providing Services and the Nurses providing Services will be directed to comply with all lawful and applicable School District policies and procedures.

3.2 Compensation.

a. The School District agrees to reimburse the Hospital for the actual cost of wages and benefits that are attributable to twenty five (25) hours of the Nurses' time per week during the 2013-2014 school year, excluding summer sessions, if any. The Nurses' actual cost of wages and benefits, that the School District will be responsible to pay for, will not exceed \$655.20 per week for this contract year. The School District also agrees to reimburse each nurse for mileage from hospital to schools/school to school and approved education-related expenses that the Nurses incur in performing Services under this Agreement. The nurses will complete the district mileage form and submit it to Support Services. The district will pay each nurse for mileage incurred in providing services to the Twin Falls School District. The Hospital will

invoice the School District for these costs on a monthly basis and the School District agrees to pay the invoice in full within thirty (30) days.

b. The School District agrees to reimburse the Hospital for the actual cost of wages, and benefits that are attributable to providing orientation for the Nurses, up to a maximum of twenty (25) hours, plus benefits.

4. Work Schedule.

The School District and the Hospital will work cooperatively to develop a work schedule which sets forth the times and days of the week that Services will be provided at each elementary and secondary school during the current school year, excluding summer sessions, if any, and non-student days.

5. <u>Confidentiality</u>.

The Hospital agrees to comply with the Health Insurance Portability and Accountability Act of 1996 and its implementing regulations, "HIPAA". The School District agrees to sign Hospital's most current Business Associate Agreement (attached hereto) and comply with its terms.

6. Status of the Parties.

It is understood and agreed that the parties shall at all times act as independent contractors. Nothing in this Memorandum shall be construed to create a joint venture, partnership, association or other affiliation or like relationship between the Hospital and the School District other than that of independent parties to a contractual relationship as set forth in this Memorandum. The Hospital staff shall not have any claim under this Memorandum against the School District for vacation pay, sick leave pay, rights to participate in the profit sharing or retirement plans of the School District or any other retirement benefits, social security disability, unemployment, worker's compensation, or other employee benefits of any kind.

7. Term of Memorandum and Termination.

- 7.1 Term of Memorandum. This Memorandum shall remain in full force and effect beginning September 2, 2013 and ending on June 6, 2014.
- 7.2 Termination. The School District may terminate this Memorandum at any time by giving at least sixty (60) days prior written notice to the Hospital of its intention to terminate. A terminating party shall use its best efforts to inform the non-terminating party of its intention to terminate so that the non-terminating party can make alternative arrangements to address an unmet need or manage unneeded staff and resources.
- 7.3 **Termination Upon Mutual Memorandum**. This Memorandum may be terminated at any time by mutual written Memorandum between the parties.

8. Miscellaneous Provisions.

- **8.1 Entire Memorandum.** This Memorandum supersedes all previous contracts or Memoranda between the parties with respect to the subject matter hereof and constitutes the entire Memorandum between the parties.
- **8.2** Amendments. This Memorandum may be amended only by an instrument in writing signed by both parties hereto.
- **8.3 Notices.** Any notice which is required or permitted to be given under this Memorandum shall be given by personal delivery or certified mail, return receipt requested, and directed to the respective party at its last known address. Unless and until changed, the address of the parties shall be as follows:

8.4 Assignment. This Memorandum may not be assignable by either party.

BUSINESS ASSOCIATE AGREEMENT

This Business Associate Agreement ("Agreement") shall be effective on the date set forth in the first Recital below, between St. Luke's Magic Valley Regional Medical Center, Ltd., a tax-exempt Idaho nonprofit corporation ("Covered Entity") and Twin Falls School District ("Business Associate").

WHEREAS, Covered Entity and Business Associate entered into an agreement whereby Business Associate would have access to protected health information, effective September 2, 2013 ("Agreement");

WHEREAS, under the terms of the Agreement, Business Associate has access to, uses or discloses, certain information provided by Covered Entity, described as protected health information ("PHI") under the Health Information Portability and Accountability Act of 1996 and its implementing regulations (collectively "HIPAA"); and

WHEREAS, HIPAA requires Covered Entity and Business Associate to enter into an agreement setting forth the parameters of Business Associate's use of the PHI according to the HIPAA regulations.

NOW, THEREFORE, in consideration of the mutual promises below and in order to comply with all legal requirements for the protection of this PHI, the parties agree as follows:

1. <u>Definitions</u>: The terms in this Agreement shall have the meanings assigned under the final HIPAA regulations now in effect or amended hereafter. Key terms are defined as follows:

Access: Means the ability, means or act of reading, writing, modifying or otherwise communicating data or information or making use of any computer system resource.

Disclose, Disclosing, or Disclosure: Means the release, transfer, provision of Access to, or divulging in any manner of information outside the entity holding the information.

Minimum Necessary Information: Means (i) in the case of routine and recurring types of Disclosures, the set of data or records which the Covered Entity's policies and procedures have established as reasonably necessary to achieve the purpose of such Disclosures; (ii) in the case of non-routine or non-recurring Disclosures, the set of data or records which the Disclosing Party determines is reasonably necessary to accomplish the purpose of the Disclosure, upon review of each Disclosure according to criteria developed by the disclosing party; provided that (iii) in the case of a Disclosure (A) to a covered entity, (B) to a professional for purposes of providing professional services to the disclosing party, or (C) to a public official for Disclosures which are permitted by law without individual consent, the Minimum Necessary Information shall be the set of data or records requested by that party, upon the party's reasonable representation that the request is for the minimum necessary given the purpose of the Disclosure(s).

2Protected Health Information (PHI): Means any information which identifies or could 1n any way concerns that individual's health status, healthcare, or payments for his or her healthcare, or which a party is otherwise legally required to protect under an information privacy and protection law applicable to that party, and includes as well any information derived by the processing of such information which is not anonymized with respect to any individual who is the subject of the information.

Use: Means the sharing, employment, application, utilization, examination, analysis, anonymization, or commingling with other information, of information by a party which holds that information.

- 2. <u>Use and Disclosure</u>: Business Associate shall not use or disclose PHI Business Associate receives from Covered Entity unless such use or disclosure contains the Minimum Necessary Information to:
- 2.1 Fulfill the Business Associate's duties and obligations enumerated in the Agreement;
- 2.2 Ensure the proper management and administration of Business Associate's business operations, provided that such disclosures are required by law, or Business Associate obtains reasonable assurances from the person to whom the information is disclosed that the information will: (i) remain confidential; (ii) only be used or further disclosed only as required by law of for the purpose for which it was disclosed to the person; and (iii) that the person will notify Business Associate of any instances when these assurances are breached.
 - 2.3 Carry out the Business Associate's legal responsibilities.
- 3. <u>Safeguards</u>: Business Associate shall use appropriate safeguards to prevent use or disclosure of PHI other than as permitted by this Agreement. In addition, Business Associate will implement administrative, physical and technical safeguards that reasonably and appropriately protect the confidentiality, integrity and availability, as those terms are defined at 45 CFR §164.304, of the electronic PHI that Business Associate creates, receives, maintains, or transmits on behalf of Covered Entity.
- 4. <u>Unauthorized Uses and Disclosures</u>: Business Associate shall immediately report any use or disclosure that is inconsistent with the terms of this Agreement or applicable law, and Business Associate shall follow Covered Entity's instructions in order to mitigate the damage cause by the unauthorized use or disclosure. Business Associate will also report any security incident (as such term is defined in the HIPAA Security Rule) of which Business Associate becomes aware in the following time and manner: (i) any actual, successful Security Incident will be reported to Covered Entity in writing, within three (3) business days of the date on which Business Associate first becomes aware of such actual successful Security Incident, and (ii) any attempted, unsuccessful Security Incident of which Business Associate becomes aware will be reported to Covered Entity in writing at the written request of Covered Entity. If the HIPAA Security Rule is amended to remove the requirement to report unsuccessful attempts at unauthorized access, this requirement shall no longer apply, effective date of that amendment.
- 5. <u>Subcontractors</u>: Business Associate shall limit its agents and subcontractors use of PHI from or on behalf of Business Associate or Covered Entity to the uses and disclosures necessary to fulfill Business Associate's obligations described in the Agreement.
- **6.** Access: Business Associate shall allow access to protected health information under the following circumstances:
- 6.1 The individual to whom the information pertains wishes to access the information, has completed Covered Entity's form, and Covered Entity has responded to the person's request by clearly identifying records that may or may not be released; or
- 6.2 The individual to whom the information pertains wishes to amend the information, has completed Covered Entity's form, the amendment has been approved, and Covered Entity is legally obligated to incorporate the amendment into information held by its agents and/or subcontractors; or
- 6.3 The Covered Entity requires access to the PHI to provide an accounting of disclosures of information, to update its internal practices, books and records; or,

- 6.4 The Secretary of the Department of Health and Human Services requires access to PHI and records that are relevant to conduct an investigation or audit of Covered Entity's compliance with the confidentiality requirements of HIPAA.
- 7. <u>Term</u>: This Agreement shall be effective from the date first set forth above until the termination date set forth in the Agreement unless:
- 7.1 The HIPAA regulations or other relevant law is amended and Business Associate refuses to amend this Agreement within fifteen (15) days after Covered Entity proposes an amendment pursuant to section 8 of this Agreement; or,
 - 7.2 Business Associate violates a material term of this Agreement.
- **8.** <u>Termination</u>: If either of the events described in sections 7.1 and 7.2 above should occur then Covered Entity shall immediately notify Business Associate of the alleged breach in writing. Such notification shall serve as notice of termination in which case, upon Covered Entity's election, Business Associate shall:
 - 8.1 Return all PHI that was received or created to Covered Entity;
 - 8.2 Destroy all PHI that was received or created; or,
- 8.3 Continue to permit Covered Entity access to any retained PHI consistent with the terms of this Agreement.
- **Amendment:** By mutual consent of the parties, this Agreement may from time to time be modified or amended in writing and such written modifications signed by the parties shall be attached to and become part of this Agreement.
- 10. Assistance in Litigation or Administrative Proceedings: Business Associate shall make itself and any agents, affiliates, subsidiaries, subcontractors or employees assisting Business Associate in the fulfillment of its obligations under this Agreement, available to Covered Entity, at no cost to Covered Entity, to testify as witnesses, or otherwise, in the event of litigation or administrative proceedings being commenced against Covered Entity, its directors, officers or employees based upon claimed violation of HIPAA, the HIPAA regulations or other laws relating to security and privacy, except where Business Associate or its agents, affiliates, subsidiaries, subcontractors or employees are a named adverse party.
- 11. <u>Effective Date</u>. This Agreement is effective as of the first date that Covered Entity provided PHI to Business Associate.

BUSINESS ASSOCIATE AGREEMENT

This Business Associate Agreement ("Agreement") is entered into between

St. Luke's Magic Valley Regional Medical Center ("Covered Entity") and ("Business Associate"), a(n)

Twin Falls School District with its principal offices located at 301 Main Ave West, Twin Falls, ID 83301.

Background

Pursuant to the parties' separate services agreement ("Services Agreement"), Business Associate has agreed to perform certain services for or on behalf of Covered Entity that may involve the creation, maintenance, use, transmission or disclosure of protected health information within the meaning of the Health Insurance Portability and Accountability Act of 1996 ("HIPAA"), and its implementing regulations, 45 CFR Parts 160 and 164 ("HIPAA Rules"). This Agreement supplements the Services Agreement and is intended to and shall be interpreted to satisfy the requirements for business associate agreements as set forth in the HIPAA Rules as they shall be amended. Business Associate understands and acknowledges that Business Associate is subject to the HIPAA Rules, and that the violation of the HIPAA Rules carry significant penalties as described in 45 CFR § 160.404.

Definitions

1. General Definitions. The following terms used in this Agreement shall have the same meaning as those terms in the HIPAA Rules: Breach, Data Aggregation, Designated Record Set, Disclosure, Health Care Operations, Individual, Minimum Necessary, Notice of Privacy Practices, Required By Law, Secretary, Security Incident, Subcontractor, Unsecured Protected Health Information, and Use.

2. Specific Definitions.

- **2.1 Business Associate** shall generally have the same meaning as the term "business associate" at 45 CFR § 160.103, and in reference to the party to this Agreement, shall mean Business Associate.
- **2.2** Covered Entity shall generally have the same meaning as the term "covered entity" at 45 CFR § 160.103, and in reference to the party to this Agreement, shall mean Covered Entity.
- 2.3 Protected Health Information (PHI) shall generally have the same meaning as the term "protected health information" at 45 CFR § 160.103, and shall include any individually identifiable information that is created, received, maintained, or transmitted by Business Associate on behalf of Covered Entity that relates to an individual's past, present, or future physical or mental health, health care, or payment for health care, whether such information is in oral, hard copy, electronic, or any other form or medium.
- **2.4** Terms used but not otherwise defined in this Agreement shall be defined as set forth in 45 C.F.R. Part 160 and Part 164, Subparts A, C, D, and E, as they shall be amended.

Agreement

3. Relationship of the Parties. Business Associate is and at all times during this Agreement shall be acting as an independent contractor to Covered Entity, and not as Covered Entity's agent. Covered Entity shall not have authority to control the method or manner in which Business Associate performs its services on behalf of Covered Entity, provided that Business Associate complies with the terms of this Agreement and the HIPAA Rules. Business Associate shall not have authority to bind Covered Entity to any liability unless expressly authorized by Covered Entity in writing, and Covered Entity shall not be liable for the acts or omissions of Business Associate. Business Associate shall not represent itself as the agent of Covered

Entity. Nothing in this Agreement shall be deemed to establish an agency, partnership, joint venture or other relationship except that of independently contracting entities.

- 4. Business Associate Responsibilities. Business Associate agrees to:
 - **4.1** Fully comply with the HIPAA Rules as they apply to business associates.
- **4.2** Not use or disclose protected health information except as permitted by this Agreement or as otherwise required by law.
- 4.3 Use appropriate safeguards to prevent the use or disclosure of protected health information other than as permitted by this Agreement. Business Associate shall comply with the requirements in 45 CFR Part 164, Subpart C applicable to business associates, including the use of administrative, physical and technical safeguards to protect electronic protected health information. In addition, if Business Associate performs activities related to Covered Entity's covered accounts as defined in 16 C.F.R. § 681.1, Business Associate will implement and comply with reasonable policies to identify, prevent, and mitigate any instance of identity theft relating to the covered accounts.
- 4.4 Immediately report to Covered Entity's Privacy Officer any use or disclosure of protected health information not permitted by this Agreement or the HIPAA Rules of which Business Associate becomes aware, including reporting breaches of unsecured protected health information as required by 45 CFR § 164.410, and reporting security incidents as required by 45 CFR § 164.314(e)(2)(i)(C). Finally, if Business Associate performs activities related to Covered Entity's covered accounts as defined in 16 C.F.R. § 681.1, Business Associate will report to Covered Entity any actual or suspected instance of identity theft involving a Covered Entity covered account. Business Associate shall report the information necessary and in such manner as to enable Covered Entity to investigate the incident and comply with Covered Entity's obligations under applicable law.
- **4.5** Mitigate, to the extent practicable, and at its sole expense, any harmful effect caused by a use or disclosure of Protected Health Information by Business Associate in violation of the requirements of this Agreement. Also, to fully cooperate with Covered Entity's efforts to promptly investigate, mitigate, and notify third parties of breaches of unsecured protected health information or security incidents as required by the HIPAA Rules.
- 4.6 Ensure that any subcontractors that create, receive, maintain, or transmit protected health information on behalf of Business Associate agree to the same restrictions, conditions, and requirements set forth in this Agreement and the HIPAA Rules applicable to such subcontractors. Business Associate may fulfill this requirement by executing a written agreement with the subcontractor incorporating the terms of this Agreement and otherwise complying with the requirements in 45 CFR §§ 164.502(e)(1)(ii), 164.502(e)(2) and 164.308(b)(2),(3).
- **4.7** Make available protected health information in a designated record set to the Covered Entity, within 10 days of request, to satisfy Covered Entity's obligations under 45 CFR 164.524. Should Business Associate or its subcontractors receive a direct request from an individual, Business Associate will promptly forward the individual's request to the Covered Entity.
- 4.8 Make any amendment(s) to protected health information in a designated record set, within 10 days of request, as directed or agreed to by the Covered Entity pursuant to 45 CFR 164.526, or take other measures as necessary to satisfy Covered Entity's obligations under 45. CFR 164.526. Should Business Associate or its subcontractors receive a direct request from an individual, Business Associate will promptly forward the individual's request to the Covered Entity.
- **4.9** Maintain and make available the information required to provide an accounting of disclosures to the Covered Entity, within 10 days of request, to satisfy Covered Entity's obligations under 45

- CFR 164.528. Should Business Associate or its subcontractors receive a direct request from an individual, Business Associate will promptly forward the individual's request to the Covered Entity.
- **4.10** To the extent Business Associate is to carry out Covered Entity's obligations under 45 CFR Part 164, Subpart E, comply with the requirements of Subpart E that apply to Covered Entity in the performance of such obligations.
- **4.11** Make its internal practices, books, and records available to the Secretary for purposes of determining compliance with the HIPAA Rules.
- 5. Uses and Disclosures by Business Associate.
- **5.1** Permissible Uses and Disclosures. Business Associate may use or disclose protected health information only as follows:
 - **5.1.1** As necessary to perform the services set forth in the Service Agreement.
 - **5.1.2** As authorized, to de-identify protected health information in accordance with 45 CFR § 164.514(a)-(c).
 - 5.1.3 As required by law.
 - **5.1.4** Business Associate may not use or disclose protected health information in a manner that would violate 45 CFR Part 164, Subpart E, if done by Covered Entity.
 - **5.1.5** Business Associate agrees to use or disclose the minimum amount of protected health information necessary for a permitted purpose pursuant to this Section 5, Covered Entity's policies and procedures, and 45 CFR § 164.502(b).
 - 5.2 Additional Use and Disclosure Provisions
 - **5.2.1** Except as otherwise limited in the underlying Agreement, Business Associate may use protected health information for the proper management and administration of the Business Associate or to carry out the legal responsibilities of the Business Associate.
 - **5.2.2** Except as otherwise limited in the underlying Agreement, Business Associate may disclose protected health information for the proper management and administration of Business Associate or to carry out the legal responsibilities of the Business Associate, provided that any disclosures for these purposes (i) are required by law, or (ii)(a) Business Associate obtains reasonable assurances from the person to whom the information is disclosed that the information will remain confidential and used or further disclosed only as required by law or for the purposes for which it was disclosed to the person, and (ii)(b) the person notifies Business Associate of any instances of which it is aware in which the confidentiality of the information has been breached.
 - **5.2.3** Except as otherwise limited in the underlying Agreement, Business Associate may use protected health information to provide data aggregation services relating to the health care operations of Covered Entity as defined in 45 CFR § 164.501.
- **6. Term and Termination.** Unless otherwise agreed in writing by the parties, this Agreement shall be effective as of the Effective Date executed by the parties and shall continue until terminated as provided below.

- **6.1 Termination.** This Agreement shall terminate on the date the Services Agreement is terminated for any reason. In addition, this Agreement may be terminated earlier as follows:
- **6.1.1** Covered Entity may terminate this Agreement without cause upon ninety (90) days prior written notice to Business Associate.
- **6.1.2** Covered Entity may terminate this Agreement upon thirty (30) days prior notice if Covered Entity determines that Business Associate or any subcontractor has violated the HIPAA Rules, a material term of this Agreement, or otherwise engaged in conduct that may compromise the protected health information. Subject to Section 6.1.3, Business Associate shall have the opportunity to cure the breach or violation within the 30-day notice period. If Business Associate fails to cure the breach or violation within the 30-day notice period, Covered Entity may declare this Agreement terminated.
- **6.1.3** Notwithstanding Section 6.1.2, Covered Entity may terminate this Agreement immediately if Business Associate or any subcontractor engages in any conduct that Covered Entity reasonably believes may result in adverse action against Covered Entity by any governmental agency or third party.
- 6.2 Termination of Services Agreement. Notwithstanding anything in the Services Agreement to the contrary, Covered Entity shall have the right to terminate the Services Agreement immediately if Business Associate's creation, maintenance, use, transmission or disclosure of protected health information is a material purpose of the Service Agreement and this Agreement is terminated for any reason.
- **6.3 Obligations of Business Associate Upon Termination.** Upon termination of this Agreement for any reason, Business Associate shall, with respect to protected health information received from Covered Entity, or created, maintained, used, or received by Business Associate on behalf of Covered Entity:
- **6.3.1** If feasible, return all protected health information to Covered Entity or, if Covered Entity agrees, destroy such protected health information.
- **6.3.2** If the return or destruction of protected health information is not feasible, continue to extend the protections of this Agreement and the HIPAA Rules to such information and not use or further disclose the information in a manner that is not permitted by this Agreement or the HIPAA Rules.
- **6.4 Survival.** Business Associate's obligations under Section 6 shall survive termination of this Agreement.
- 7. Regulatory References. A reference in this Agreement to a section in the HITECH Act or HIPAA Rules means the section as in effect or as amended.
- **8. Amendment.** The parties agree to take such action as is necessary to amend this Agreement from time to time to comply with the requirements of the HITECH Act, HIPAA Rules, the FTC Identity Theft "Red Flag" Rules, and any other applicable laws and regulations.
- **9. Interpretation.** Any ambiguity in this Agreement shall be interpreted to permit compliance with the HITECH Act, HIPAA Rules, and other applicable law.
- 10. Governing Law. This Agreement shall be construed to comply with the requirements of the HIPAA Rules, and any ambiguity in this Agreement shall be interpreted to permit compliance with the HIPAA Rules. All other aspects of this Agreement shall be governed under the laws of the State of Idaho and venue for any actions relating to this Agreement shall be in Ada County, Idaho.

- 11. Assignment/Subcontracting. This Agreement shall inure to the benefit of and be binding upon the parties and their respective legal representatives, successors and assigns. Business Associate may assign or subcontract rights or obligations under this Agreement to subcontractors or third parties without the express written consent of Covered Entity provided that Business Associate complies with Section 4.6, above. Covered Entity may assign its rights and obligations under this Agreement to any successor or affiliated entity.
- 12. Cooperation. The parties agree to cooperate with each other's efforts to comply with the requirements of the HITECH Act, the HIPAA Rules, the FTC Identity Theft Rules, and other applicable laws; to assist each other in responding to and mitigating the effects of any breach of protected health information in violation of the HIPAA Rules or this Agreement; and to assist the other party in responding to any investigation, complaint, or action by any government agency or third party relating to the performance of this Agreement. In addition to any other cooperation reasonably requested by Covered Entity, Business Associate shall make its officers, members, employees, and agents available without charge for interview or testimony.
- 13. Relation to Services Agreement. This Agreement supplements the Services Agreement. The terms and conditions of the Services Agreement shall continue to apply to the extent not inconsistent with this Agreement. If there is a conflict between this Agreement and the Services Agreement, this Agreement shall control.
- 14. No Third Party Beneficiaries. Nothing in this Agreement is intended to nor shall it confer any rights on any other persons except Covered Entity and Business Associate and their respective successors and assigns.
- **15. Entire Agreement.** This Agreement contains the entire agreement between the parties as it relates to the use or disclosure of protected health information, and supersedes all prior discussions, negotiations and services relating to the same to the extent such other prior communications are inconsistent with this Agreement.
- 16. Indemnification. Business Associate hereby agrees to indemnify, defend and hold harmless the Covered Entity and its shareholders, directors, officers, partners, members, employees, agents and/or contractors against any losses, liabilities, fines, penalties, costs or expenses (including reasonable attorneys' fees) which may be imposed upon Covered Entity by reason of any suit, claim, action, proceeding or demand by any third party which results from Business Associate's breach of this Agreement or from any negligence or wrongful acts or omissions, including failure to comply with the terms and requirements of the applicable laws and regulations by Business Associate, its shareholders, directors, officers, partners, members, employees, agents, contractors and/or subcontractors. This obligation of Business Associate to indemnify Covered Entity shall survive the termination of this Agreement for any reason.

- 17. Encryption. Business Associate and its subcontractors, if applicable, shall employ adequate data and device (desktop, laptop, USB thumb drive, CD/DVD, etc.) encryption to render the Covered Entity's protected health information data unusable, unreadable, or indecipherable to unauthorized individuals through the use of a technology or methodology tested by the National Institute of Standards and Technology and judged to meet the standard. Such protection shall also extend to any databases or collections of PHI containing information derived from the PHI as well as to PHI backups and archives.
- 18. Effective Date. The Effective Date of this Agreement shall be September 9,2013.

MEMORANDUM OF UNDERSTANDING

Twin Falls School District Nursing Support

THIS MEMORANDUM OF UNDERSTANDING ("Memorandum") is made and entered into as of the 2th day of September 2013, between St. Luke's Magic Valley Regional Medical Center, Ltd. ("the Hospital") and Twin Falls School District, a public school district located in Twin Falls County, Idaho ("the School District").

RECITALS:

- A. WHEREAS, the Hospital is a sole community hospital that was organized and operates primarily for the benefit of Magic Valley residents.
- B. WHEREAS, the School District operates numerous public schools throughout the City of Twin Falls and a number of the primary and secondary school-age children who attend the schools require nursing services throughout the day or would benefit from a qualified school nurse being present at school.
- C. WHEREAS, as part of the Hospital's commitment to promoting a healthy community the Hospital will ensure that the School District has the school nursing services described in this Memorandum pursuant to the terms hereof.

NOW THEREFORE, in consideration of the foregoing recitals and the mutual promises and covenants hereinafter contained, the parties agree as follows:

1. Recitals.

The recitals set forth above are hereby incorporated by reference into this Memorandum as a material and substantive part of this Memorandum.

2. Hospital Responsibilities.

- 2.1 Services. The Hospital agrees to provide two duly trained and licensed registered nurses to the School District's elementary and secondary students who will each work twenty five (25) hours per week to provide the following services in cooperation with School District personnel, (collectively the "Services") during the each school year (excluding summer sessions, if any) during which this Agreement is effective:
 - a. Coordinating school health services being provided within the elementary and secondary schools;
 - b. Receiving and triaging all general school nursing questions that may be identified on a daily basis and providing appropriate referral and follow-up;
 - c. Providing vision screening, referral and follow-up;
 - d. Providing scoliosis screening, referral and follow-up;
 - e. Providing puberty classes to students in grades 5 and 6;

- f. Providing supervision of prescription and non-prescription medication and delivery systems;
- g. Supporting students identified by the School District needing to have health care plans in place.
- h. Responding to health care concerns as identified by school personnel;
- i. Providing health-related education presentations as requested for both students and faculty.
- j. Maintaining open lines of communication with St. Luke's Magic Valley Medical Center, South Central District Health and other District contracted nursing personnel.
- k. Providing drug testing services as requested by School District personnel.
- **2.2 Personnel.** Effective as of the date of this Agreement, two (2) duly qualified and licensed registered nurses employed by Hospital, who is mutually approved by Hospital and the School District ("Nurses"), will provide one-half the Services. This Agreement shall not in any way be construed as an employment agreement between the Hospital and the nurses who are employed to provide the Services. The Nurses will continue to be "at-will" employees.
- **2.3 Medical Supplies.** The Hospital will provide the Nurses with the supplies necessary to ensure that the Nurses can adequately provide the Services.
- **2.4** Service Locations. The Services will be provided to the seven elementary schools, three middle schools, and three secondary schools within Twin Falls School District # 411.
- **2.5** Compensation. The Hospital agrees to employ the Nurses and pay the cost of wages and benefits in accordance with applicable Hospital policies, subject to Section 3.2 of this Agreement.

3. School District Responsibilities.

3.1 Space. The School District shall provide a suitable place for the Nurses to provide Services and perform administrative duties. The space will be equipped and insured by the School District, but the Hospital will be responsible for personal items, if any, that are stored in the space. The space provided by the School District will only be used for purposes related to providing Services and the Nurses providing Services will be directed to comply with all lawful and applicable School District policies and procedures.

3.2 Compensation.

a. The School District agrees to reimburse the Hospital for the actual cost of wages and benefits that are attributable to twenty five (25) hours of the Nurses' time per week during the 2013-2014 school year, excluding summer sessions, if any. The Nurses' actual cost of wages and benefits, that the School District will be responsible to pay for, will not exceed \$655.20 per week for this contract year. The School District also agrees to reimburse each nurse for mileage from hospital to schools/school to school and approved education-related expenses that the Nurses incur in performing Services under this Agreement. The nurses will complete the district mileage form and submit it to Support Services. The district will pay each nurse for mileage incurred in providing services to the Twin Falls School District. The Hospital will

invoice the School District for these costs on a monthly basis and the School District agrees to pay the invoice in full within thirty (30) days.

b. The School District agrees to reimburse the Hospital for the actual cost of wages, and benefits that are attributable to providing orientation for the Nurses, up to a maximum of twenty (25) hours, plus benefits.

4. Work Schedule.

The School District and the Hospital will work cooperatively to develop a work schedule which sets forth the times and days of the week that Services will be provided at each elementary and secondary school during the current school year, excluding summer sessions, if any, and non-student days.

5. <u>Confidentiality</u>.

The Hospital agrees to comply with the Health Insurance Portability and Accountability Act of 1996 and its implementing regulations, "HIPAA". The School District agrees to sign Hospital's most current Business Associate Agreement (attached hereto) and comply with its terms.

6. Status of the Parties.

It is understood and agreed that the parties shall at all times act as independent contractors. Nothing in this Memorandum shall be construed to create a joint venture, partnership, association or other affiliation or like relationship between the Hospital and the School District other than that of independent parties to a contractual relationship as set forth in this Memorandum. The Hospital staff shall not have any claim under this Memorandum against the School District for vacation pay, sick leave pay, rights to participate in the profit sharing or retirement plans of the School District or any other retirement benefits, social security disability, unemployment, worker's compensation, or other employee benefits of any kind.

7. Term of Memorandum and Termination.

- 7.1 Term of Memorandum. This Memorandum shall remain in full force and effect beginning September 2, 2013 and ending on June 6, 2014.
- 7.2 Termination. The School District may terminate this Memorandum at any time by giving at least sixty (60) days prior written notice to the Hospital of its intention to terminate. A terminating party shall use its best efforts to inform the non-terminating party of its intention to terminate so that the non-terminating party can make alternative arrangements to address an unmet need or manage unneeded staff and resources.
- 7.3 **Termination Upon Mutual Memorandum.** This Memorandum may be terminated at any time by mutual written Memorandum between the parties.

8. Miscellaneous Provisions.

- **8.1 Entire Memorandum.** This Memorandum supersedes all previous contracts or Memoranda between the parties with respect to the subject matter hereof and constitutes the entire Memorandum between the parties.
- **8.2 Amendments.** This Memorandum may be amended only by an instrument in writing signed by both parties hereto.
- **8.3 Notices.** Any notice which is required or permitted to be given under this Memorandum shall be given by personal delivery or certified mail, return receipt requested, and directed to the respective party at its last known address. Unless and until changed, the address of the parties shall be as follows:

8.4 Assignment. This Memorandum may not be assignable by either party.

BUSINESS ASSOCIATE AGREEMENT

This Business Associate Agreement ("Agreement") shall be effective on the date set forth in the first Recital below, between St. Luke's Magic Valley Regional Medical Center, Ltd., a tax-exempt Idaho nonprofit corporation ("Covered Entity") and Twin Falls School District ("Business Associate").

WHEREAS, Covered Entity and Business Associate entered into an agreement whereby Business Associate would have access to protected health information, effective September 2, 2013 ("Agreement");

WHEREAS, under the terms of the Agreement, Business Associate has access to, uses or discloses, certain information provided by Covered Entity, described as protected health information ("PHI") under the Health Information Portability and Accountability Act of 1996 and its implementing regulations (collectively "HIPAA"); and

WHEREAS, HIPAA requires Covered Entity and Business Associate to enter into an agreement setting forth the parameters of Business Associate's use of the PHI according to the HIPAA regulations.

NOW, THEREFORE, in consideration of the mutual promises below and in order to comply with all legal requirements for the protection of this PHI, the parties agree as follows:

1. <u>Definitions</u>: The terms in this Agreement shall have the meanings assigned under the final HIPAA regulations now in effect or amended hereafter. Key terms are defined as follows:

Access: Means the ability, means or act of reading, writing, modifying or otherwise communicating data or information or making use of any computer system resource.

Disclose, Disclosing, or Disclosure: Means the release, transfer, provision of Access to, or divulging in any manner of information outside the entity holding the information.

Minimum Necessary Information: Means (i) in the case of routine and recurring types of Disclosures, the set of data or records which the Covered Entity's policies and procedures have established as reasonably necessary to achieve the purpose of such Disclosures; (ii) in the case of non-routine or non-recurring Disclosures, the set of data or records which the Disclosing Party determines is reasonably necessary to accomplish the purpose of the Disclosure, upon review of each Disclosure according to criteria developed by the disclosing party; provided that (iii) in the case of a Disclosure (A) to a covered entity, (B) to a professional for purposes of providing professional services to the disclosing party, or (C) to a public official for Disclosures which are permitted by law without individual consent, the Minimum Necessary Information shall be the set of data or records requested by that party, upon the party's reasonable representation that the request is for the minimum necessary given the purpose of the Disclosure(s).

2Protected Health Information (PHI): Means any information which identifies or could 1n any way concerns that individual's health status, healthcare, or payments for his or her healthcare, or which a party is otherwise legally required to protect under an information privacy and protection law applicable to that party, and includes as well any information derived by the processing of such information which is not anonymized with respect to any individual who is the subject of the information.

Use: Means the sharing, employment, application, utilization, examination, analysis, anonymization, or commingling with other information, of information by a party which holds that information.

- 2. <u>Use and Disclosure</u>: Business Associate shall not use or disclose PHI Business Associate receives from Covered Entity unless such use or disclosure contains the Minimum Necessary Information to:
- 2.1 Fulfill the Business Associate's duties and obligations enumerated in the Agreement;
- 2.2 Ensure the proper management and administration of Business Associate's business operations, provided that such disclosures are required by law, or Business Associate obtains reasonable assurances from the person to whom the information is disclosed that the information will: (i) remain confidential; (ii) only be used or further disclosed only as required by law of for the purpose for which it was disclosed to the person; and (iii) that the person will notify Business Associate of any instances when these assurances are breached.
 - 2.3 Carry out the Business Associate's legal responsibilities.
- 3. <u>Safeguards</u>: Business Associate shall use appropriate safeguards to prevent use or disclosure of PHI other than as permitted by this Agreement. In addition, Business Associate will implement administrative, physical and technical safeguards that reasonably and appropriately protect the confidentiality, integrity and availability, as those terms are defined at 45 CFR §164.304, of the electronic PHI that Business Associate creates, receives, maintains, or transmits on behalf of Covered Entity.
- 4. <u>Unauthorized Uses and Disclosures</u>: Business Associate shall immediately report any use or disclosure that is inconsistent with the terms of this Agreement or applicable law, and Business Associate shall follow Covered Entity's instructions in order to mitigate the damage cause by the unauthorized use or disclosure. Business Associate will also report any security incident (as such term is defined in the HIPAA Security Rule) of which Business Associate becomes aware in the following time and manner: (i) any actual, successful Security Incident will be reported to Covered Entity in writing, within three (3) business days of the date on which Business Associate first becomes aware of such actual successful Security Incident, and (ii) any attempted, unsuccessful Security Incident of which Business Associate becomes aware will be reported to Covered Entity in writing at the written request of Covered Entity. If the HIPAA Security Rule is amended to remove the requirement to report unsuccessful attempts at unauthorized access, this requirement shall no longer apply, effective date of that amendment.
- 5. <u>Subcontractors</u>: Business Associate shall limit its agents and subcontractors use of PHI from or on behalf of Business Associate or Covered Entity to the uses and disclosures necessary to fulfill Business Associate's obligations described in the Agreement.
- **6.** Access: Business Associate shall allow access to protected health information under the following circumstances:
- 6.1 The individual to whom the information pertains wishes to access the information, has completed Covered Entity's form, and Covered Entity has responded to the person's request by clearly identifying records that may or may not be released; or
- 6.2 The individual to whom the information pertains wishes to amend the information, has completed Covered Entity's form, the amendment has been approved, and Covered Entity is legally obligated to incorporate the amendment into information held by its agents and/or subcontractors; or
- 6.3 The Covered Entity requires access to the PHI to provide an accounting of disclosures of information, to update its internal practices, books and records; or,

- 6.4 The Secretary of the Department of Health and Human Services requires access to PHI and records that are relevant to conduct an investigation or audit of Covered Entity's compliance with the confidentiality requirements of HIPAA.
- 7. <u>Term</u>: This Agreement shall be effective from the date first set forth above until the termination date set forth in the Agreement unless:
- 7.1 The HIPAA regulations or other relevant law is amended and Business Associate refuses to amend this Agreement within fifteen (15) days after Covered Entity proposes an amendment pursuant to section 8 of this Agreement; or,
 - 7.2 Business Associate violates a material term of this Agreement.
- 8. <u>Termination</u>: If either of the events described in sections 7.1 and 7.2 above should occur then Covered Entity shall immediately notify Business Associate of the alleged breach in writing. Such notification shall serve as notice of termination in which case, upon Covered Entity's election, Business Associate shall:
 - 8.1 Return all PHI that was received or created to Covered Entity;
 - 8.2 Destroy all PHI that was received or created; or,
- 8.3 Continue to permit Covered Entity access to any retained PHI consistent with the terms of this Agreement.
- 9. <u>Amendment</u>: By mutual consent of the parties, this Agreement may from time to time be modified or amended in writing and such written modifications signed by the parties shall be attached to and become part of this Agreement.
- 10. <u>Assistance in Litigation or Administrative Proceedings</u>: Business Associate shall make itself and any agents, affiliates, subsidiaries, subcontractors or employees assisting Business Associate in the fulfillment of its obligations under this Agreement, available to Covered Entity, at no cost to Covered Entity, to testify as witnesses, or otherwise, in the event of litigation or administrative proceedings being commenced against Covered Entity, its directors, officers or employees based upon claimed violation of HIPAA, the HIPAA regulations or other laws relating to security and privacy, except where Business Associate or its agents, affiliates, subsidiaries, subcontractors or employees are a named adverse party.
- 11. <u>Effective Date</u>. This Agreement is effective as of the first date that Covered Entity provided PHI to Business Associate.

BUSINESS ASSOCIATE AGREEMENT

This Business Associate Agreement ("Agreement") is entered into between

St. Luke's Magic Valley Regional Medical Center ("Covered Entity") and ("Business Associate"), a(n)

Twin Falls School District with its principal offices located at 301 Main Ave West, Twin Falls, ID 83301.

Background

Pursuant to the parties' separate services agreement ("Services Agreement"), Business Associate has agreed to perform certain services for or on behalf of Covered Entity that may involve the creation, maintenance, use, transmission or disclosure of protected health information within the meaning of the Health Insurance Portability and Accountability Act of 1996 ("HIPAA"), and its implementing regulations, 45 CFR Parts 160 and 164 ("HIPAA Rules"). This Agreement supplements the Services Agreement and is intended to and shall be interpreted to satisfy the requirements for business associate agreements as set forth in the HIPAA Rules as they shall be amended. Business Associate understands and acknowledges that Business Associate is subject to the HIPAA Rules, and that the violation of the HIPAA Rules carry significant penalties as described in 45 CFR § 160.404.

Definitions

1. General Definitions. The following terms used in this Agreement shall have the same meaning as those terms in the HIPAA Rules: Breach, Data Aggregation, Designated Record Set, Disclosure, Health Care Operations, Individual, Minimum Necessary, Notice of Privacy Practices, Required By Law, Secretary, Security Incident, Subcontractor, Unsecured Protected Health Information, and Use.

2. Specific Definitions.

- **2.1 Business Associate** shall generally have the same meaning as the term "business associate" at 45 CFR § 160.103, and in reference to the party to this Agreement, shall mean Business Associate.
- **2.2** Covered Entity shall generally have the same meaning as the term "covered entity" at 45 CFR § 160.103, and in reference to the party to this Agreement, shall mean Covered Entity.
- 2.3 Protected Health Information (PHI) shall generally have the same meaning as the term "protected health information" at 45 CFR § 160.103, and shall include any individually identifiable information that is created, received, maintained, or transmitted by Business Associate on behalf of Covered Entity that relates to an individual's past, present, or future physical or mental health, health care, or payment for health care, whether such information is in oral, hard copy, electronic, or any other form or medium.
- **2.4** Terms used but not otherwise defined in this Agreement shall be defined as set forth in 45 C.F.R. Part 160 and Part 164, Subparts A. C. D. and E. as they shall be amended.

Agreement

3. Relationship of the Parties. Business Associate is and at all times during this Agreement shall be acting as an independent contractor to Covered Entity, and not as Covered Entity's agent. Covered Entity shall not have authority to control the method or manner in which Business Associate performs its services on behalf of Covered Entity, provided that Business Associate complies with the terms of this Agreement and the HIPAA Rules. Business Associate shall not have authority to bind Covered Entity to any liability unless expressly authorized by Covered Entity in writing, and Covered Entity shall not be liable for the acts or omissions of Business Associate. Business Associate shall not represent itself as the agent of Covered

Entity. Nothing in this Agreement shall be deemed to establish an agency, partnership, joint venture or other relationship except that of independently contracting entities.

- 4. Business Associate Responsibilities. Business Associate agrees to:
 - 4.1 Fully comply with the HIPAA Rules as they apply to business associates.
- **4.2** Not use or disclose protected health information except as permitted by this Agreement or as otherwise required by law.
- 4.3 Use appropriate safeguards to prevent the use or disclosure of protected health information other than as permitted by this Agreement. Business Associate shall comply with the requirements in 45 CFR Part 164, Subpart C applicable to business associates, including the use of administrative, physical and technical safeguards to protect electronic protected health information. In addition, if Business Associate performs activities related to Covered Entity's covered accounts as defined in 16 C.F.R. § 681.1, Business Associate will implement and comply with reasonable policies to identify, prevent, and mitigate any instance of identity theft relating to the covered accounts.
- 4.4 Immediately report to Covered Entity's Privacy Officer any use or disclosure of protected health information not permitted by this Agreement or the HIPAA Rules of which Business Associate becomes aware, including reporting breaches of unsecured protected health information as required by 45 CFR § 164.410, and reporting security incidents as required by 45 CFR § 164.314(e)(2)(i)(C). Finally, if Business Associate performs activities related to Covered Entity's covered accounts as defined in 16 C.F.R. § 681.1, Business Associate will report to Covered Entity any actual or suspected instance of identity theft involving a Covered Entity covered account. Business Associate shall report the information necessary and in such manner as to enable Covered Entity to investigate the incident and comply with Covered Entity's obligations under applicable law.
- **4.5** Mitigate, to the extent practicable, and at its sole expense, any harmful effect caused by a use or disclosure of Protected Health Information by Business Associate in violation of the requirements of this Agreement. Also, to fully cooperate with Covered Entity's efforts to promptly investigate, mitigate, and notify third parties of breaches of unsecured protected health information or security incidents as required by the HIPAA Rules.
- **4.6** Ensure that any subcontractors that create, receive, maintain, or transmit protected health information on behalf of Business Associate agree to the same restrictions, conditions, and requirements set forth in this Agreement and the HIPAA Rules applicable to such subcontractors. Business Associate may fulfill this requirement by executing a written agreement with the subcontractor incorporating the terms of this Agreement and otherwise complying with the requirements in 45 CFR §§ 164.502(e)(1)(ii), 164.502(e)(2) and 164.308(b)(2),(3).
- 4.7 Make available protected health information in a designated record set to the Covered Entity, within 10 days of request, to satisfy Covered Entity's obligations under 45 CFR 164.524. Should Business Associate or its subcontractors receive a direct request from an individual, Business Associate will promptly forward the individual's request to the Covered Entity.
- 4.8 Make any amendment(s) to protected health information in a designated record set, within 10 days of request, as directed or agreed to by the Covered Entity pursuant to 45 CFR 164.526, or take other measures as necessary to satisfy Covered Entity's obligations under 45. CFR 164.526. Should Business Associate or its subcontractors receive a direct request from an individual, Business Associate will promptly forward the individual's request to the Covered Entity.
- **4.9** Maintain and make available the information required to provide an accounting of disclosures to the Covered Entity, within 10 days of request, to satisfy Covered Entity's obligations under 45

- CFR 164.528. Should Business Associate or its subcontractors receive a direct request from an individual, Business Associate will promptly forward the individual's request to the Covered Entity.
- **4.10** To the extent Business Associate is to carry out Covered Entity's obligations under 45 CFR Part 164, Subpart E, comply with the requirements of Subpart E that apply to Covered Entity in the performance of such obligations.
- **4.11** Make its internal practices, books, and records available to the Secretary for purposes of determining compliance with the HIPAA Rules.

5. Uses and Disclosures by Business Associate.

- **5.1 Permissible Uses and Disclosures.** Business Associate may use or disclose protected health information only as follows:
 - **5.1.1** As necessary to perform the services set forth in the Service Agreement.
 - **5.1.2** As authorized, to de-identify protected health information in accordance with 45 CFR § 164.514(a)-(c).
 - 5.1.3 As required by law.
 - **5.1.4** Business Associate may not use or disclose protected health information in a manner that would violate 45 CFR Part 164, Subpart E, if done by Covered Entity.
 - **5.1.5** Business Associate agrees to use or disclose the minimum amount of protected health information necessary for a permitted purpose pursuant to this Section 5, Covered Entity's policies and procedures, and 45 CFR § 164.502(b).

5.2 Additional Use and Disclosure Provisions

- **5.2.1** Except as otherwise limited in the underlying Agreement, Business Associate may use protected health information for the proper management and administration of the Business Associate or to carry out the legal responsibilities of the Business Associate.
- **5.2.2** Except as otherwise limited in the underlying Agreement, Business Associate may disclose protected health information for the proper management and administration of Business Associate or to carry out the legal responsibilities of the Business Associate, provided that any disclosures for these purposes (i) are required by law, or (ii)(a) Business Associate obtains reasonable assurances from the person to whom the information is disclosed that the information will remain confidential and used or further disclosed only as required by law or for the purposes for which it was disclosed to the person, and (ii)(b) the person notifies Business Associate of any instances of which it is aware in which the confidentiality of the information has been breached.
- **5.2.3** Except as otherwise limited in the underlying Agreement, Business Associate may use protected health information to provide data aggregation services relating to the health care operations of Covered Entity as defined in 45 CFR § 164.501.
- **6. Term and Termination.** Unless otherwise agreed in writing by the parties, this Agreement shall be effective as of the Effective Date executed by the parties and shall continue until terminated as provided below.

- **6.1 Termination.** This Agreement shall terminate on the date the Services Agreement is terminated for any reason. In addition, this Agreement may be terminated earlier as follows:
- **6.1.1** Covered Entity may terminate this Agreement without cause upon ninety (90) days prior written notice to Business Associate.
- **6.1.2** Covered Entity may terminate this Agreement upon thirty (30) days prior notice if Covered Entity determines that Business Associate or any subcontractor has violated the HIPAA Rules, a material term of this Agreement, or otherwise engaged in conduct that may compromise the protected health information. Subject to Section 6.1.3, Business Associate shall have the opportunity to cure the breach or violation within the 30-day notice period. If Business Associate fails to cure the breach or violation within the 30-day notice period, Covered Entity may declare this Agreement terminated.
- **6.1.3** Notwithstanding Section 6.1.2, Covered Entity may terminate this Agreement immediately if Business Associate or any subcontractor engages in any conduct that Covered Entity reasonably believes may result in adverse action against Covered Entity by any governmental agency or third party.
- **6.2 Termination of Services Agreement.** Notwithstanding anything in the Services Agreement to the contrary, Covered Entity shall have the right to terminate the Services Agreement immediately if Business Associate's creation, maintenance, use, transmission or disclosure of protected health information is a material purpose of the Service Agreement and this Agreement is terminated for any reason.
- **6.3 Obligations of Business Associate Upon Termination.** Upon termination of this Agreement for any reason, Business Associate shall, with respect to protected health information received from Covered Entity, or created, maintained, used, or received by Business Associate on behalf of Covered Entity:
- **6.3.1** If feasible, return all protected health information to Covered Entity or, if Covered Entity agrees, destroy such protected health information.
- **6.3.2** If the return or destruction of protected health information is not feasible, continue to extend the protections of this Agreement and the HIPAA Rules to such information and not use or further disclose the information in a manner that is not permitted by this Agreement or the HIPAA Rules.
- **6.4 Survival.** Business Associate's obligations under Section 6 shall survive termination of this Agreement.
- 7. Regulatory References. A reference in this Agreement to a section in the HITECH Act or HIPAA Rules means the section as in effect or as amended.
- **8. Amendment.** The parties agree to take such action as is necessary to amend this Agreement from time to time to comply with the requirements of the HITECH Act, HIPAA Rules, the FTC Identity Theft "Red Flag" Rules, and any other applicable laws and regulations.
- **9. Interpretation.** Any ambiguity in this Agreement shall be interpreted to permit compliance with the HITECH Act, HIPAA Rules, and other applicable law.
- **10. Governing Law.** This Agreement shall be construed to comply with the requirements of the HIPAA Rules, and any ambiguity in this Agreement shall be interpreted to permit compliance with the HIPAA Rules. All other aspects of this Agreement shall be governed under the laws of the State of Idaho and venue for any actions relating to this Agreement shall be in Ada County, Idaho.

- 11. Assignment/Subcontracting. This Agreement shall inure to the benefit of and be binding upon the parties and their respective legal representatives, successors and assigns. Business Associate may assign or subcontract rights or obligations under this Agreement to subcontractors or third parties without the express written consent of Covered Entity provided that Business Associate complies with Section 4.6, above. Covered Entity may assign its rights and obligations under this Agreement to any successor or affiliated entity.
- 12. Cooperation. The parties agree to cooperate with each other's efforts to comply with the requirements of the HITECH Act, the HIPAA Rules, the FTC Identity Theft Rules, and other applicable laws; to assist each other in responding to and mitigating the effects of any breach of protected health information in violation of the HIPAA Rules or this Agreement; and to assist the other party in responding to any investigation, complaint, or action by any government agency or third party relating to the performance of this Agreement. In addition to any other cooperation reasonably requested by Covered Entity, Business Associate shall make its officers, members, employees, and agents available without charge for interview or testimony.
- 13. Relation to Services Agreement. This Agreement supplements the Services Agreement. The terms and conditions of the Services Agreement shall continue to apply to the extent not inconsistent with this Agreement. If there is a conflict between this Agreement and the Services Agreement, this Agreement shall control.
- 14. No Third Party Beneficiaries. Nothing in this Agreement is intended to nor shall it confer any rights on any other persons except Covered Entity and Business Associate and their respective successors and assigns.
- 15. Entire Agreement. This Agreement contains the entire agreement between the parties as it relates to the use or disclosure of protected health information, and supersedes all prior discussions, negotiations and services relating to the same to the extent such other prior communications are inconsistent with this Agreement.
- 16. Indemnification. Business Associate hereby agrees to indemnify, defend and hold harmless the Covered Entity and its shareholders, directors, officers, partners, members, employees, agents and/or contractors against any losses, liabilities, fines, penalties, costs or expenses (including reasonable attorneys' fees) which may be imposed upon Covered Entity by reason of any suit, claim, action, proceeding or demand by any third party which results from Business Associate's breach of this Agreement or from any negligence or wrongful acts or omissions, including failure to comply with the terms and requirements of the applicable laws and regulations by Business Associate, its shareholders, directors, officers, partners, members, employees, agents, contractors and/or subcontractors. This obligation of Business Associate to indemnify Covered Entity shall survive the termination of this Agreement for any reason.

- 17. Encryption. Business Associate and its subcontractors, if applicable, shall employ adequate data and device (desktop, laptop, USB thumb drive, CD/DVD, etc.) encryption to render the Covered Entity's protected health information data unusable, unreadable, or indecipherable to unauthorized individuals through the use of a technology or methodology tested by the National Institute of Standards and Technology and judged to meet the standard. Such protection shall also extend to any databases or collections of PHI containing information derived from the PHI as well as to PHI backups and archives.
- 18. Effective Date. The Effective Date of this Agreement shall be September 9,2013.

SERVICE PROVIDER AGREEMENT BETWEEN THE TWIN FALLS SCHOOL DISTRICT NO. 411 AND THE TWIN FALLS POLICE DEPARTMENT

THIS AGREEMENT is made and entered into as of the date set forth below, by and between the TWIN FALLS SCHOOL DISTRICT NO. 411 (hereinafter "School District") and the TWIN FALLS POLICE DEPARTMENT (hereinafter "Police Department").

WHEREAS, it is mutually beneficial to the parties for the Police Department to assign Police Officers as School Resource Officers (hereinafter "SROs") to schools within the School District; and

WHEREAS, the Police Department recognizes and supports the need for safe schools and a safe academic learning environment for community youth; and

WHEREAS, the parties shall work in partnership to enhance a safe learning environment; and

WHEREAS, the parties to this Agreement mutually agree that all obligations stated or implied in this Agreement shall be interpreted in light of, and consistent with, governing state and federal laws.

NOW, THEREFORE, in consideration of the mutual agreements and covenants contained herein, the parties to this Agreement agree as follows:

- 1. <u>Rights and Responsibilities of the Twin Falls Police Department</u>: The Chief of Police shall select and appoint qualified, sworn Police Officers to staff up to five (5) School Resource Officer (SRO) positions within the School District. The duties of the Police Department are as follows:
 - 1.1. Provide law enforcement and police services, through the designation of SROs, to identified schools, school grounds, areas adjacent to the schools, and school-sponsored events. SROs shall not be expected to perform the roles of private security officers.
 - 1.2. Investigate allegations of criminal incidents which may have occurred on school grounds, areas adjacent to the schools, and school-sponsored events per Police Department policies and procedures.
 - 1.3. Enforce state and local laws and ordinances. Make appropriate referrals to juvenile authorities, other governmental agencies, or community agencies and resources when necessary and appropriate to assist students and staff.
 - 1.4. Work to prevent juvenile delinquency through close contact and positive relationships with students.

- 1.5. Establish and maintain a close partnership with school administrators in order to provide for a safe school environment. Assist school officials with their efforts to enforce Board of Education policies and procedures.
- 1.6. Ensure school administrators' safety by being present during school searches initiated by school staff, which may involve weapons, controlled dangerous substances, or in certain cases where a student's emotional state may present a risk to the administrators.
- 1.7. Assist school administrators in emergency crisis planning and building security matters. Provide a course of training for school personnel in handling crisis situations which may arise at the school.
- 1.8. Maintain high visibility within the school communities and attend and participate in various school functions. Build working relationships with school staff, as well as with student and parent groups.
- 1.9. Develop and implement classes in law-related education to support the educational efforts of the faculty.
- 1.10. Work with guidance counselors and other student support staff to assist students and to provide services to students involved in situations where referrals to service agencies are necessary. Assist in conflict resolution efforts.
- 1.11. Initiate interaction with students in the classroom and general areas of the school building. Promote the profession of Police Officer and be a positive role model. Increase the visibility and accessibility of Police to the school community.
- 1.12. Take all necessary law enforcement activity, as required, against intruders, loiterers, students, or any individual(s) disrupting the educational process, or whose presence is detrimental to the morals, health, safety, academic learning, or discipline of students at school or any school-related function, to the extent allowed by law. As soon as possible, the SRO shall inform the building principal or designee of such action(s).
- 1.13. The assigned SRO shall not act as a school disciplinarian. However, if the building principal or designee believes a particular incident violates the law, the principal or designee shall contact the appropriate SRO and that Officer shall determine whether law enforcement action is appropriate.
- 1.14. The Chief of Police, or designee, shall directly supervise the individual(s) assigned as SROs and will perform scheduled and/or non-scheduled visits to the school. A Police Supervisor shall be responsible for training, directing, and evaluating the SROs.
- 1.15. The Chief of Police, or designee, shall approve SRO reports, provide leadership, and supply assistance to the SROs in carrying out the terms of this Agreement.

- 2. <u>Rights and Responsibilities of Twin Falls School District No. 411</u>: The School District shall provide the necessary support for the SRO Program. The duties of the School District are as follows:
 - 2.1. Provide a private office to be used by the assigned SRO(s) for general business purposes, furnished with a desk, chair, work table, locking file cabinet, and office supplies, as needed; a telephone and access to a two-way radio, as needed; and a computer, as needed.
 - 2.2. Provide the SRO with a secure location for files and records.
 - 2.3. Provide access to office equipment, including, but limited to, copiers, fax machines, etc., as needed.
 - 2.4. Provide payment for the SRO services identified in the Agreement upon receipt of a billing from the City of Twin Falls, not to exceed \$122,450.00.
- 3. For the purposes of this Agreement, the Police Department and its employees are designated by the School District as its law enforcement unit. The Police Department and its employees are officially authorized by the School District to enforce laws and maintain school safety.
- 4. The assigned personnel of the Police Department, pursuant to this Agreement, are designated as school officials with legitimate educational interests and are authorized to access education records of students attending the School District as necessary to fulfill he terms of this Agreement.
- 5. The Agreement shall become effective on July 1, 2013, and remain in effect until June 30, 2014. Any changes shall be mutually agreed upon and shall be in writing. This Agreement may be terminated by either party by providing sixty (60) days' advance notice in writing to the other party.

The parties to this agreement, in consideration of the mutual covenants and stipulations set out herein, agree as follows:

ARTICLE 1. TERMS OF AGREEMENT

The period of this agreement will commence on the <u>4th</u> of September, 2013 and remain in effect until the <u>6th</u> day of June, 2014.

ARTICLE 2. RELATIONSHIP OF PARTIES

In performing services under Agreement, Provider is and shall at all times remain an independent contractor of the District. Nothing herein is to be construed as establishing an employer-employee relationship.

ARTICLE 3. CONFIDENTIALITY OF PARTIES

Provider agrees that all information regarding services provided pursuant to this Agreement, including, but not limited to, the student's identity and the nature of services rendered, shall be confidential. Provider is prohibited from disclosing any information obtained as a result of rendering services pursuant to this agreement to any individual not authorized by the District without parental consent.

ARTICLE 4. REPORTING OF ABUSE, ABANDONMENT OR NEGLECT

Provider acknowledges its obligation to comply with Idaho Code 16-1601, *et seq.* and report within 24 hours, any suspected abuse, abandonment, or neglect of a child to the Building Administrator. The building administrator will assist with further reporting.

ARTICLE 5. PROVIDER LICENCE

For the duration of the contract, the provider will maintain in effect and have in possession, all applicable licenses required by state and federal laws for occupational therapists. Provider will supply support services with a current copy of said license each year.

ARTICLE 6. INSURANCE AND LIABILITY

Provider shall be solely liable for any loses or damages resulting from Provider's performance of any of the services covered by this agreement. Provider shall indemnify and hold harmless the District from any liability including, but not limited to, costs, expenses, and attorney's fees resulting from Provider's performance of the services provided under this agreement. Providers Worker's Compensation Policy and Proof of liability insurance shall be submitted to the district within one month of the date of this agreement. Provider will provide the district with a copy of \$1,000,000,000,000, liability insurance naming Twin Falls School District as insured.

ARTICLE 7. AMENDMENT/TERMINATION

This Agreement may be amended at any time with the prior written mutual consent of both parties. Any and all amendments to this Agreement shall be in writing. Additionally, either party may terminate this Agreement within 30 days written notice.

ARTICLE 8. NON-DISCRIMINATION

The parties hereby agree that no person shall on the grounds of race, color, creed, national origin, sex, age, or disability, be excluded from or denied participation in, or otherwise subjected to discrimination under any activity performed pursuant to this Agreement.

ARTICLE 9. SCOPE AND SEQUENCE OF SERVICES

Provider agrees to provide services to Twin Falls School District students who qualify for occupational therapy via an IEP team process. Provider will supply services as described in the student's IEP. If the provider will be unavailable for a day, provider agrees to contact the schools and support services. Provider will complete timely student evaluations as directed by the evaluation team. Provider will complete eligibility report for occupational therapy. Provider will complete detailed student service reports, due to support services by the 5th of each month. Student progress reports will be completed and given to support services to be placed in student files each grading quarter. A detailed service statement will be delivered to support services before the 6th of each month for services rendered. If the statement arrives after the 6th payment will be paid the following month.

ARTICLE 10. DISTRCIT OBLIGATION

- 9. The Contractor agrees to furnish a valid certificate of insurance for Worker's Compensation and a valid certificate of liability listing the Twin Falls School District as the additional insured for \$1M to the Owner prior to work being started on the project.
- 10. Contractor must obtain all necessary permits and licenses required by the local municipal/county government to do the work.
- 11. The Contractor must furnish to the Owner a performance and payment bond each for 85% of the contracted amount to be executed by a surety company duly authorized to do business in this state prior to any work being started on the project.
- 12. In the event the Contractor is delayed in the prosecution of the work by acts of God, fire, flood or any other unavoidable casualties; or by labor strikes, late delivery of materials; or by neglect of the Owner; the time for completion of the work shall be extended for the same period as the delay occasioned by any of the aforementioned causes.
- 13. In the event the work is delayed due to neglect of the Contractor, the Contractor agrees to pay the owner the sum of \$_\$100.00 per _day as liquidated damages until such time as the work is completed.
- 14. This contract contains the entire agreement of the parties, and there are no other promises or conditions in any other agreement whether oral or written concerning the subject matter of this contract. This contract supersedes any prior written or oral agreements between the parties.
- 15. Contractor agrees to indemnify, defend, and hold harmless the Owner, and its officers, agents and employees, from and against any and all claims, losses, actions, or judgments for damages or injury to persons or property arising out of or in connection with the acts

and/or any performances or activities of Contractor, Contractor's agent, employees, or representatives under this agreement.

- 16. The Owner shall have the right to inspect all work performed under this contract. All work that needs to be inspected or tested and certified by an engineer as a condition of any government departments or other state agency, or inspected and certified by the local health officer, shall be done at each necessary stage of the project and before further work can continue. All inspection and certification (if required) will be done at the Owner's expense.
- 17. Neither the Owner nor Contractor shall have the right to assign any rights or interest occurring under this agreement without the written consent of the other, nor shall the Contractor assign any sums due, or to become due, to him under the provisions of this agreement.
- 18. This agreement shall be interpreted under the laws of the State of Idaho.
- 19. Attorney's fees and court costs shall be paid by the defendant in the event that judgment must be, and is, obtained to enforce this agreement or any breach thereof.

SERVICE PROVIDER AGREEMENT

THIS AGREEMENT, entered into on this <u>15th</u> day of <u>April, 2013</u>, between VALLEY THERAPY SERVICES, INC., Twin Falls, Idaho, (hereinafter referred to as "Provider") and TWIN FALLS SCHOOL DISTRICT, Twin Falls, Idaho (hereinafter referred to as "District") for the calendar school year 2013-2014;

The parties to this Agreement, in consideration of the mutual covenants and stipulations set out herein, agree as follows:

ARTICLE 1. TERMS OF AGREEMENT

The period of the Agreement will commence on the first day of school, 2013 And remain in effect until the last day of school, 2014.

ARTICLE 2. RELATIONSHIP OF PARTIES

In performing services under Agreement, Provider is and shall at all times be an independent contractor of the District. Nothing herein is to be construed as establishing an employer-employee relationship.

ARTICLE 3. CONFIDENTIALITY

Provider agrees that all information regarding services provided pursuant to this Agreement, including, but not limited to, the students' identify and the nature of services rendered, shall be confidential. Provider is prohibited from disclosing any information obtained as a result of rendering services pursuant to this Agreement to any individual not authorized by the District, without parental consent.

ARTICLE 4. REPORTING OF ABUSE, ABANDONMENT OR NEGLECT

Provider acknowledges its obligation to comply with Idaho Code § 16-1601, et seq. and report, within 24 hours, any suspected abuse, abandonment or neglect of a child to the law enforcement agency or Idaho Department of Health and Welfare. Provider also agrees to inform the District within 24 hours of such suspicion.

ARTICLE 5. COORDINATION OF SERVICES

To facilitate delivery of services, the District will provide 1) Reasonable and prompt notification of meetings and other appointments in which the Provider is expected to participate; 2) Signed parental consent forms, as necessary;

3) Identifying information regarding the client and the parent/guardian; and, 4) Reasonable assistance in facilitating communication between the Provider and clients, parents/guardians, and other providers and agencies.

ARTICLE 6. INSURANCE AND LIABILITY

Provider shall be solely liable for any losses or damages resulting from Provider's performance of any of the services covered by this Agreement. Provider shall indemnify and hold harmless the District from any liability including, but not limited to, costs, expenses, and attorneys' fees resulting from Provider's performance of the services provided under this Agreement. Proof of insurance shall be submitted to the District within ten (10) days of the date of this Agreement.

ARTICLE 7. AMENDMENT/TERMINATION

This Agreement may be amended at any time with the prior written mutual consent of both parties. Any and all amendments to this Agreement shall be in writing. Additionally, either party may terminate this Agreement upon 30 (thirty) days written notice.

ARTICLE 8. NON-DISCRIMINATION

The parties hereby agree that no person shall, on the grounds of race, color, creed, national origin, sex, age, or disability, be excluded from or denied participation in, or otherwise subjected to discrimination under any activity performed pursuant to this Agreement.

ARTICLE 9. SCOPE OF SERVICES

Valley Therapy Services will provide the following services in Speech/Language Pathology for the Twin Falls School District:

- Diagnostic services for children referred for speech or language problems by school personnel,
- 2. Therapeutic services for children diagnosed as having delayed or disordered speech and/or language skills.
- 3. Consultative services for parents and school personnel with respect to therapeutic management and progress of the child.
- 4. Documentation of evaluations and therapy progress as required by the Idaho State Department of Education.

- 5. Be responsible for attending pertinent Child Study Team/IEP Meetings during therapist's regular hours.
- 6. The services will be provided on an as needed basis, a specific schedule to be developed jointly by the District and Clinical personnel.
- 7. Other services as agreed upon between parties.

ARTICLE 10. ALLOWABLE COSTS FOR SERVICE

The Twin Falls School District, through its Board of Trustees, shall arrange appropriate payment to Valley Therapy Services as follows:

The fee for the above noted service shall be:

- 1. \$50.00 per contract hour for a Bachelor's Level Speech-Language Therapy Aide (SLPA)
 7 hours per day X 4 days per week
- 2. Mileage reimbursement at the current federal mileage rate if driving between schools in the District is required.
- 3. Contract hours will include evaluations, therapy, and administrative time including therapy preparation and planning, documentation, IEP development, meetings, training, consultation time, time escorting students to and from the classroom, and travel time between schools in the district.
- 4. Diagnostic and therapy materials, stickers, or other miscellaneous therapy supplies will be provided by the school district.
- 5. Payment for the previous month's services will be made promptly following the next scheduled District Board Meeting. A service fee of 1.5% will be added to any invoice not paid within 30 days of invoice date.

ARTICLE 11. BILLING
