- <u>Call to Order</u> The Board of Trustees of School District No. 411, Twin Falls County, State of Idaho, met in its regular monthly meeting at Canyon Ridge High School boardroom #301 located at 300 North College Road, Twin Falls, Idaho, at the hour of 7:00 p.m., on Monday, December 12, 2016. - <u>II.</u> <u>Pledge of Allegiance</u> The Board of Trustees stood and recited the Pledge of Allegiance to the Flag.
- III. Procedural Matters Action Items:
- 1. Approval of Agenda (Additions and Deletions) Chairman Jansen asked if there were any additions or deletions to the agenda. Superintendent Dobbs asked to remove B.1. Middle School AD Recommendation under Budget and Finance and add one early graduation request to letter O. in the consent calendar. Trustee Barron moved to approve the agenda as amended. Trustee McClintock seconded the motion. The motion passed unanimously.
- <u>IV.</u> <u>Unscheduled Delegations (Audience to Address the Board)</u> Chairman Jansen asked if there was anyone wishing to address the Board. There was no one.
- V. Superintendent Dobbs announced the classified employee of the month from Lincoln Elementary School as Percy Greene, head-custodian and classified employee of the month from Bridge Academy as Sarah Gabbard, paraeducator. Superintendent Dobbs read a brief resume' and presented Ms. Hansen, Ms. Lockwood, Mr. Greene, and Ms. Gabbard each with a gift, plaque, and gift certificate to either Jaker's or Anchor Bistro. Ms. Hansen, Ms. Lockwood, Mr. Greene, and Ms. Gabbard thanked the board for the honor.

1. Superintendent Dobbs presented the 2017-2018 draft school district calendar for board consideration. The calendar could still change with the negotiations process. This will return next month for board action.

VIII. Budget & Finance A. Information Items:

1. Director of Fiscal Affairs, Bob Seaman presented the Budget Advisory Committee's recommendation to go out for a \$9,000,000 supplemental levy. The Budget Advisory Committee recommends approval of a four million five hundred thousand dollar (\$4,500,000) levy for two years for a total of nine million dollars (\$9,000,000). Without the support of this levy the district wouldn't be able to maintain the programs it has in place. This amount is

approximately 10% of the district budget. Budget Advisory Committee is made up of district administrators, teachers, parents, students, and community members, and takes on the responsibility to advise the board on finance items such as supplemental levies, bond levies, and emergency levies. Mr. Seaman presented all the figures the Budget Advisory Committee considered when making this recommendation. The election will be March 14, 2017. This is also listed as an action item because of time constraints.

2. Director of Educational Technology & Operations, Brady Dickinson gave a brief update on the Magic Valley High School project and the cell tower conversion agreement with SBA. With this conversion no property is changing hands, this is a permanent easement giving SBA the right to have their equipment on our stadium light post. The \$132,675.00 from the cell tower conversion will help fund the Magic Valley High School project.

VIII. Budget & Finance B. Action Items:

- 1. The board discussed lowering the amount of the levy to show some good will to our patrons that may be feeling some voter fatigue. After a long discussion and the reading of the resolution by title only, Trustee Babayan moved to approve the resolution calling for a supplemental levy as per Idaho Code 33-802(3) in the amount of four million two hundred fifty thousand dollar (\$4,250,000) levy for two years for a total of eight million five hundred dollars (\$8,500,000) for the purpose of paying all lawful expenses of maintaining and operating the District for the fiscal year beginning July 1, 2017, and ending June 30, 2019. Trustee McClintock seconded the motion. Motion passed unanimously.
- 2. After a brief discussion, Vice Chairman Matsuoka moved to approve the cell tower conversion easement with SBA as presented. Trustee McClintock seconded the motion. Motion passed unanimously.
