WORKING WITH YOUR SCHOOL BOARD

<u>WELCOME</u> to another Twin Falls School District Board of Trustees Meeting. You are encouraged to attend all regular board meetings.

We are proud of our school system and the board members are dedicated to the continued improvement of the Twin Falls Schools.

We understand that from time to time patrons of school districts have concerns and feel a need to bring those concerns to the attention of the school or teachers. In order to maintain continuity and best resolve these concerns, we recommend to our patrons the following procedures:

- 1. The first and most effective step is to take the concern to the staff member who is closest to the problem. (In many cases this will be the teacher, coach, etc.) We have found that most problems are resolved at this level.
- 2. If there is still a concern on the matter, we then recommend that the concern be brought to the attention of the Principal. We have found that unresolved concerns from item #1 are usually resolved satisfactorily by the building administrator.
- 3. If the concern is not satisfactorily resolved at that level, then the concern should be taken to the Director of Elementary Programs or Director of Secondary Programs.
- 4. If the concern is not satisfactorily resolved at that level, then the concern should be taken to the Superintendent of Schools. Difficult concerns can usually be resolved.
- 5. However, if the patron still feels the concern has not been properly resolved he/she may use the right of appeal to the Board of Trustees. This is done by calling or writing to the Superintendent and asking for the item to be placed on the agenda of the next regularly scheduled board meeting.
- 6. If you desire to address the board, we would like you to be as comfortable as possible. As a board we hold public meetings which are not public forums and therefore have rules which are necessary for the benefit of all. The following guidelines will assist you as you present your information to the board.
 - A. Prepare your thoughts ahead of time. Usually a brief written outline handed to each board member helps the board follow your presentation. This outline would also give them something upon which to make notes as you speak.
 - B. If a group is involved, select one individual to be your spokesperson. He/she can then guide the presentation with the board and help the board chairman in directing questions to the group.
 - C. Plan your presentation to be as brief as possible. This should include a question/answer period. If more time is needed it is best to give a complete written presentation to the board for their future study. If you give more than five to six minutes of testimony, time restraints will make it difficult for the board to respond that same evening.
 - D. Usually the board will direct the administration to help resolve the concerns and ask for a report back to the board at a later date. However, please remember a solution may take time to be resolved.

We are eager to have our patrons and school staff working together for the improvement of education in the Twin Falls Schools.



- Identification of critical achievement gaps that become the focus of the Team;

- Development of solutions to close gaps, including local and State level actions and accountabilities;
- Shared responsibility for action, utilizing diverse areas of expertise and influence;
- Monitoring performance on closing critical gaps and when needed, expediting course corrections;
- Annually evaluating Team effectiveness in meeting or exceeding student achievement results; and
- Celebrating School performance every step of the way, while setting new achievement goals for the next school year's Annual School Improvement Plan.

By year end 2017, IBE plans to start 6-8 Student Achievement Teams across the State.

To date, Teams are in process in the following Districts: Eastern Idaho (Idaho Falls, Bonneville, Rigby and St. Anthony); Southeastern Idaho (Pocatello and potentially Twin Falls); Southwestern Idaho (Caldwell and Kuna) and North Central Idaho (Lewiston and potentially Moscow); and Northern Idaho (with potential teams in Sandpoint and Coeur d'Alene).

JOB GOAL

Under direction of the Director of Business Affairs, provides the business/finance office with support supervision in the monitoring and oversight of district budgets and financial statements especially federal programs.

ESSENTIAL DUTIES include the following (or other duties assigned by the Superintendent or Board).

Employment Responsibilities

- Supervise the Rreviewing, balancing, reporting and providing guidance to stakeholders on the accounts and budgets of the school district.
- Prepares all supporting documentation and schedules for the IFARMS Annual and Amended Budget and budget forms for review.
- Preparing and ensuring budgetary compliance for budgets, documentation, policies and reports for F-federal, special education, transportation, food service, local revenue funds, state revenue funds, special distributions and other programs.
- Assisting Supervise stakeholders in preparation of budgets and operations of the accounting system including initial budgets, budget amendments, requisition processing, tracking purchase orders, individual and program account management, the generation of related reports, and adjusting journal entries.
- Preparation and posting of monthly board reports, contracts, payable and payroll reports, budgets and audits on the Twin Falls School District website.
- Supervises and implements freight and distribution activities and personnel within the finance department.
- Compiles and presents school district financial information to budget advisory committee, negotiations team, and board members in the absence of the Director of Fiscal Affairs.
- Providing assistance to Supervise employees in the implementation and on-going operations of the district school arranding system.
- Point of contact for district independent auditor. Prepares all required statements, schedules and documentation for the annual audit.

REQUIRED SKILLS: In order to perform the above duties, the employee must:

- Possess the ability to work independently.
- Have a mastery of Microsoft Office Products software especially Microsoft Excel.
- Be able to master the district accounting software quickly.
- Be able to communicate clearly.
- Work independently and as an integral part of the finance department and the district team.
