- L Call to Order The Board of Trustees of School District No. 411, Twin Falls County, and State of Idaho, met in its regular monthly meeting at Canyon Ridge High School Boardroom #301 located at 300 North College Road, Twin Falls, Idaho, at the hour of 7:00 p.m., on Monday, July 8, 2019. The following trustees were present: Chairman, Bernie Jansen; Vice-Chairman, Bryan Matsuoka; Trustees, Mary Barron; and Todd Hubbard. There were also present Associate Superintendent, Bill Brulotte; Board Clerk, Michelle Lucas; as well as district directors, interested patrons, employees, and the media. Superintendent Dickinson and Trustee McClintock were unable to attend.
- II. Pledge of Allegiance The Board of Trustees stood and recited the Pledge of Allegiance.

III. Procedural Matters Action Items

- 1. Approval of Agenda (Additions and Deletions) Chairman Jansen asked if there were any additions or deletions to the agenda. There were none. Trustee Hubbard moved to approve the agenda as submitted. Trustee Barron seconded the motion. The motion passed unanimously.
- 2. Associate Superintendent, Brulotte introduced agenda item III. A. 1. Trustee Resignation and Declaration of Vacancy that will be effective at the conclusion of this board meeting. Trustee Hubbard shared his resignation letter and said a few words thanking District staff and the Board of Trustee for the opportunity to work with them. His letter stated that his resignation is to be effective "at the adjournment of the July 8, 2019 board meeting." Vice Chairman Matsuoka moved to accept Trustee Hubbard's letter of resignation effective at the adjournment of this board meeting. Trustee Barron seconded the motion. Motion carried unanimously.

Chairman Jansen announced that the next order of business is to declare a vacancy on the Board of Trustees. After a full and complete discussion, upon motion duly made by Trustee Barron and seconded by Vice Chairman Matsuoka the following resolution was presented:

WHEREAS, Todd Hubbard has been a member of the Board of Trustees of School District #411, having been sworn into office on July 10, 2017 after having been duly elected in accordance with the applicable laws of the State of Idaho; and WHEREAS, said trustee has resigned and resignation has been received and accepted by the Board of Trustees; and

WHEREAS, pursuant to Section 33-504, Idaho Code this Board of Trustees is required to declare a vacancy when the above stated condition exists; NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Twin Falls School District #411 hereby declares that at the end of this meeting Todd Hubbard is disqualified from holding the office of Trustee for the above stated reasons; BE IT FURTHER RESOLVED, that a vacancy on the Board of Trustees is hereby declared, which vacancy will be filled by appointment within ninety (90) days.

Chairman Jansen stated that the vacancy is in Zone 3, the candidate must live in this zone, and the appointed trustee is scheduled to serve until December 2021. Applications will be accepted through August 9, 2019 at 5:00 p.m. at the School District Office located at 201 Main Avenue West, Twin Falls.

VI. Superintendent's Report

A. Associate Superintendent, Brulotte announced the exempt employee of the month recipient for the month of July as Sheila Rinehart, purchasing agent/risk manager; classified recipient for the month of July as Sallie Snapp, payroll assistant; and classified maintenance employee of the month of July as Warren Huffaker, maintenance worker district wide. Associate Superintendent Brulotte read a brief resume' on each recipient and presented each with a gift,

plaque, and gift certificate to either Yellow Brick Café or Slice Pizza. Mrs. Rinehart, Ms. Snapp and Mr. Huffaker thanked the Board for the honor.

VII. Instruction A. Information Item:

1. Director of Secondary Programs, L.T. Erickson presented the science curriculum adoption proposal which includes Biology – HMH Science Dimensions Biology; Earth Science – HMH Science Dimensions Earth and Space Science; and Biology II – Pearson (Miller Levine). Chemistry will wait until next year for more NGSS (Next Generation Science Standards) aligned books to be published. With all three subjects there's a need for approximately 835 books at \$150 each plus teacher materials. This will get classroom sets, it would take over 1.5 million to purchase a book for every student. After some questions from the Board, Dr. Erickson said that he will make sure these books are on the State Department of Educations approved curriculum list before ordering. This item will return July 17, 2019 for board action.

VIII. Budget & Finance A. Information Items:

- 1. The Board reviewed the canned foods, frozen meats, products, non-food items, and equipment bid recommendations for August 1, 2019 through January 27, 2020. Bids recommended are: Nicholas & Company \$407,388.54 (weekly deliveries for half the year), \$32,674.34 to Nicholas & Company, \$9,069.70 to Food Services of America, \$13,895.75 to Gem State Paper & Supply, \$29,342.40 to Northwest Distribution, and \$10,439.61 to Sysco Idaho Inc. for a total request of \$502,810.34. Director of Educational Technology and Operations, Ryan Bowman shared that the increase of approximately \$12,000 is due to an increase in produce and other goods.
- 2. Associate Superintendent Brulotte shared that the Idaho State Legislature approved 3% additional money for administrative salaries. District office administration recommends this money be applied to our administrative salary schedule which will pay for a 2% increase for administrative staff. This increase is comparable to teaching staff when considering the average increase. District office administration also recommends a 2% increase for all classified staff as well. This provides for a consistent increase to all employees. The Board reviewed the Classified, Administrators, and Classified Supervisors Salary Schedules for your consideration. This item is also listed for action this evening.
