- <u>Call to Order</u> The Board of Trustees of School District No. 411, Twin Falls County, State of Idaho, met in its regular monthly meeting at Canyon Ridge High School boardroom #301 located at 300 North College Road, Twin Falls, Idaho, at the hour of 7:00 p.m., on Monday, March 9, 2020. The following trustees were present: Chairman Bryan Matsuoka; Vice Chairman Paul McClintock; Trustees, Jayson Lloyd, Heidi Casdorph, and Jonathan Lord. There were also present Superintendent, Brady Dickinson; Associate Superintendent, Bill Brulotte; and Board Clerk, Michelle Lucas, as well as district directors, interested patrons, employees, and the media.
- II. Pledge of Allegiance The Board of Trustees stood and recited the Pledge of Allegiance.
- III. Procedural Matters Action Items
- 1. Approval of Agenda (Additions and Deletions) Chairman Matsuoka asked if there were any additions or deletions to the agenda. There were none. Trustee Lloyd moved to approve the agenda as proposed. Vice Chairman McClintock seconded the motion. The motion passed unanimously.
- <u>IV.</u> <u>Unscheduled Delegations (Audience to Address the Board) Chairman Matsuoka asked if anyone was wishing to address the Board. There was no one.</u>
- V. Consent Calendar Vice Chairman McClintock moved to approve the consent calendar which included: minutes from February 9 and 20, 2020 meetings; building and board financial reports; accounts payable and payroll; monthly long term suspensions report; private service providers (PSP)/consultants/and others: Todd Whitaker as Opening Day speaker; administrator resignation for 2020-2021 school year: Jerold Guthrie; certified retirements for Tina Tauszik, Vicci Archer, and Valerie Van Leeuwen; certified resignations for 2020-2021 school year: Christine Godfry, Julie Parker, and ViAnn Aristizabal; new classified employees: Shannon Van Horn and Michelle Pato; in district transfers for Ranie Evans, and Rebecca Emery; classified retirement from Debbie Hine; classified resignations from Jessie Williams, Kaylan McKinney, and Gentry Heider; extra-curricular employees: Megan Greenwood, Tyler Rosas, and Averie Schroeder; extra-curricular resignations for 2020-2021 school year: Matt Harr and Heather Webb; student teacher request for Peggyanne Nickerson, 1st grade at Lincoln Elementary School; early graduation requests from Twin Falls High School for Meadow Fogleman and

Emma Burnham; and an extended-out of district travel request from Twin Falls High School. The motion was seconded by Trustee Lord. Motion passed unanimously.

VI. Superintendent's Report

- A/B. Superintendent Dickinson announced the certified employee of the month from Robert Stuart Middle School for the month of March as Valerie Van Leeuwen, 6th grade earth science teacher and from South Hills Middle School, Jessica Miller, tittle I teacher. Superintendent Dickinson announced the classified employee of the month from Robert Stuart Middle School as Mandie Brannen, bookkeeper and from South Hills Middle School as Bridget Tilton, registrar. Superintendent Dickinson read a brief resume' and presented each Ms. Van Leeuwen, Ms. Miller, Ms. Brannen, and Ms. Tilton with a gift, plaque, and gift certificates for either Buffalo Wild Wings or Tomato's Italian Grill. Ms. Van Leeuwen, Ms. Miller, Ms. Brannen, and Ms. Tilton thanked the board for the honor.
- C. Superintendent Dickinson introduced Tonia Burk who submitted the request to place an honorary rock monument at the Twin Falls High School Softball field for Dan Creek, a retired softball/baseball coach that passed away April 2019. The proposed monument will be a 3x3' engraved rock slab installed at Twin Falls High School baseball field. Director of Educational Technology and Operations, Ryan Bowman reassured the Board that from a maintenance standpoint this monument won't require school district funds or cause any inconvenience to maintain. Vice Chairman McClintock moved to approve the monument proposal as submitted. Trustee Casdorph seconded the motion. Motion passed unanimously. Ms. Burk said the dedication will be held April 3, 2020.
- D. Dr. Dickinson shared with the Board that Twin Falls High School Boys Basketball Varsity team earned the 2019-2020 Winter Sports/Activities Academic State Champion Award for achieving the highest cumulative grade point average for a 4A Idaho School.

VII. Instruction A: Information Items:

1. Superintendent Dickinson along with the Elementary School Attendance Zone Committee members shared recommended changes for the 2020-2021 school year. The Board discussed the map in the board packet showing recommended adjustments to elementary school attendance zones. Sawtooth Elementary School is the only boundary that doesn't have proposed changes. The committee stood for questions from the Board. This item returns for action next month.

VII. Instruction B. Action Items:

1. Director of Secondary Programs, L.T. Erickson stood for question on the course proposals for Financial Literacy and Robotics/Integrated Mathematics curriculum. After a brief discussion, Vice Chairman McClintock moved to approve Financial Literacy and Robotics/Integrated Mathematics proposals as submitted. Trustee Lloyd seconded the motion. Motion passed unanimously.

VIII. Budget & Finance A. Information Items:

- 1. Superintendent Dickinson shared updated budget information and shared his budget committee's recommendations for adjustments for the shortfalls districtwide. He began by briefly explaining how school finance works, how funding units are funded based on student ADA for payment. Administration tries to calculate/project budgets based off 95% attendance. This year the district should have budgeted out less to other building/administrator budgets. However, because the classified were not calculated in the projections/budgets back in April 2019 it's difficult this time of year, when budgets are pretty much spent, to pull them back. By making these committee recommended changes the district should be able to end the year in the positive, with a small carryover. The carryover has dwindled for two reasons: the district lived on carryover during recession, and built two schools while coming out of the recession. Dr. Dickinson shared that concerning issues in Twin Falls is the drop in attendance and drop in enrollment growth from previous years. Next year, we may not qualify for the emergency levy, which is additional funds the district qualifies for when our enrollment increases from the previous year. We need to prepare for the worst, and create the 2020-2021 budget not expecting to qualify for an emergency levy and focus on building carryover. Some board action may be needed throughout this process such as approving the list of people that won't receive notice of reasonable assurance. The committee considered everything but ultimately concentrated on maximizing opportunities for students and having as minimal impact on staff as possible. Dr. Dickinson pointed out that the last item listed for recommended reductions is "Additional options to be considered during 2020-2021 contract negotiations" because additional changes could Building the carryover will probably be a 5-year process to get to 3 million carryover. Dr. Dickinson stood for questions from the Board, then stated that he is trying to be transparent, open to ideas, and be proactive throughout this process.
- 2. The Board reviewed bid recommendations from Purchasing Agent, Sheila Rinehart for janitorial supplies which is paid for by plant facilities money, not the general fund where the shortfall is currently. This is also listed as an action item because this is a time sensitive matter.
- 3. Rachel Youren from Twin Falls School District's finance department pulled up on the screen board/school buildings financials and accounts payable/payroll reports as published in our board packets online. Miss Youren shared step by step how the board can review the data for consideration each month. This information is published monthly at the same time as the board packets online.

VIII. Budget & Finance B. Action Items:

1. After a brief discussion, Vice Chairman McClintock moved to approve janitorial supply bids as recommended for a total of \$88,874.88 as proposed by Purchasing Agent Sheila Rinehart. Trustee Lloyd seconded the motion. Motion passed unanimously.
