WORKING WITH YOUR SCHOOL BOARD

<u>WELCOME</u> to another Twin Falls School District Board of Trustees Meeting. You are encouraged to attend all regular board meetings.

We are proud of our school system and the board members are dedicated to the continued improvement of the Twin Falls Schools.

We understand that from time to time patrons of school districts have concerns and feel a need to bring those concerns to the attention of the school or teachers. In order to maintain continuity and best resolve these concerns, we recommend to our patrons the following procedures:

- 1. The first and most effective step is to take the concern to the staff member who is closest to the problem. (In many cases, this will be the teacher, coach, etc.) We have found that most problems are resolved at this level.
- 2. If there is still a concern on the matter, we then recommend that the concern be brought to the attention of the Principal. We have found that unresolved concerns from item #1 are usually resolved satisfactorily by the building administrator.
- 3. If the concern is not satisfactorily resolved at that level, then the concern should be taken to the Director of Elementary Programs or Director of Secondary Programs.
- 4. If the concern is not satisfactorily resolved at that level, then the concern should be taken to the Superintendent of Schools. Difficult concerns can usually be resolved.
- 5. However, if the patron still feels the concern has not been properly resolved he/she may use the right of appeal to the Board of Trustees. This is done by calling or writing to the Superintendent and asking for the item to be placed on the agenda of the next regularly scheduled board meeting.
- 6. If you desire to address the board, we would like you to be as comfortable as possible. As a board, we hold public meetings, which are not public forums and therefore have rules, which are necessary for the benefit of all. The following guidelines will assist you as you present your information to the board.
 - A. Prepare your thoughts ahead of time. Usually a brief written outline handed to each board member helps the board follow your presentation. This outline would also give them something upon which to make notes as you speak.
 - B. If a group is involved, select one individual to be your spokesperson. He/she can then guide the presentation with the board and help the board chair in directing questions to the group.
 - C. Plan your presentation to be as brief as possible. This should include a question/answer period. If more time is needed it is best to give a complete written presentation to the board for their future study. If you give more than five to six minutes of testimony, time restraints will make it difficult for the board to respond that same evening.
 - D. Usually the board will direct the administration to help resolve the concerns and ask for a report back to the board at a later date. However, please remember a solution may take time to be resolved.

We are eager to have our patrons and school staff working together for the improvement of education in the Twin Falls Schools.

The following trustees were present: Chairman Bryan Matsuoka; Vice Chairman Jonathan Lord, Trustees Heidi Casdorph, and Jayson Lloyd. There were also present Superintendent of Schools, Brady D. Dickinson; Board Clerk, Michelle Lucas; Associate Superintendent, Bill Brulotte; as well as directors, interested patrons, employees, and the news media. Due to State of Idaho social distancing and gathering restrictions, overflow rooms with the meeting projected on screens, were provided each time the 10 person limit was reached. The meeting was also streamed via Zoom. Trustee Paul McClintock was unable to attend.
- II. <u>Pledge of Allegiance</u> The Board of Trustees stood and recited the Pledge of Allegiance.
- III. <u>Procedural Matters Action Items:</u>

Approval of Agenda (Additions and Deletions) – Chairman Matsuoka asked if there were any additions or deletions to the agenda. There were none. Vice Chairman Lord moved to approve the agenda. Trustee Casdorph seconded the motion. The motion passed unanimously.

IV. <u>Unscheduled Delegations (Audience to Address the Board)</u> – Chairman Matsuoka asked if there was anyone wishing to address the Board. There was no one.

V. <u>Consent Calendar</u>

Trustee Lloyd moved to approve the consent calendar, which included: administrator retirement for Teresa Jones as Director of Elementary Programs; certified retirement from Karla Lucas; certified release of contract for Diane Nelson; new classified employees: Caryl Miller, Victor Martinez, Addie Hall, and Jenny Castleberry; classified in district transfer for Robbi Gibson; classified resignations from Taylar Johnston, and Brycen Rogers; new extracurricular employees: Daniel Gardner, Jason Cornwell, Daniel Green, Jasmine Robertson, and Jared Sorenson; current active guest teacher list; current temporary employee list; and early graduation requests for Colby Hagan (CRHS) and Spencer Lauda (TFHS). The motion was seconded by Vice Chairman Lord. Motion passed unanimously.

VI. Student Panel Discussion with the Board

The Board had a thirty minute discussion with a panel of six students: 5th graders from Pillar Falls Elementary School: Grace Hurd and Jackson Caywood; 8th graders from South Hills Middle School: Bronson Fennel and Besiha Larsen; 12th graders from Twin Falls High School: Josh Mix and Raleigh Brittain. The Board asked questions about the student's experiences at their schools with online schooling; learning with COVID concerns; how they feel about online Monday's; what they think of the hybrid schedule and the schedule now; and their highlight of the year so far. After a great discussion with the students, the Board thanked the students for their feedback and participation.

VII. <u>Legislative Update</u>

Superintendent Dickinson gave a legislative update on the work being done on the Governor's order to freeze the salary allocation which froze the career ladder. The District was notified that the freezing of the career ladder wasn't going to stick for the full 2020-2021 school year. When they unfreeze the salary allocation the money needed to backfill the career ladder will be taken out of discretionary money. The idea is that the CARES Act, ESSR I, and now the ESSR II money can be used to backfill what will be lost in discretionary money. There are rules and strings attached to these funds to meet all the regulations. This will be challenging for our human resources/payroll department. Because these funds are for this year, we have a need to go back and negotiate the 2020-2021 salary schedule. Also once these negotiations are finalized, we have to turn around and start negotiations for 2021-2022 school year. Superintendent Dickinson is hopeful that this can be done before spring break. He also shared the aspect of the advanced professional rung/level. The State Department wasn't prepared to fund the new level this year. He is asking the board to authorize reopening 2020-2021 negotiations on a limited scope to establish an updated salary schedule. The District is still waiting on the action from JFAC to establish the multiplier which won't happen for the next couple of weeks. With no other questions, Vice Chairman Lord moved that due to the unfreezing of the career ladder by the state, that the Board authorize the superintendent to reopen a limited scope negotiations with the Twin Falls Education Association for the purpose of establishing an updated salary schedule for 2020-2021 school year. Trustee Lloyd seconded the motion. Motion passed unanimously. Chairman Bryan Matsuoka and Trustee Paul McClintock are the trustees on the negotiations team with superintendent and other directors. Superintendent Dickinson is hoping for middle to late February for these negotiations.

VIII. <u>Supplemental Levy Presentation</u>

Superintendent Dickinson presented Supplemental Levy information to the Board. The levy election will be March 9, 2021 for \$5,700,000 per year for two (2) years, for the purpose of paying all lawful expenses of maintaining and operating the District for the fiscal years beginning July 1, 2021, and ending June 30, 2023 as approved by the Board on December 14, 2020. Superintendent Dickinson shared district operating costs, per pupil spending (Idaho is 51st state in student spending), bond savings, tax relief and the amount the tax rate would decrease if levy passes. There is a public meeting that may be online only, depending on restrictions, set for February 25, 2021 at 7:00 p.m.

IX. 2015-2020 Strategic Plan Tasks Update

Director of Community Relations, Eva Craner reviewed the updated Strategic Plan action plans for 2020-2021. She touched on a few actions in each focus area: Life Ready Students, Quality Learning Opportunities, A Healthy Learning Community, Quality Personnel, School

Community Public Relations, School Environment and Facilities, and Stewardship of Resources then stood for questions from the Board. Trustees asked for a report in February on how the kids are adjusting to the non-normal-normal right now and to hear from staff on students and staff health and wellness issues. Teresa Jones and LT Erickson will give a report in February.

X. Report: Governor's Order on Gatherings and Spectators

Superintendent Dickinson shared updated information on the Stage 2 Athletics Plan for Governor's Orders on Gatherings and Spectators at school events. The most recent order, which has changed three times since January 11th, currently states that each participant may have 4 spectators each at the event or the district can use up to 40% of the gyms (rooms) capacity for each activity. It also gives specific numbers for non-participating essential personnel allowed in the room. The most recent order removed the cleaning between games because people were congregating out in smaller rooms while they waited for the gym/room to be cleaned.

- 1. Building Goals: 1 Rock Creek Elementary subgroup, students with disabilities, will close the achievement gap by 10% in ISAT ELA and Math. 18/19 ISAT ELA gap was 36.5% and the math gap was 48%. 2 Rock Creek Elementary students will show 7% growth on 2021 Spring ISAT and IRI tests.
- 2. **Growth Towards Goals** ISAT testing timeline is utilized throughout the year. Istation work is also utilized. All students 1st 5th have chromebooks and we have iPads for every kindergarten student. Along with small group interventions, we utilize our EL para, 3 literacy paras, SpEd and ERC paras in order to facilitate small group work as we are in year 3 of our push in model for all students. K-3 teachers utilize the "Planning for Reading Intervention" Guide to determine small group work. We are also in Year 1 of our Co-teaching model working closely in 3rd and 5th grade.
- 3. <u>Growth Indicators</u> IRI Kindergarten: Fall 53%, January 49%; First Grade: Fall 47%, January 55%; Second Grade: Fall 49%, winter 57%; Third Grade: Fall 62%, January 60%. Istation Fourth Grade: Fall 65%, January 68%; Fifth Grade: Fall 64%, January 70%
- 4. <u>Instructional Focus/Priorities</u> We continue to establish/adjust the instructional routines and strategies necessary to help all students be successful in a non-Title One school. The staff has worked together to determine best practices and continue to review those to help student success. We also look outside the box to make small group adjustments as well. The staff continues to utilize various data models, Impact Team, PLC and Reading Intervention Analysis as they review data. We are also in year two of our literacy coaching work with EdNwest. We are in year three of the push in model for core curriculum and are pleased with progress. This is also the first year of implementing our co-teaching instruction in 3rd and 5th grade.
- 5. <u>School Improvement Initiatives</u> We have received a 3 year PBIS Grant through the state and in year 2 of full implementation. We recognized the need for an EL para and with the loss of the EL grant have committed building funds to support the EL para. We utilize several data protocols Impact Team Training, PLC and Reading Intervention Analysis to utilize what best fits the work.
- 6. <u>Interventions and Extensions</u> Various intervention models are used throughout the building with the help of three K-3 Literacy paras and an EL para. Interventions used are Wonder Works, SIPPS, Read Naturally, Istation Reading and Math, Bridges Intervention and small group instruction with a certified teacher. Genius Hour is also utilized as an extension in many grade levels each week. We are also utilizing our Literacy paras on Mondays as they do Read Live interventions online. All information is placed in Mileposts.
- 7. <u>Leadership Premium Usage</u> tutoring (grade level and EL), Student Council. We are hoping to reinstate Leadership Camp, Kindness Club and our Robotics clubs next year.
- 8. <u>Challenges</u> Large Class Sizes are beginning to be a concern in multiple grade levels; student population increasing (605); strong need for additional para help in order to more effectively implement our Push In and co-teaching Models for all grades. Push in model is where we provide core instruction for all learners which includes special education students. This allows for all students to have access to core instruction before receiving more individualized skill needs.
- 9. <u>Bright Spots</u> Top Performer in Math Growth from Spring 2019; Goal Maker in ELA, Math and ELL from Spring 2019; PBIS Grant for 3 years; Push in Model Implementation continued; co-teaching model; weekly recognition of students; Quarterly Celebrations (academic and PBIS) parental support; Positive culture; Morning Mile (1st school in Idaho to implement this program) teachers willing to tutor students for a small amount of time during the week.

1. Building Goals:

- Improve Math Scores 25% of students at Magic Valley High School meeting continuous enrollment of 56+ days will demonstrate growth of one year. Math scale scores will measure growth from 2018-19 to 2020-21.
- Improve ISAT ELA Scores 50% of students at Magic Valley High School meeting continuous enrollment of 56+ days will demonstrate growth of one year as measured by ELA ISAT scale scores from 2018-19 to 2020-21.
- Improve our graduation rate We have increased our graduation rate from 30% during the 2018-19 school year to 40.9% in the 2019-20 school year as measured by the Idaho State Dept of Education. We will continue to look at ways to increase the graduation rate by 5% each year.

2. Growth Towards Goals:

At the building level, a shared leadership structure is in place with our CSI Up leadership team, which meets monthly and is chaired by the administrator. This team is comprised of the building administrator, three teachers (math, ELA and business), counselor, college and career adviser, instructional coach, parents, students and an SDE capacity builder. The focus of the CSI Up team is school improvement, assessment, instruction and accountability. Decisions made by the CSI Leadership team are communicated to the faculty through shared agendas and meeting minutes. Time for input and discussions from the entire staff is provided at faculty meetings. This structure allows the CSI Up Leadership team to effectively communicate with varied representatives from stakeholder groups and work collaboratively on school improvement efforts, and at the same time,

provide and support meaningful leadership roles for staff and stakeholders. The building administrator facilitates those conversations and discussions, with other members of the CSI team available to answer questions and share information.

- In 2019 22% of our 10th graders tested proficient or above in ELA, and no students were proficient in math, as compared to 2018 where none of the 10th grade students met proficiency on the math and ELA ISAT. We were not able to test students last year, so we will compare the 2019 numbers to the levels our students test this year.
- Student assessment and achievement data is reviewed during the district's Data Day in September and after their interim assessments in Achieve 3000 and STAR Math. Assessment results provide direction for interventions and class placement during the school year. In addition, individual teachers review their students' pre-assessments, End-of-Course Assessments, as well as their individual achievement data to guide instruction.

3. Growth Indicators:

- MVHS utilizes several universal screeners to measure student growth throughout the year.
- Achieve3000, an online program, is used to screen students and to facilitate a school wide reading intervention. Achieve 3000 is based on scientific research and is a proven and patented method of online differentiated reading instruction. It is designed for Tier I group instruction and is fully equipped to support instruction in reading comprehension, writing, vocabulary, fluency, and foundation skills. Students are required to complete an activity twice weekly and progress is monitored and levels are adjusted within the program for growth; reports are used by the classroom teachers to inform students and parents of progress. All MVHS students are assessed three times a year; once upon registration, at the beginning of second semester and again during our last term. Students whose scores fall below the basic Lexile level or are not making adequate yearly progress of 40 Lexile points per year are compiled to be reviewed by the RTI Team for monitoring or Tier II intervention.
- All students at MVHS are also screened using STAR Math, once at the beginning of the year, or upon enrollment, at the beginning of second semester and at the end of the year. The results of this assessment is reviewed by the RTI Team and students will be identified for remediation and/or Tier II interventions by the team.
- All students write a short essay as part of the enrollment process to give us an idea of their writing skills. We also have three all-school-writes throughout the year and each student is scored based on a common rubric.
- MVHS also uses an online mathematics program called Fast Math to facilitate a school wide Tier I math intervention. Students begin with addition and progress through pre-algebra concepts, all aligned to CCSS. Our lowest below basic scorers are scheduled into an intensive Tier II intervention class, utilizing the Math 180 program, offered four times yearly. Progress and improvement will be assessed using the students' STAR Math scores.
- All scores are reviewed by the faculty for validity and inconsistencies by comparing student's longitudinal scores from screeners, state assessments, and district benchmarks using Silverback's

Mileposts data program which compiles all assessments, interventions, plans, and behavioral reports. Parents of students recommended for Tier II interventions are contacted by letter with a form that is to be signed giving consent for the student to be designated for intervention. Students are then enrolled in a Read 180 class for Tier II intervention which is documented and progress monitored in Mileposts and reports are used to assess student progress, make recommendations for interventions, and inform administration, parents, and students of student's progress.

4. Instructional Focus/Priorities:

- The students at MVHS have two levels of learning needs. First is a more general need as evidenced by their grades and achievement levels upon enrollment at MVHS. Our students have not been successful in traditional schools; they need a change in environment, they need a different approach to education, and they need a clean slate, all of which they receive at MVHS.
- More specifically, our students struggle with core subjects, which is clearly delineated in our placement assessments (Star Math, Achieve 3000), ISAT data, and historical grades. Our math department assesses students' specific gaps and provides daily math lessons, utilized in advancement class twice a week, to address those gaps. Our students score consistently low in the "concepts and procedure" area on the ISAT. Our weekly math lessons give students targeted instruction that improves those skills.
- We also have identified specific needs with reading. Achieve 3000 is incorporated into our second period class at least twice a week, and students identified with low lexiles (under 700) are targeted for a Read 180 support class with our Title 1 para-educator and a classroom teacher.
- The root cause of specific learning needs varies with each individual student. Some have gaps in learning due to past attendance issues. Some have struggled since elementary school and simply haven't kept up with their peers. Some have parental/personal issues that result in a home-life that does not support their education. Some students have the skills, but are not motivated to do their best. Some have difficulty processing emotion, and therefore are challenged with mental health issues that affect their ability to learn. Despite the root cause, MVHS functions with the philosophical foundation that every student can learn, and it is our responsibility to provide the time, support system, and learning environment to create an opportunity for students to succeed.
- As an alternative school, the instruction at MVHS is tailored to students who have struggled academically. Teachers give a pre-assessment on the first day of each block to assess pre-existing knowledge and instructional needs. The smaller class sizes at MVHS allow for teachers to identify students' learning styles and achievement levels, and also aid in ensuring that time and individual attention is provided as necessary. Students are grouped for instruction in various ways, as determined by the subject, assignment, classroom and/or individual needs. Finally, an End-Of-Course assessment is utilized to evaluate student growth. All of these strategies assessment, small class sizes, one-on-one attention along with evidence-based curriculum provide all students with the opportunity to meet academic proficiency. Teachers use formative assessments to determine understanding and then reteach and retest as needed with a goal that all students will achieve at least 70%.
- Students also have the opportunity to recover credit in PLATO credit recovery courses.

5. School Improvement Initiatives:

- Magic Valley High School was identified as a CSI Up school two years ago. Although we did not feel the criteria used was reflective of the many good things we do for our students, we have taken a proactive approach and used it as an opportunity to look at our current practices and see what changes we could make to better meet the needs of our students. We sent teams of teachers to visit other alternative schools, conducted interviews with our students and parents, and attended professional development provided by the state. Through the needs assessment it was decided that we would change our schedule to a three period day, look at ways to get students to do their best on the ISAT and change the way we administered the ISAT.
- We changed our schedule last school year to provide students the opportunity to earn eighteen credits a year. Students take three classes per day and are in those classes for approximately six weeks. Instead of juggling 7-8 classes for 50 minutes a day, students are allowed the opportunity to focus on three, one hour and forty five minute classes. Class size is limited to eighteen students or less, which also allows both the teacher and student an opportunity to get to know each other. This relationship helps the instructor personalize their instruction to the specific needs of the student. The difference in environment and approach results in more success for the students, and also allows for recognition of accomplishments at a quicker rate and promotes a feeling of self-worth for the students. Our schedule allows us to enroll new students every six weeks and provides us the flexibility to meet the needs of students who only need a few credits in order to graduate. We have a forty five minute advancement time two times per week, where students work on Achieve 3000, Fast Math and restorative practices and Core lessons. We provide a Success Center after school from 3:00-5:30 pm Tuesday through Thursday to give students an opportunity to make up time and missing work. Students can also choose to be involved with additional learning opportunities via the Robotics Club and the Drama Club. If students are behind in academic credits, they may choose to attend Night School, offered in the spring (generally mid-February through the end of April). Students have the opportunity to earn one credit during Night School. Finally, Summer School is also offered to students; Summer School consists of a 13-day block with the opportunity to earn one additional

6. Interventions and Extensions:

- Achieve 3000 is utilized as a school wide Tier I reading intervention. Every student is given a level set test three times a year to determine reading levels as well as monitoring progress and improvement. Students are required to complete an activity two times a week in their advancement classroom. Students showing lower than a 700 Lexile on their level set test for Achieve 3000 are monitored by a Title 1 paraprofessional in the classroom and receive support as needed. Our lowest lexile scorers are scheduled into a Read 180 Tier II class, offered three times a year.
- All students' mathematics levels are assessed using STAR Math three times a year. Our lowest below basic scorers will be scheduled into an intensive Tier II intervention class, utilizing the Math 180 program, offered four times a year. Progress and improvement will be assessed using the students' STAR Math scores.
- Magic Valley High School has a full-time Workplace Coordinator/College and Career Advisor whose directive is to provide opportunities for students to learn about and prepare for postsecondary education and the workforce. MVHS operates with the philosophy that it is crucial to show the students where they could go to college and where they could be working after high school. The

College/Career Advisor has assisted students in registering for and utilizing funding for dual credit courses at CSI. In previous years she has arranged field trips to various businesses including Chobani, Agri-service, KMVT, and Seastrom Manufacturing. With community involvement being crucial, our normal practice is to offer several career fairs based on the students' interests. At the beginning of the year a career interest survey is given to the students, which allows them to have input in the guest speakers they would like to see and what careers are of interest to them. This year has been challenging due to restrictions related to COVID 19. We have not been able to provide the opportunities as in the past, but hopefully we will be closer to "normal" as we move forward this year and into next school year.

In previous years, our workplace coordinator has coordinated Employability Luncheons in which local business leaders talk with students regarding effective resumes, interview practices and provides appropriate work-force ready skills that are needed to be employed at their companies. She develops strong partnerships with the local businesses, which allow our students to job shadow and intern. The College/Career Advisor has also coordinated and chaperoned campus visits to CSI, NNU, CWI, BSU, and ISU. With CSI so accessible in our community, our students have been able to attend many CSI Program Exploration Days and Career Fairs in previous years. We work with the CSI Transition Coordinator who helps students connect with the appropriate contacts at CSI and enroll in dual credit classes. Many college representatives visit our school most years, including the College of Idaho, ISU, U of I, BSU, CSI, and Lewis Clark State College which allows students to learn more about their options after high school.

8. Challenges:

It has been a challenging year for both students and staff, as we try to support students in both virtual and face-to-face learning. Teachers have worked hard to develop online course work and to maintain contact with, and support our students. We had a lot of students take on extra hours at work last spring and during this school year based on their life circumstances. Attendance and getting students back in habit of being a student has been a challenge


