## 1. Scope of Work/Payment:

1.1. <u>Project Description</u>: The Client is hiring the Business to lead the following courses: **Co-planning for Language through Content** and an **Administrator Session** via four separate virtual sessions.

## 1.3. Payment Schedule:

Expenses: Client shall pay to the Business any expenses incurred by the Business in the provision of services under this Agreement, including, but not limited to travel expenses based on federal rates for mileage and per diem lodging, meals and incidentals no later than 30 days after receipt is provided.
- 1.5. Refund and Cancellation Policy:
