WORKING WITH YOUR SCHOOL BOARD

<u>WELCOME</u> to another Twin Falls School District Board of Trustees Meeting. You are encouraged to attend all regular board meetings.

We are proud of our school system and the board members are dedicated to the continued improvement of the Twin Falls Schools.

We understand that from time to time patrons of school districts have concerns and feel a need to bring those concerns to the attention of the school or teachers. In order to maintain continuity and best resolve these concerns, we recommend to our patrons the following procedures:

- 1. The first and most effective step is to take the concern to the staff member who is closest to the problem. (In many cases this will be the teacher, coach, etc.) We have found that most problems are resolved at this level.
- 2. If there is still a concern on the matter, we then recommend that the concern be brought to the attention of the Principal. We have found that unresolved concerns from item #1 are usually resolved satisfactorily by the building administrator.
- 3. If the concern is not satisfactorily resolved at that level, then the concern should be taken to the Director of Elementary Programs or Director of Secondary Programs.
- 4. If the concern is not satisfactorily resolved at that level, then the concern should be taken to the Superintendent of Schools. Difficult concerns can usually be resolved.
- 5. However, if the patron still feels the concern has not been properly resolved he/she may use the right of appeal to the Board of Trustees. This is done by calling or writing to the Superintendent and asking for the item to be placed on the agenda of the next regularly scheduled board meeting.
- 6. If you desire to address the board, we would like you to be as comfortable as possible. As a board we hold public meetings which are not public forums and therefore have rules which are necessary for the benefit of all. The following guidelines will assist you as you present your information to the board.
 - A. Prepare your thoughts ahead of time. Usually a brief written outline handed to each board member helps the board follow your presentation. This outline would also give them something upon which to make notes as you speak.
 - B. If a group is involved, select one individual to be your spokesperson. He/she can then guide the presentation with the board and help the board chairman in directing questions to the group.
 - C. Plan your presentation to be as brief as possible. This should include a question/answer period. If more time is needed it is best to give a complete written presentation to the board for their future study. If you give more than five to six minutes of testimony, time restraints will make it difficult for the board to respond that same evening.
 - D. Usually the board will direct the administration to help resolve the concerns and ask for a report back to the board at a later date. However, please remember a solution may take time to be resolved.

We are eager to have our patrons and school staff working together for the improvement of education in the Twin Falls Schools.

- I. Call to Order The Board of Trustees of School District No. 411, Twin Falls County, State of Idaho, met in its properly posted, regular monthly meeting at Canyon Ridge High School boardroom #301 located at 300 North College Road, Twin Falls, Idaho, at the hour of 7:00 p.m., on Monday, June 13, 2022. The following trustees were present: Vice Chairman, Jayson Lloyd; Trustees, Heidi Casdorph, Heidi Tubbs, and Eric Smallwood. There were also present Superintendent, Brady Dickinson; Board Clerk, Michelle Lucas, as well as district directors, interested patrons, employees, and the media. Chairman, Jonathan Lord was unable to attend.
- <u>II</u>. <u>Pledge of Allegiance</u> The Board of Trustees stood and recited the Pledge of Allegiance.
- III. Approval of Agenda (Additions and Deletions) Vice Chairman Lloyd asked if there were any additions or deletions to the agenda. There were none. Trustee Smallwood moved to approve the agenda as posted. Trustee Tubbs seconded the motion, motion carried.
- IV. Unscheduled Delegations (Audience to Address the Board)
- A. Mr. Jaren Thompson addressed the Board and shared that he is addressing the Board as both a teacher of 12 years and a parent with kids in the district. He shared his concerns about district policy 3085 and how the district interprets Title IX laws. He also shared some of his personal experiences with LGBT problems in the classroom, bullying from LGBT students, and violations of other students' rights.
- B. Mr. Shane Klaas addressed the Board regarding Jaren Thompsons' resignation and his own concerns about district policy regarding students identifying as other genders. He read part of district policy 3281 and shared his interpretation of the definition of gender.
- C. Mr. Matt Feemster addressed the Board on behalf of Teacher, Jaren Thompson. He also shared his concerns about district policy, classroom concerns, and students identifying as other genders in schools.
- V. Consent Calendar Trustee Tubbs moved to approve the consent calendar which included: minutes from June 13, 2022 meeting; board financial reports; building financial reports; accounts payable and payroll; contracts for private service providers (PSP)/consultants: Twin Falls Police Dept., DMTI Inc., Boise State University, Math Education

Collective/Professional Learning University Services, South Central Public Health District, and MSB Consulting Group, LLC; certified retirement from Brett Doyle; certified resignations from Matthew Coleman, Brian Johnson, Kimball Hardman, Jamie Allen, and Russell Burnum; new classified employees: Tia Standlee, Robert Walker, Shay Nolan, Daron Alleman, and Wendy Maughan; in-district transfers for Teresa Easterling, Rashell Anderson, and Yudith Hall; classified resignations from James Mooney and Daniel Craig; and extra-curricular resignations from Grace Tigue, Taylor Lewis, Autumn Pittard, Ellen Dedmon, and Chris Waitley. Motion was seconded by Trustee Lloyd, motion carried.

VI. Superintendent's Report:

- A. Superintendent Dickinson announced the exempt employee of the month recipient for the month of July as Jim Ohlensehlen, information systems coordinator, and classified recipient for the month of July as Kristi Stone, elementary and secondary programs administrative assistant; and classified maintenance employee of the month of July as Deralyn Neel, maintenance secretary. Superintendent Dickinson read a brief resume' on each recipient and presented each with a gift, plaque, and gift certificate to Milner's Gate. Mrs. Stone, Ms. Neel and Mr. Ohlensehlen thanked the Board for the honor.
- B. Superintendent Dickinson gave the Board a brief update on current teacher openings. There was 64 teacher openings earlier, and now there are 34: 15 elementary, 12 secondary, and 7 special education. He informed the Board that starting August 1st the district can hire teachers with less than a bachelors, they can have a minimum of 48 credits. This exception will allow them to work for one year, they are required to get their teachers certificate, enter a provisional program that takes three years, before they can work a second year as a teacher. The Board discussed contingency plans if enough teachers can't be hired for the 2022-2023 school year.

VII. Budget & Finance A. Information Items:

1. The Board reviewed the canned foods, frozen meats, products, non-food items, and equipment bid recommendations for August 10, 2022 through May 24, 2023. Bids recommended are: Nicholas & Company \$559,934.23 (weekly), \$81,167.91 to Nicholas & Company, \$25,309.22 to Gem State Paper & Supply; \$19,177.80 to Northwest Distribution, and \$83,035.68 to U.S. Foods for a total request of \$768,624.84. Director of Educational Technology and Operations, Ryan Bowman stood for questions from the Board. A six year comparison was included in the board packet showing that prices have increased significantly due to supply and demand issues.

VII. Budget & Finance B. Action Items:

1. Trustee Smallwood moved to accept the bids recommended for canned foods, frozen meats, products, non-food items, and equipment for \$768,624.84 as presented. Trustee Casdorph seconded the motion, motion carried.

1. Superintendent Dickinson stood for questions about the American Rescue Plan (ARP) update which was presented at the last board meeting. With no other questions, Trustee Casdorph moved to approve the updated American Rescue Plan as presented last month. Trustee Tubbs seconded the motion, motion carried.

IX. Personnel A. Information Item:

- Community Relations Director, Eva Craner shared revision recommendations to 1. policies/procedures: 1210 Qualifications and Duties of Board Officers; 1420 Trustee Expenses; 2385 Limited English Learner Program; 2415 Supporting Students with Characteristics of Dyslexia; 2606 Middle School/Junior High School Credit; 2700 High School Graduation Requirement; 3370P Searches and Seizure; 4110 Public Complaints; 4180 Community Involvement in Student Nutrition and Exercise: 5480 Leadership Premiums; 5750 Employing Retired Teachers and Administrators; 8105 Extracurricular Transportation; and 8160 Contracting for Transportation Services. Administrative Updates: 2420 Parent and Family Engagement; 2420P Family Engagement Guidelines; 2700P High School Graduation Requirements; 3010 Open Enrollment by Students Who Reside Within and Outside the District; 3295 Hazing, Harassment, Intimidation, Bullying, Cyberbullying; 3346 Restraint or Seclusion of a Student; 3500 Student Health/Physical Screenings/ Examinations; 6100P Board/Superintendent Relations; 7215 Fund Accounting System (GASB Statement 54); 7305 Investment of Funds; 7500 New Fees or Increases of Fees; 7710 Bond Continuing Disclosure and Certification Requirements; and 8170 District-Owned Vehicles. These will return next month for a 2nd reading.
- 2. Director of Operations, Ryan Bowman and Superintendent, Dickinson shared plans to increase security District wide. Mr. Bowman shared plans to contract with a security company to add a security guard at every elementary school and one at Bridge Academy. The current safety and security aide positions will become more behavior positions and can be funded from the ESSR funds this year. This will free up funds to go towards the security guards. The rest of the funding for the security guards can come from half carry-over and half Safe and Drug Free funds. These ten security guards will wear a security uniform and be armed. The cost of these this year will be roughly \$500,000. The Board discussed possible options for funding after the 2022-2023 school year including possibly wrapping it into the supplemental levy. Before doing that, the District would put it to the public to see how they feel about the extra security. Mr. Bowman and Dr. Dickinson stood for questions from the Board. This item will return July 20th at the work-session for possible action.

X. Board Goals A. Information Item:

1. Superintendent Dickinson shared an ISBA resolution titled "Salary Based Apportionment for Classified Employees" that he has been working on with Kuna School District. This is

a renewal of a past resolution that has been around for many years. This resolution is to change the funding formula to get additional funding for classified staff. This is also listed as an action item this evening because it is time sensitive to meet the deadline. Superintendent Dickinson explained to the new board members the process a resolution follows to try to get it passed.

- 1. After some discussion, Trustee Tubbs moved to approve the final July 20, 2022 work session agenda. Trustee Casdorph seconded the motion, motion carried.

There were also present Superintendent, Brady Dickinson; Associate Superintendent, Bill Brulotte; Board Clerk, Michelle Lucas; as well as district directors, interested patrons, employees, and the media.
- II. Pledge of Allegiance The Board of Trustees stood and recited the Pledge of Allegiance.
- III. <u>Procedural Matters</u> Approval of Agenda (Additions and Deletions) Chairman Lord asked if there were any additions or deletions to the agenda. There were none. Vice Chairman Lloyd moved to approve the agenda as submitted. Trustee Tubbs seconded the motion, motion carried.
- <u>IV.</u> <u>Unscheduled Delegations (Audience to Address the Board)</u> There were none.
- V. Consent Calendar Trustee Smallwood moved to approve the consent calendar which included: new certified employees: Cindy Castaneda, Andrew Stark, Clint Moerer, Jeffery Garrigues, Jill Fisher, Deborah Metts, Danny Luker, Victoria Francis, Daniel Parker, Katherine Thompson, Cindy Brown, Sky Alexander, Cassandra Harding, Zachary Reichenberger, Amber Harrison, Katelyn Hughes, and Traci Higgins; certified resignations from Michael Dillard and Jaren Thompson; new classified employees: Tiffany Yeoman, Lindsey Bolen, and Jeff Duckworth; classified in-district transfer for Diana Ojeda Razo; and extra curricular resignations from Shaylene Ruiz and Taylor Huddleston. Motion was seconded by Trustee Casdorph, motion carried.

VI. District Safety Plan Update

Director of Educational Technology and Operations, Ryan Bowman shared the current safety plan and steps he is looking forward to taking this year and into the future to keep students and staff safe. Mr. Bowman stood for questions from the Board. Mr. Bowman then discussed other safety considerations such as hiring security guards for each elementary school and one for Bridge Academy for a total of ten security guards in addition to the SRO's we already have at the rest of the secondary schools. The SRO's have been covering the elementary schools a few hours about 2-3 days a week for years. Mr. Bowman also shared what will be expected of these security guards and requested approval to move forward with these plans. Dr. Dickinson explained intentions for funding these ten security guards and the transition of

the current safety and security aides. After some questions and discussion, Vice Chairman Lloyd moved to approve the pursuit of the new building security guards as presented. Trustee Smallwood seconded the motion, motion carried.

VII. 2020-2025 TFSD #411 Strategic Plan- July Update

Associate Superintendent, Bill Brulotte highlighted a focus area for each of the July 2022-2023 updates for the 2020-2025 strategic plan. The plan's focus areas are: Life Ready Students; Quality Learning Opportunities; A Healthy Learning Community; Quality Personnel; School Community Public Relations; School Environment and Facilities; and Stewardship of Resources. Mr. Brulotte stood for question from the Board. This item will return in September for Board action.

VIII. 10 Year Plant Facilities Plan Update and District Building Projects Update

Director of Educational Technology & Operations, Ryan Bowman gave an update on projects completed; current projects (Magic Valley High School vestibule, Robert Stuart Middle School vestibule and Support Services building at 160 Gooding Street site); and current budget. He also shared a report that showed an estimation of costs based on today's prices for asphalt, HVAC, and roofing needs. In order to meet all these needs, it's estimated that it would cost approximately \$15 million for asphalt, \$50.6 million for HVAC, and close to \$20 million for roofing needs. The Board discussed with the Superintendent future options on ways to pay for these facility updates which included running bonds and levies. The District's Legal Counsel, Eric Heringer will attend a board meeting in September to further discuss these options.

IX. Student Achievement Reports

Director of Elementary Programs, Jennie Peterson and Director of Secondary Programs, L.T. Erickson shared testing data; district priorities; data trends/observations with IRI data, ISAT data, social emotional data, IRI/ISAT; summer academy data; longitudinal data, and both elementary and secondary focus areas and target priorities moving forward. After much discussion, Mrs. Peterson and Dr. Erickson stood for questions from the Board.

X. Board Discussion - Vision, Goals, and Focus of Year

Trustees participated in an activity where directors shared their wants/wishes/vision for their departments and with much input from the Board added more items to the lists. After, each trustee went around the room where the lists were hanging and put three dots on each to represent the items that trustee feels are the top priorities. With these priorities identified administrators know what direction to go and these will also help Superintendent Dickinson with his visions and goals for 2022-2023 school year.

XI. Adjournment

Trustee Smallwood moved to adjourn the meeting. Trustee Casdorph seconded the motion and the motion passed unanimously. Meeting adjourned at 9:19 p.m.

Superintendent Goal/Objectives/Tasks: 2022-2023

Goal: Be the District of choice for parents, students, and employees through the offering of top-notch programs in a fiscally responsible, modern, and flexible system.

For each objective, items without quantitative measures will be reported on in the spring of 2023 for evaluation.

Objective: Expand opportunities for students.

Work with CSI to maximize the opportunity for TFSD students to engage in CTE programs on campus. This includes programs in the new center scheduled to open in 2024.

Support a plan to offer a dual immersion magnet program at Oregon Trail Elementary with the goal of beginning the program in the fall of 2023.

Support the growth of the GT magnet program at Morningside Elementary.

Objective: Improved student achievement

Demonstrate continued growth in all academic measures. This includes IRI, ISAT, graduation rates, and school-based assessments.

Objective: Fiscally responsible

Ensure an accurate and responsible budget is implemented for 2022-2023 that maintains programs, takes care of employees, and keeps the district in sound financial condition.

Work with the Budget Advisory Committee on a proposal for the renewal of our supplemental levy and then make community presentations in preparation for the levy election in March.

Objective: School Connection

Continue implementing a PR plan centered around advanced opportunities for students in the TFSD. Highlight dual credits, students earning associate degrees, CTE opportunities, etc. At the elementary level target enrichment opportunities and highlight academic support.

Increase opportunities for staff input by hosting office hours each week in one of the schools. During this time, Dr. Dickinson will be available for staff to visit about any topic of importance.

Be visible throughout the district and community. Host an open forum in each trustee zone during the fall of 2022. Attend 3 school events at each school during the year. In addition, attend community events and collaborate with other community leaders.

Continue utilizing the Highlights of the Week and Board Update to be sent out each week.

Objectives: Modern facilities

Work with the Director of Operations to continue implementation of the 10-year long-range plan for facilities. Topics include security, HVAC, furniture, and technology.

Explore options to accelerate the timeframe for the modernization of facilities.

Work with our Safety Committee to provide additional security to our schools. Complete a review of current practice and work with the TFPD to ensure best practices.

Objective: Effective use of shared leadership

Meet with each director and principal in the fall to collaboratively set goals for the year. Evaluate progress at the end of the school year.

Meet with each Board member individually during the 2022-2023 school year to ensure open communication.

Objective: Quality personnel

Hire and retain qualified staff for certified and classified positions. A report will be made to the Board before May 2023 demonstrating progress in this area.
