- <u>I.</u> Call to Order The Board of Trustees of School District No. 411, Twin Falls County, State of Idaho, met in its regular, properly posted, August board meeting at Canyon Ridge High School boardroom #301 located at 300 North College Road, Twin Falls, Idaho, at the hour of 7:00 p.m., on Monday, August 8, 2022. The following trustees were present: Chairman Jonathan Lord, and trustees: Jayson Lloyd, Heidi Casdorph, Heidi Tubbs, and Eric Smallwood. There were also present Superintendent, Brady Dickinson; Associate Superintendent, Bill Brulotte; Board Clerk, Michelle Lucas; as well as district directors, interested patrons, employees, and the media.
- II. Approval of Agenda (Additions and Deletions) Chairman Jonathan Lord asked if there were any additions or deletions to the agenda. There were none. Vice Chairman Lloyd moved to approve the agenda as submitted. Trustee Tubbs seconded the motion, motion carried.
- III. Pledge of Allegiance The Board of Trustees stood and recited the Pledge of Allegiance.

- V. VI. Superintendent's Report:

- A/B. Superintendent Dickinson announced the certified employee of the month from O'Leary Middle School for the month of August as Annette McFarlin, computer science teacher and the classified employee of the month from O'Leary Middle School as Andrea Cervantes, online coordinator. Superintendent Dickinson read a brief resume' on each recipient and presented each with a gift, plaque, and gift certificate to Koto's. Mrs. McFarlin and Ms. Cervantes thanked the Board for the honor.
- C. Twin Falls Education Association Co-Presidents, Deanna Carter and Camille Johnson addressed the Board and introduced their council members: Vice President, Pete Hurst; Stormy Heinz, Beliz Garcia, Lisa Odaffer, and former Co-President, Joe Bartley.
- D. Superintendent Dickinson and Director of Human Resources, Shannon Swafford updated the Board on current vacancies and plans for coverage at the schools that are short on teachers. As of August 3rd there were still 17.5 teaching positions, 82 classified positions, and 57 coaching positions to fill. Mrs. Swafford updated the list with 8 additional teacher new hires. Dr. Dickinson added that approximately 45% of the 90 teachers hired are on an alternative route or provisional. The District may also have to hire out some of the classified positions to cover food service and custodial services.

VII. Budget & Finance A. Information Items:

- 1. Fiscal Affairs Director, Rachel Youren shared Twin Falls School District 2022 carryover projections. Miss Youren defined restricted and unrestricted funds and shared general fund unrestricted carryover amount \$7,353,483.15. The rest of the carryover is restricted and assigned to open purchase orders, grants, alternative funds, and special state use for a total unassigned general fund carryover of \$4,073,209.15. This amount is projected still because there is one more payroll to run from 2021-2022 school year and some outstanding expenditures. The reason for the unusual carryover amount is because the District was told to budget conservatively in case the State of Idaho didn't access money from the Public Education Stabilization Fund (PESF) to fully fund Districts, however the State did fund Districts and this is why there is an estimated 12.39% carryover.
- 2. Director of Educational Technology and Operations, Ryan Bowman shared the 2022-2023 safety and regular bus routes for board approval. Mid-Columbia Bus Company is still our bus service provider. Mr. Bowman noted that safety bus routes haven't changed for a number of years and the regular bus routes will continue to be adjusted slightly during the start of the year as students register. The bus company has had to consolidate some routes due to a shortage of drivers. This item is also up for action because it's so time sensitive with school starting August 17, 2022.

VII. Budget & Finance B. Action Items:

1. Vice Chairman Lloyd moved that the Board approve the 2022-2023 safety and regular bus routes as submitted. Trustee Tubbs seconded the motion, motion carried.

VIII. Instruction A. Information Item:

- 1. Superintendent Dickinson shared dates for this year's homecoming week for Twin Falls High School: September 19th September 23rd, 2022 and for Canyon Ridge High School: September 12th September 16th. The service Bowl is set for October 14, 2022. Dr. Dickinson will send the Board updates as more details are provided.
- 2. Opening Day Ceremony is set for August 12, 2022 with guest speaker, A.J. Juliani. This event will be posted if the Board wishes to attend. Chairman Lord will be a guest speaker as well.
