CHECKLIST FOR JAPAN

Must have Documents

1. Original Passport with at least 6 months validity and minimum 3 blank pages + all old passports if any;
2. 2 recent colour photographs (Refer to Page 3);
3. Personal Covering letter (For Employed-Plain paper/ Self-Employed-Letterhead);
4. Attested and updated savings and salary Bank Statements with minimum balance of 3 lakhs (last 6 months);
5. ITR Acknowledgment Copies for last 3 years;
6. Flight and Hotel reservation (If Booked)
7. Supporting Financial Documents such as Fixed Deposits, Property Investments, Other Investments etc. (Optional)
8. Visa application form.
9. Aadhar and PAN card

Kindly note: The Govt is very strict on the photograph requirement; please ensure that your photos are as per the specifications (page 3).

Supporting documents as per occupation

1. If Employed:

Original Leave sanctioned certificate with company seal and signature;
Last 3 month salary slips

2. If Self Employed:

GST / Partnership Deed / Business Registration Licence
Company's updated bank statement of last 6 months. (Attested)

3. If Retired:

Proof of retirement like pension book, statement etc.

4. If Student:

School / College / Institute ID Card;
Bonafide certificate.

5. If Minor:

Birth Certificate;

6. If Visiting friend or relative:

Original Invitation letter;
Inviter's ID proof like Passport, valid Japan visa/Resident Permit;
Address proof like any Electricity bill, any Utility bill etc.

7. If Sponsored:

Sponsorship letter (Mentioning Travel dates and relationship).
Sponsor's national ID proof like Passport, PAN card or Resident permit;
Updated personal / company's bank statement of last 6 months.
Pay slips (In case of employed) / GST (In Case of Self Employed)

8. For Business Visa:

Original Invitation letter from host Company stating purpose of trip, business details etc;
Original Letter of Guarantee & a certified copy of the incorporation register or an overview of company / organisation. (If inviting company is bearing the expenses); Covering letter from Indian company on company letterhead.

- **Taken looking straight forward with the face clearly visible**
- **Printed on good quality paper**

- **Delhi - 2x2 Inches**
- **Mumbai - 2x2 Inches**
- **Bengaluru - 35x45 mm passport size**
- **Chennai - 2x2 inches**
