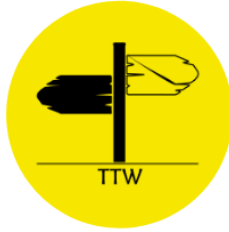

1. **Savings bank statements reflecting a balance of 3 lakhs per person are recommended. The statement should show gradual/consistent deposits and not sudden large deposits.**
2. **You may also provide additional financial documents, such as mutual funds, stocks, or fixed deposits, to strengthen your application.**
3. **Please note that the visa cost is non-refundable. Additionally, an embassy visa fee of €90 per person must be paid directly at the VFS office. Visa fees is subject to change as per embassy norms.**
4. **For smooth processing of the application, all documents must be shared atleast 4 days prior to the appointment.**

Must have Documents

6. Original Passport with at least 6 months validity and minimum 3 blank pages
+ all old passports if any;
7. 2 recent colour photographs (Photo Specification on last page);
8. Original Personal updated Bank Statement (last 6 months) - Attested and signed
2-3 days prior to appointment by the bank.
9. Recommended savings balance of 3L per applicant. Please refrain from making
significant deposits in the account prior to application.
10. Income Tax Returns Acknowledgement Page for last 3 years;
11. Flight reservation & Hotel reservation (If booked)
12. Day-wise Itinerary
13. Travel Insurance (minimum coverage of EUR 30000)
14. Marriage Certificate (if applicable)

Supporting documents as per occupation and visa type*

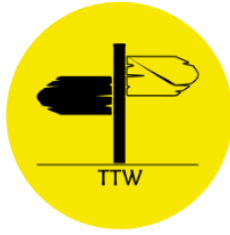

1. If Employed:

- Original Leave sanctioned certificate with company seal and signature (Should
be on company letterhead)
- Last 3 months' salary slip.
- Employment Contract/Offer
letter

2. If Self Employed:

- Business Registration GST/ MOA / Partnership deed;
- Company's updated bank statement of last 6 months (Attested and signed prior 2-3
days to appointment by the bank)
- Company's acknowledgement page of IT returns for the last 3 years.

3. If Retired:

- Proof of retirement like Retirement letter, pension book, statement etc.

4. If Student:

- School / College / Institute ID Card;
- Bonafide certificate from school for leave approval. (On School/College letterhead)

5. If Minor:

- Birth Certificate;
- No Objection Certificate from the parents / non-accompanying parent(It should be notarized)
- ID proof of parent like passport or PAN card

6. If Visiting friend or relative:

- Invitation letter by their local authority
- Inviter's ID proof like Passport or Resident Permit
- Address proof like any Electricity bill, any Utility bill, etc

7. If Sponsored:

- Sponsorship letter;
- Sponsor's national ID proof like Passport, PAN card or Resident permit;
- Updated bank statement of last 6 months
- 3 years ITR
- 3 months Salary Slips (If Sponsor is employed) GST Certificate (If Sponsor is Self-Employed)

VISA PHOTO REQUIREMENT

The Embassy/Government are very strict about the photograph requirements for applicants. Your visa may be rejected if these requirements are not met.

- Two photographs.
- Not more than 6 months old.
- Size: 3.5 x 4.5 cm.
- Colored, with a plain white background.
- Taken facing straight forward with a clearly visible face.
- Neutral, non-smiling expression, ears should be visible
- Without Spectacles
- Printed on glossy paper.
