This online course is based on NFPA 1031 - *Standard for Professional Qualifications for Fire Inspector*, to provide the student with the fundamental knowledge, skills, and attitudes to conduct fire and life safety inspections.

Subjects covered in this course include the fire inspector's responsibilities and role in code enforcement, the relationship of fire and codes, general fire prevention practices, inspection competencies, life safety considerations and enforcement, fire safety principles and requirements related to hazardous materials, special hazards of electrical, heating, and cooking equipment and systems, and fire protection systems and equipment.

Following successful completion of this course and the required skills, the student will be eligible to take the TCFP examination for certification as a certified Fire Inspector I & II.

Optional live online lecture every Wednesday. Students can join these video sessions from virtually any device and participate in the lectures just as if they were in a classroom.
