WebEOC users may all View the records on each sub-board for additional detailed impacts by selecting the **View** option to the right of each record.

Clicking on any header (ex. Jurisdiction Name) will sort the listed entries in ascending or descending order.

Jurisdictional representatives tasked with completing supply chain impacts should check to see if their jurisdiction has an existing record on a respective sub-board. If there is a previous entry, users can edit that record by clicking the **Edit** link to the right of the displayed entry. If jurisdictional impacts on a specific sub-board do not have an existing entry OR have exceeded the fields on the input form, users can simply create a new entry using the **+CREATE RECORD** button. Representatives with access may also delete a record for their own jurisdiction if it is no longer applicable.

Create or Edit a record entry:

Complete all applicable information, including Jurisdiction Name, Jurisdiction Type, and Point of Contact (on all sub-board entry forms). Remember to click boxes if there are impacts associated with the form. This ensures the impact is easily visible to viewers on the display screen. All fields are not required, but any relevant links or additional detailed information is recommended, if available. Be sure to scroll to the bottom of the form and click **Save**.
