Human trafficking is the commercial exploitation of people. The U.S. State Department estimates that there are at least 12.3 million adults and children who are victims of forced labor, bonded labor, and commercial sexual servitude at any given time, making it the second largest illegal industry in the world, generating approximately \$31.6 billion annually. No country is exempt from the pandemic of human trafficking. Washington State itself, with its international border, airport and seaport, and the prevalence of trade related occupations and the demand for agricultural labor in outlying areas, is an unwilling participant in this egregious human rights violation.

This continuing education will provide legal and business professionals with a better understanding of human trafficking and the current efforts to combat it. Panels will review the federal and state legal framework regarding human trafficking; the prosecution of trafficking cases; multi-agency and victim service providers collaboration; regulatory and compliance risks for businesses; corporate social responsibility and best practices; and ethical issues for legal professionals raised by human trafficking.
