Call to Order

Items Discussed

- A) The UW Student Advocacy Alliance
Lincoln Johnson, Associate Vice President for Campus Life, and Elizabeth Higgins, Director of Community Standards and Student Conduct, shared the background of the UW Student Advocacy Alliance with the Council and distributed a handout. Part of how alliance had begun was that there was a sense that administration had been reactive to controversies, and there was a hope to instead become proactive. One of the goals is to have students develop the process, to serve as leadership development, and advance the concept of dialog. Johnson later explained that the hope is not necessarily to change minds, but to engage. Higgins shared that they hope to build student facilitation skills, and that the slogan is Community in Controversy, Civility in Conflict.
- B) Husky Principles
Higgins shared the Husky Principles background with the Council. Resolutions in support have been passed by the ASUW and GPSS. The idea of the Husky Principles is to set expectation of community members, build community, and build tradition. The Husky Principles do not replace the Student Conduct Code.
- C) HUB Renovation Update
All administration will move out of the HUB on June 14th, and everything will be out by July 1. The HUB is set to reopen in September 2012. The Council discussed what food options will fill the void left by the absence of the HUB which include the UW Club, Parnassus, 1101, 8, and McCarty. Another topic discussed was the new Senate Chamber that will be in the new HUB and how it could host the Faculty Senate. Meeting and event space will become an issue for many on campus and many things will likely be in Meany and Kane. Classroom

Support Services will also help student groups find space. Johnson shares the website for the HUB renovation, which is newhub2012.com. Johnson shared that many groups will have to forgo programming the next two years. There will also be a closing ceremony on May 20th at 4:30 and Regent Gates will speak at the event. Johnson also points out that the renovated HUB will have more of the school colors than it has currently.

D) ASUW Report

Padvorac shared that the person that will be replacing him on the ASUW Board will be a great addition to the Council next year. He also shared a project that the ASUW has been working on to create a system that would facilitate study groups. They are working on software that could do this and with Faculty. The Council discussed how it may integrate with C.L.U.E.

E) GPSS Report

Martin shared that GPSS leadership went to Washington, D.C. in April to work on Graduate Student priorities such as tax exemption for Graduate Fellowships.
