- Field to document "Sex" renamed to "Gender" field.

Most Important Take-Aways



If you are using online surveys:

- Create the Program Activity <u>before</u> the class starts, so you have your PEARS ID ready.
- Ask participants to write their **exact same** first and last name into the pre- and post-surveys.
 - First name and last initial also works.
 - This allows us to match pre-surveys to post-surveys.

What to Enter into as an Indirect Activity?



YES

Activities that do not meet the definition of Direct Education, Social Marketing Campaigns, **PSE** Activities:

- Food demos
- Websites
- Health Fair tables
- Signage
- Hard copy materials
- Podcasts



NO

- Direct education
- SNAP-Ed approved curricula
- PSE activities
- Social Media for Social Marketing
- YouTube or other videos
- Email flyers
- Social media posts

Indirect Activities Series

Adding a Series:

- For a series of indirect activities at a single site, add them in the following way:
 - Add the series as one indirect activity.
 - E.g. Farmers Market Kids Club (held throughout the Farmers Market season.)
 - Add each date that a session takes place as its own Intervention Channel in that indirect activity.
 - E.g. October session, November session, ...

Reach of Indirect Activities

"New" vs "Unique"

- Unique = number of individuals reached.
- New = have not been reached before.

In most circumstances:

Reach for the **first** indirect activity at a site includes both

unique and new individuals.

Reach of Indirect Activities

Example 1: Sending newsletters home with students at an entire school.

- The first newsletter has...
 - ✓ UNIQUE reach = total number of individuals.
 - ✓ NEW reach = individuals not reached yet by indirect. activity this fiscal year, and...
- The second, third, and other newsletters this year have...
 - ✓ They have only UNIQUE reach.
 - No NEW reach.

Reach of Indirect Activities

Example 1: Sending newsletters home with students at an entire school.

- The first newsletter has...
 - ✓ **UNIQUE** reach = 200 students
 - ✓ **NEW** reach = 200 students (yes, those are the same 200 from above.)
- The second, third, and other newsletters this year have...
 - ✓ They have only **UNIQUE** reach = 200 students
 - No NEW reach.

Most Important Take-Aways



- **Intervention Channels:** Find the closest related channel from the drop-down.
 - Full list of drop-down options: Drop Down Menu Selection Supplemental Guidance
 - Only if absolutely none of the options are close, choose Other and describe channel used.
- **Reach:** If tracking reach through a spreadsheet or other document (as with the Social Media Guidance), please attach to the **Indirect Activities** module.
- Multiple indirect activities at a single site: Report one Indirect Activity with multiple channels.
 - E.g., a Farmers Market Kids Club at the same market every week: Create one Indirect Activity and add a new channel to that activity every week.

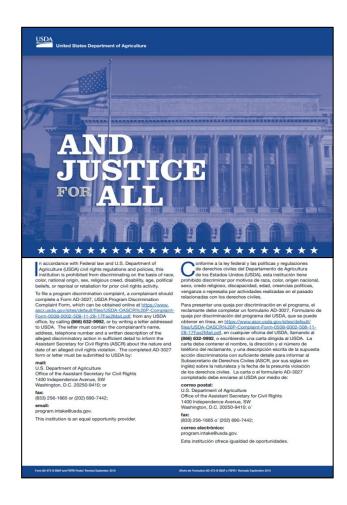

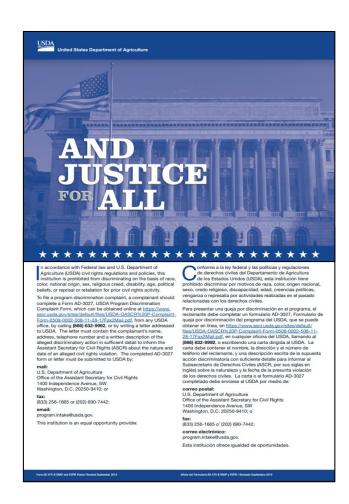
