

#7. Water and Transportation

Summary: In this module you will examine links between climate change, water and modern transportation.

Goals: By the end of this module you will be able to evaluate the GHG emissions and water footprint of your transportation needs.

Assessment Tools:

Discussion Questions (can be used in classroom or for on-line discussion board):

- Many environmental activists argue that Ethanol is bad for the environment. (For example: https://e360.yale.edu/features/the case against ethanol bad for environment) From a water footprint perspective, does the article by Scown et al (2011) support that position? Why or why not?
- Do you think that mobile sources of GHGs are a significant driver of climate-related impacts on water resources? Why or why not? Provide examples from the assigned readings to support your position.
- What do you think is the best type of fuel to use for your own transportation needs? Why that one?

Written Plan: World Water Day is an annual observance that highlights the importance of freshwater around the globe. Write a plan or proposal for a meaningful way to mark this day in your community in 2021. https://www.worldwaterday.org/









Footprint determination: Calculate the water footprint of your transportation habits in a typical week. For this exercise, assume that all of your travel is done by personal auto. If you don't have a car, then select a model you would like to own and use that. If you don't know the mileage of your vehicle from personal experience, then look it up (https://www.fueleconomy.gov/feg/findacar.shtml). What type of fuel do you typically purchase? Use the estimate of gallons of water per mile driven from the table below in your calculations. Prepare a short write-up to describe the assumptions used in calculating your footprint.
