Follow up from the last lesson by asking teens			
to share ways they reduced saturated fats from their diets, reduced screen time, and were more active.			
Ask teens to share a food jingle they know. For			
example: "Lucky Charms are Magically			
Delicious," "L'Eggo My Eggo," "Do the Dew," or "I Wish I were an Oscar Meyer Weiner."			
Another option for this activity is to identify the			
brand related to the following slogans or add your own:

Empty Calories				
Ask:				
What types of foods advertisements do you				
see most often?				
<ul><li>How do these ads appeal to teens?</li><li>Discuss what these foods have in common.</li></ul>				
(they tend to be highly processed and high in				
added sugars, saturated fat, and sodium.)				
How would you describe the nutritional				
value of these foods?				
How do you feel after eating or drinking				
foods high in added sugars?				
Write EMPTY CALORIES on the board.				
Discuss why many of these foods are				
classified as "empty calories." (Empty				
calories are the opposite of nutrient-dense				
foods. They tend to by high in calories, but				
do not provide the vital nutrients our bodies				
needs to function.)				
Explain to teens:				
Americans consume more empty calories				
from added sugars in beverages and				
processed foods than is recommended.				
Americans teens on average get almost half				
of their added sugars just from sugar-				
sweetened beverages.				
<ul> <li>Excess sugar in the diet can lead to chronic disease and tooth decay.</li> </ul>				
Ask:				
Why should teens be concerned about				
eating too many empty calories? (They can				
replace nutrient dense foods and beverages				
and can contribute to weight gain.)				
Have teens review "Kick the Sugar Habit" on				
page 21 in the student workbook.				
Discuss their reaction to the amount of sugar				
found in the foods listed on the page.				
Do an internet image search on "tooth decay"				
to show teens how sugar and improper dental				
hygiene can damage teeth and gums.				
Display a small bag with 50 grams of sugar (12.5				
tsp).				
Tell teens:				
MyPlate recommends limiting added sugars to 10% of total daily calories. For an average

calories from added sugars or 50 grams.

level. Their personalized checklist will show			
recommended calories per day. Based on			
recommended calories, use the formula on

their added sugar limit in teaspoons.

2. Added Sugars Stations:			
Set up three learning stations for drinks,			
breakfast, and snacks.			
Place paper, pencils, and calculators at each station.			
Give each group the Names of Sugar handout.			
Use this at each station to identify different			
types of sugar found in the foods and			
beverages.			
Include instructions and questions at each			
stations so teens can complete the activities			
independently.			
Notes on the Nutrition Facts Label and Added			
Sugars			
Tell students:			
The current Nutrition Facts Label reports			
sugars in foods which include naturally			
occurring sugars and added sugars. Naturally

Added sugars come in many forms. The		
Names of Sugar handout list many of the		
common forms. Natural sugars are not		
included in the 50 grams per day limit of		
added sugars recommended by the 2015		
Dietary Guidelines for Americans.		
The updated Nutrition Facts Label lists only		
added sugars, making it easier to determine		
how many grams of added sugars are found		
in a serving. It is useful to monitor how much		
added sugars one is consuming and judge if		
one is keeping below the limit.		
If food labels used in this activity are the		
current format, instruct students to evaluate		
the product to determine if the sugars are		
mostly natural or added.		
Have them check the ingredients list to		
identify any forms of added sugars. If these		
ingredients appear as the first few listed, the		
product probably contains mostly added		
sugars. If the product contains fruit or milk		
products as one of the first ingredients, then		
<ul><li>the sugar may be natural.</li><li>Be Careful: many food manufacturers add</li></ul>		
fruit juice concentrate to sweeten foods,		
which should be considered as added sugars.		
Drink Station		
Place instructions and questions along with 8 to		
10 containers from a variety of beverages.		
<ul> <li>Put a bowl in front of each. Place the "Go,</li> </ul>		
Slow, Whoa" poster at this station.		
The water and low-fat or fat-free milk are		
"Go" drinks, 100% fruit juice and flavored		
milk are "slow" drinks, and the others are		
"Whoa" drinks.		
Have sugar, either loose, in cubes, or in packets		
to measure. Note: If you plan to have teens		
measure sugar, it is recommended to use salt		
instead.		
Have students follow instructions at each of the		
three stations and answer the questions.		
Optional: Place a variety of drink cups from		
different restaurants or convenience stores at		
the station.		
Cups should range from small (12 oz) to		
super-sized (48oz).		
Teens will then calculate the amount of

not permit, you may choose to premeasure the		
sugar in bags and label each bag with the		
amount of sugar in grams or teaspoons. Have		
teens match the measured sugar samples with		
the beverages.		
Breakfast Station		
Place instructions and questions along with		
packaging from typical breakfast foods at this		
station. Have students follow instructions and		
answer station questions.		
Snack Station		
Place instructions and questions along with		
packaging from typical breakfast foods at this station. Have students follow instructions and		
answer station questions.		
Station Debrief		
After teens visit each station, discuss their		
reaction to seeing how much added sugars are		
in common foods and how much they are		
consuming each day.		
Review the Names of Sugar handout and		
observe how many different names were		
found on the foods they examined.		
Discuss the importance of limiting added		
sugars for teens and their families.		
Discuss why water and low-fat or fat-free		
milk are the recommended "Go" drinks.		
Brainstorm ideas to make small changes that		
would reduce the amount of added sugars		
they consume.		
Make a poster to hang in the classroom with		
their "Top 10" ways to reduce sugar		
consumption.		
Optional:

The Danger Zone			
Have teens open to page 22 in the student			
workbook. Refer to the Food Safety Fact Sheets:			
CHILL and COOK.			
Ask:			
Why is the temperature range of 40 degrees			
to 140 degrees considered the Danger Zone?			
Share with teens:			
Temperature danger zone is the			
temperature range in which microorganisms			
grow quickly and sometimes reach levels			
that can make people ill.			
Foods and perishable beverages like milk			
should not remain in the danger zone for			
more than 2 hours.			
Have teens record the temperatures of the			
danger zone, as well as the proper			
refrigeration 33 degrees to 39 degrees and			
freezer temperatures -10 to 0 degrees.			
Discuss times that food might be in the  danger zone for long periods of time (>2)			
danger zone for long periods of time (>2 hours) such as a picnic, during a family,			
church or community gathering, or when			
leaving leftovers out to cool.			
Remind teens that bacteria can still grow on			
food in the refrigerator temperature range			
of 33 to 29, even though it will be much			
slower. For this reason, leftovers should not			
be left in the refrigerator more than 4 days.			
<ul> <li>Monitor other foods according to their shelf</li> </ul>			
life and product dating. (See Refrigerator and			
Freezer Chart for reference).			
Ask:			
How often do you check the "Use By" date			
on foods you eat?			
What foods do you eat that have these			
dates? (i.e. eggs, dairy, and meats.)			
What do you do when you notice foods has			
passed the recommended use-by date?			
(Refer to the "For Your Information: Lesson			
411" section at the end of this lesson for			
more information on date labeling on foods.)			
Danger Zone Simulation:			
This experiment shows the effect			
Temperature has on bacterial growth.			
Display 3 small clear cups and label them			
COLD, WARM, and HOT.			
Place an instant-read thermometer next to

• Put 1/3 cup of water at room temperature in			
a liquid measuring cup.			
Add a packet of Rapid Rise Yeast and a			
teaspoon of sugar. Stir to dissolve.			
Divide the mixture between 3 cups.			
Add about 1 cup of cold water with a few ice			
cubes, if available, in the COLD cup, warm			
water in the WARM cup (bath temp) and			
boiling or very hot water in the HOT cup.			
• Let cups stand. After at least 20 minutes,			
have teens make observations on the growth			
of the "bacteria" in each cup.			
Results:			
The cup with cold water should show a few			
bubbles. Note that growth is occurring but			
very slowly, like it would under refrigeration.			
Discuss that food left in the refrigerator after			
5 days could have bacteria growth and should be discarded to be safe.			
The warm water cup should have a good amount of froth on the top showing strong			
growth.			
<ul> <li>Discuss how bacteria grows exponentially in this temperature range (doubles about every</li> </ul>			
20 minutes). After a few hours in the right			
conditions, a few bacteria can become			
thousands.			
• Food left out at room temperature for more			
than 2 hours can be unsafe and should not			
be eaten.			
The hot water cup should show no growth.			
All the yeast should be dead lying at the			
bottom of the cup. Depending on the food,			
cooking to an internal temperature of 145 to			
165 should keep it safe.			
Discuss how the results of this experiment			
might change the way you handle food.			
Review the best temperature settings for			
refrigeration and freezing. Refrigeration			
should be set at 37 degrees and freezers			
should be set at 0 degrees. Challenge teens			
to use a refrigerator thermometer to check			
their refrigerators at home.

Demonstrate how to assemble a blender cup to			
prevent leaks, how to take it apart and how to			
clean it.

The blender should always be taken apart,			
cleaned, and allowed to dry before			
reassembling.			
Remind teens of the danger zone when			
cleaning and storing blenders. If not cleaned			
properly, bacteria can grow on the blender			
parts to dangerous levels. Review the			
operation of the blender.			
Make the Banana Berry Smoothie or the Berry			
Purple Smoothie.			
For a challenge, have teens create new			
smoothie recipes by trying different fruit			
combinations. Vegetables, like spinach and			
kale, make great additions as well.			
Other healthy options include adding a few			
tablespoons of nut butter, avocado, or			
herbs, like mint and basil.			
Ask:			
Would a smoothie be an acceptable			
substitute for a milkshake? Why or Why not?			
What are some ways you can reduce sugar-			
sweetened beverages and sugary snacks and			
increase the amount of water you drink?

Get More Activity Every Day			
Discuss reactions to screen time from the last			
session. Have students share their reactions to			
how much time they spend on screens. Share			
any new activities they tried to help break up or			
reduce their screen time.			
Ask:			
If you had to add in 10-minutes of activity in			
your day, when would you do it?			
Is there a time when you are sedentary that			
a quick break of activity would help make			
you feel better?			
What activity could you do in those 10-			
minutes?			
Share with teens:			
Doing multiple 10-minute bouts of exercise			
throughout the day can be just as effective			
as 30-60 minutes of exercise at once.			
Have teens share ideas of fun activities they			
can do in 10-minutes.			
Remind them that being active is fun and			
enjoyable, and it is not hard to make			
exercise a regular habit.

more likely to be active when others are involved.			
<ul> <li>Suggest that music can be helpful in staying</li> </ul>			
motivated while walking, running, or			
working out at a gym. And music can get			
them up to dance, which is another excellent			
physical activity.			
Have teens set goals for doing more small bouts			
of physical activity to break up their screen			
time.			
Remind teens that finding motivation to do			
more physical activity is challenging.			
Encourage them to include friends and			
family to help with staying active.			
Optional Physical Activity			
Have teens practice activities they can do			
quickly, for short periods of time.			
Have them warm up with 10 squat jumps, 10			
side lunges, and 10 standing butt kicks.			
Repeat these exercises 3 times with a short			
30-second break in between.			
While doing these exercises, have teens think			
about two things:			
Can you do these exercises at home while			
watching TV or in-between subjects when			
doing homework?			
How can you make physical activity more			
enjoyable? Try to think of different ways that			
you could make exercising more fun so you			
can be more inclined to do it for at least 60			
minutes a day.

Help teens to set and share goals to reduce the

changes in what they eat and drink can make a			
big difference in the long run.
