1. Scope: This addendum covers the Child Safety Seats lead by the State of New Jersey for use by state agencies and other entities located in the Participating State/Entity authorized by that state's statutes to utilize **state/entity** contracts with the prior approval of the state's chief procurement official.

2. Participation: Use of specific WSCA-NASPO cooperative contracts by agencies, political subdivisions and other entities (including cooperatives) authorized by an individual state's statutes to use **state/entity** contracts are subject to the prior approval of the respective State Chief Procurement Official. Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

3. Participating State Modifications or Additions to Master Agreement:
(These modifications or additions apply only to actions and relationships within the Participating Entity.)

Eligible participants in this agreement include all agencies, institutions, officers, boards, commissions and public universities of the State of South Dakota, and all political subdivisions of the State, including counties, municipalities and public school corporations within the State of South Dakota.

Public universities of the State of south Dakota may make purchases directly from the contractor.

Political subdivisions of the State of South Dakota may purchase directly from the contractor according to their own procurement procedures.

Only line items 0002 - Combination Seat Maestro 3102198, 00012 - Convertible Child Seat w/Harness Rethreading Titan 65, 00017 - Infant Car Seat Embrace w/Pillow 31511561, and 00027 - High Back Booster w/Backrest Chase 3431198 may be purchased from Evenflo. If interested in purchasing anything other than previously listed, contact Kathy Stasch with the State of South Dakota Office of Procurement Management.

The Contractor may, at the Contractor's discretion, extend pricing for this agreement to Indian tribal governments and non-profit organizations in South Dakota. Any sale made to Indian tribes and non-profit organizations from this agreement shall be included in any required reports and shall be subject to the NASPO administrative fee.

Please channel your PO through one of our authorized resellers so they can arrange for proper ordering and installation of your unit.

8. Price Agreement Number:

All purchase orders issued by purchasing entities within the jurisdiction of this participating addendum shall include the Participating State contract number: 16621 and the Lead State price agreement number: A86334.

9. Individual Customer:

Each State agency and political subdivision, as a Participating Entity, that purchases products/services will be treated as if they were Individual Customers. Except to the extent modified by a Participating Addendum, each agency and political subdivision will be responsible to follow the terms and conditions of the Master Agreement; and they will have the same rights and responsibilities for their purchases as the Lead State has in the Master Agreement. Each agency and political subdivision will be responsible for their own charges, fees, and liabilities. Each agency and political subdivision will have the same rights to any indemnity or to recover any costs allowed in the contract for their purchases. The Contractor will apply the charges to each Participating Entity individually.

This Participating Addendum and the Master Agreement number A86334 (administered by the State of New Jersey) together with its exhibits, set forth the entire agreement between the parties with respect to the subject matter of all previous communications, representations or agreements, whether oral or written, with respect to the subject matter hereof. Terms and conditions inconsistent with, contrary or in addition to the terms and conditions of this Addendum and the Master Agreement, together with its exhibits, shall not be added to or incorporated into this Addendum or the Master Agreement and its exhibits, by any subsequent purchase order or otherwise, and any such attempts to add or incorporate such terms and conditions are hereby rejected. The terms and conditions of this Addendum and the Master Agreement and its exhibits shall prevail and govern in the case of any such inconsistent or additional terms within the Participating State.



