This Participating Addendum adds the State of Arkansas (hereinafter "Participating State") as a Participating entity to purchase from the Oregon Price Agreement, Number 9949, with Hertz Corporation (hereinafter "Contractor").

1. Scope: This addendum covers Nationwide Vehicle Rental Services, within the scope of the WSCA Master Agreement for State Agencies and Political Subdivisions.
2. Changes:
 - a. Payments shall be submitted to the contractor at the address shown on the invoice. Payments shall be tendered to the contractor within thirty (30) days of the date of invoice. After the sixtieth (60) day from the date of the invoice unless mutually agreed to, interest shall be paid on the unpaid balance due to the contractor at a rate of one half of one percent per month in accordance with Arkansas Code Annotated § 19-11-224. The procuring agency shall make a good-faith effort to pay within thirty (30) days after date of invoice.
 - b. Usage Reports shall be emailed to John Leverett at: john.leverett@dfa.arkansas.gov within thirty (30) calendar days upon completion of performance quarterly periods cited in the paragraph below.

Contract quarterly reporting periods shall be:

January 1 through March 31, due April 30;
April 1 through June 30, due July 30;
July 1 through September 30, due October 30;
October 1 through December 31, due January 30;

- c. Record Retention & Access: The vendor must maintain all pertinent financial and accounting records and evidence pertaining to the contract in accordance with generally accepted principles of accounting and other procedures specified by the State of Arkansas. Access will be granted upon request, to State or Federal Government entities or its designated officials, or any of their duly authorized representatives. Financial and accounting records must be available, upon request, to the State of Arkansas' designee(s) at any time during the contract period and any extension thereof, for five (5) years from expiration date and final payment on the contract or extension thereof.
- d. Contractors should have the capability of accepting the Participating state's authorized VISA Travel Card as a method of payment. VISA acceptance is preferred but is not the exclusive method of payment.
