This Participating Addendum adds the State of Washington (hereinafter "Participating State") as a Participating entity to allow its Cities, Counties, Utilities, School Districts, Non-Profit Corporations and other related entities defined as "Political Subdivisions" to purchase from the Oregon Price Agreement #9949 with Hertz Corporation (hereinafter "Contractor").

- 1. Scope: This Addendum allows for **Nationwide Vehicle Rental Services** with Contractor (**Hertz**) <u>for Political Subdivisions only</u>, within the scope of the WSCA Master Agreement.
- 2. Changes:
 - a. Contractor may offer contract pricing to Washington Political Subdivisions only.
 - b. Contractor may <u>not</u> extend pricing to Washington <u>State Agencies</u>, who are currently only authorized to use the previously executed Participating Addendum awarded by Washington to the bidder deemed by Oregon's solicitation process to be the lowest, responsive, responsible bidder under the Price Agreement which is still in effect.
 - c. Contractor will validate requesting customer's Political Subdivision status prior to extending pricing. Washington's current list of State Agencies can be confirmed by reviewing the Office of Financial Management (OFM) list at: http://www.ofm.wa.gov/policy/75.20.htm. This list varies as agencies change, and can be used to confirm the requesting customer is not a state agency and therefore eligible to participate under this Addendum. A sample list effective July 1, 2010 is attached, but should not be considered final at any time due to ongoing updates by OFM.
 - d. The State of Washington's Standard Terms and Conditions submitted in Attachment A of the original solicitation apply to this Addendum.
 - e. Contractor must provide Sales and Subcontractor Reports to the Participating State electronically on a quarterly basis, <u>due within thirty (30) days after the end of the calendar quarter</u>, i.e., no later than April 30th, July 31st, October 31st and January 31st. The Sales Report shall be in the electronic format provided at: https://fortress.wa.gov/ga/apps/CSR/Login.aspx.
