1. Scope: This Participating Addendum covers the Data Communications Products and Services 14-19 contracts led by the State of Utah for use by political subdivisions, public universities, and other entities located in the Participating State authorized by that state's statutes to utilize state contracts with the prior approval of the state's chief procurement official. Agencies governed by chapter 34 RSMo are specifically prohibited from using this agreement unless specifically authorized by the Director of the Division of Purchasing and Materials Management for the State of Missouri.

2. Participation: Use of specific WSCA-NASPO cooperative contracts shall only apply to political subdivisions/local governments authorized by an individual state's statutes to use state contracts are subject to the prior approval of the state's Director of the Division of Purchasing and Materials Management. A political subdivision/local government is defined as any city, county, district, or other local governing body including State Universities, community colleges, and K-12 public schools empowered to expend public funds and enrolled in the state's cooperative procurement purchasing program. Agencies governed by chapter 34 RSMo are specifically prohibited from using this agreement unless specifically authorized by the Director of the Division of Purchasing and Materials Management for the State of Missouri. Use of specific WSCA/NASPO cooperative contracts shall be governed by the scope as approved by the Director of the Division of Purchasing and Materials Management for the State of Missouri. Issues of interpretation and eligibility for participation are solely within the authority of the Director of the Division of Purchasing and Materials Management for the State of Missouri.

3. Participating State Modifications or Additions to Master Agreement:
No Changes Are Required.

4. Lease Agreements: The political subdivisions of the State of Missouri are approved to utilize the lease agreement for equipment with no changes to the terms and conditions. Agencies governed by chapter 34 RSMo are specifically prohibited from using this lease agreement unless specifically authorized by the Director of the Division of Purchasing and Materials Management for the State of Missouri.


