1. **Scope:** This addendum covers the Data Communications Products and Services 14-19 contracts led by the State of Utah for use by state agencies and other entities located in the Participating State authorized by that state's statutes to utilize state contracts with the prior approval of the state's chief procurement official.

2. **Participation:** Use of specific WSCA-NASPO cooperative contracts by agencies, political subdivisions and other entities (including cooperatives) authorized by an individual state's statutes to use state contracts are subject to the prior approval of the respective State Chief Procurement Official. Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

3. **Participating State Modifications or Additions to Master Agreement:**

Required Reports: Contractor must submit quarterly reports to the Contracting Officer assigned by the State to manager this contract. This report must show all purchases made under this contract in the state of Alaska and list it by the total purchases made by each entity. The State will work with the Contractor to develop this report. These reports are due 30 days after the end of the quarter.

First Quarter July 1 through September 30
Second Quarter October 1 through December 31
Third Quarter January 1 through March 31
Fourth Quarter April 1 through June 30

All purchase orders issued by purchasing entities within the jurisdiction of the Participating Addendum shall include the Participating State contract number, 2014-DATACOM-0020 and the Lead State contract number, AR626



