### **Modification 1.0**

Services/ Commodity: Electronic Monitoring of Offenders Services for the Department of Corrections, Division of Adult Institutions. Division of Community Corrections.

WHEREAS, the State of Wisconsin Department of Corrections, whose principal business address is 3099 E. Washington Ave., P.O. Box 7925, Madison, WI 53707-7925, hereinafter referred to as **DOC**, and **CONTRACTOR**, whose principal business address is BI Incorporated, 6400 Lookout Road, Boulder, CO 80301, hereinafter referred to as BI Incorporated, entered into a Contract for Services (the "Contract") for the initial period of July 1, 2014 through December 31, 2016, with the option to extend three, mutually agreed one year terms.

WHEREAS, the DOC and Contractor wish to enter into a modification to the original WSCA Contract 00212 between the parties,

Now, therefore, it is mutually agreed as follows:

1. Appendix E, BI Incorporated Price Sheet to be amended as follows:

- 2. Section 4.0, Contractor Qualifications and Requirements, Section 4.1, Established Business is modified to include the following language at the end of the first paragraph: "All contractor installers will be required to take a drug screen and background check prior to servicing this contract."
- 3. Section 5.0, Delivery Requirements, is modified to add Section 5.9, Other Delivery Requirements, to include the following language:
  - Install and removal response times within 24 hours (TAD and GPS units).
  - Service calls within 24hrs.
  - Installation on site within 8 hours.
  - BI will provide 25 fixed HG206 cellular units for use at all times at no cost. These are made available to DOC when unable to install equipment due to digital phone line and/or other offender telecommunication restrictions.
  - BI will maintain the current plans of 20% spares/ backup inventory and supplies for replacement and installs at no charge for the respective equipment used. BI calculates a flat 20% off all rented RF (radio frequency) and Sobrietor units only AND separately 20% off all active days for ET1, TAD and Soberlink units.
  - -BI installers will be responsible for maintaining their inventory of all GPS and TAD units.
  - -BI Inc. will be responsible for inventorying all GPS and TAD units at no charge.
  - -BI Inc. to provide DOC 15 scanners to monitor and track inventory.
  - -BI will reconcile rented (non-agency owned) inventory on a monthly basis for TAD and ET1 units with DOC management or designee.

- -BI will provide an annual 5% lost and damaged allowance for BI owned/rented units.
- 4. Section 7.8 and Appendix D, Training is modified to include:
  - Training of 2 DOC Staff per quarter to include installer training at no charge.
  - BI will provide 2 staff per quarter to come to Madison to train DOC staff on the software and monitoring program by BI Inc. at no charge to DOC.
  - Training will include inventory and tools training, device training and software usage training.
- 5. All other standard terms and conditions will remain the same as on WSCA Contract 00212.
